The Assembly was called to order at 10.00 o'clock a.m.

ORDERS OF THE DAY

Government Motions

The Assembly held the debate on the motion arising out of the tabling by Mr. Arcand, Minister of International Relations, on 26 March 2009, of The Entente entre le Québec et la France en matière de reconnaissance mutuelle des qualifications professionnelles, signed in Québec City on 17 October 2008.

This motion reads as follows:

THAT, pursuant to section 22.3 of the *Act respecting the Ministère des Relations internationales*, the National Assembly ratify the Entente entre le Québec et la France en matière de reconnaissance mutuelle des qualifications professionnelles, signed in Québec City on 17 October 2008.

Following a meeting with the House leaders, Mrs. Houda-Pepin, First Vice-President, informed the Assembly of the speaking time for the proceedings with respect to this limited debate: 12 minutes shall be allotted to the independent Members; the two parliamentary groups will share equally the rest of the time allotted for this debate; within this framework, any time not used by a parliamentary group may be added to that of the other group, while any time not used by the independent Members will be redistributed equally among the parliamentary groups, it having been agreed that this apportionment may not be carried out before the time allotted to both parliamentary groups has entirely expired; and individual addresses shall not be limited.

A debate arose thereon.

The debate being concluded, the motion was carried. Accordingly, this commitment was approved.

At 11.18 o'clock a.m., at the request of Mrs. Vien, Minister of Government Services, Mrs. Houda-Pepin, First Vice-President, suspended the proceedings until 2.00 o'clock p.m.

THAT the National Assembly mark the 200th anniversary of the founding of the Chambre de commerce de Québec, the first Francophone chamber of commerce in North America, active since 21 February 1809, by recognizing its assistance and contribution to the economic life of Québec City businesses through its vitality and outreach.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Orders 84 and 185, Mrs. Gagnon-Tremblay, Minister responsible for the Estrie region, Mr. Bérubé (Matane), Mr. Bonnardel (Shefford) and Mr. Khadir (Mercier) jointly moved:

THAT the National Assembly mark the naming of the city of Sherbrooke to host the Canada Games in the summer of 2013; the entire population of Québec will have the opportunity, for its part, to come and cheer on our emerging athletes and then take advantage of the improvements that will be made to the sports facilities of the region.

THAT the National Assembly ask the Federal Government to reconsider its decision to cut the subsidy granted to the Mount Mégantic Observatory through the Natural Sciences and Engineering Research Council (NSERC) of Canada.

- the Committee on Transportation and the Environment shall hold a deliberative meeting for the purpose of organizing its proceedings and of discussing the possibility of carrying out an order of surveillance on the Agence métropolitaine de transport and an order of initiative on the situation of lakes.

Information on the Proceedings of the Assembly

Mr. Chagnon, Second Vice-President, informed the Assembly that on Wednesday, 8 April 2008, during Business Standing in the Name of Members in Opposition, a debate will be held on the motion by Mrs. Maltais (Taschereau). This motion reads as follows:

> THAT the National Assembly recall sections 61 and 62 of the *Act respecting the National Assembly* as well as the wording of the oath of allegiance taken by the members of the Cabinet, that it demand that the Premier have his own directives regarding conflicts of interest enforced, that it solemnly affirm that a Cabinet member must not be bound to another employer during the exercise of his duties and that it ask for the appointment, as expeditiously as possible, of an independent ethics commissioner.

Business Having Precedence

Debate on the Budget Speech

The Assembly resumed the debate, which had been suspended on 31 March 2009, on the motion by Mrs. Jérôme-Forget, Minister of Finance, –That this Assembly approves in general the budgetary policy of the Government, and on the want of confidence motions moved by Mr. Legault (Rousseau), Mr. Khadir (Mercier), Mr. Simard (Richelieu), Mrs. Marois, Leader of the Official Opposition, Mr. Girard (Gouin) and Mrs. Bouillé (Iberville).

The debate being concluded, Mr. Gendron, Third Vice-President, rendered the following ruling on the receivability of the want of confidence motion by Mrs. Bouillé (Iberville):

RULING FROM THE CHAIR

The want of confidence motion moved by Mrs. Bouillé (Iberville) within the framework of the debate on the Budget Speech is out of order on the grounds that this motion contains recitals, which is contrary to Standing Order 191.

On behalf of the Member concerned, Mr. Gendron, Third Vice-President, requested leave of the Assembly to replace the aforementioned motion ruled out of order by a new motion in compliance with the Standing Orders.

By leave of the Assembly, Mr. Gendron, Third Vice-President, tabled the motion by Mrs. Bouillé (Iberville), which now reads as follows:

THAT the National Assembly severely blame the Government for having let the agricultural community down by systematically refusing to increase the budget of La Financière agricole du Québec of 300 million dollars for the past 7 years, and by causing the organization to face a deficit of more than 1.2 billion dollars in 2009.

Mr. Gendron, Third Vice-President, then proceeded to put the question on the want of confidence motions presented during the debate on the Budget Speech.

First, the question was put on the want of confidence motion moved by Mr. Legault (Rousseau). This motion reads as follows:

THAT the National Assembly severely blame the Government for having presented a 2009-2010 budget without a recovery plan to limit the effects of the economic crisis on Québec, particularly the lack of major measures to counter dropping out of school, to adequately fund postsecondary education, to increase the productivity of businesses and minimize the number of jobs lost and to come in aid to moderate-income individuals.

A recorded division was thereupon demanded.

The motion was negatived on the following vote:

(Division No. **17** in Appendix)

Yeas: 48 Nays: 62 Abstentions: 0

The question was then put on the want of confidence motion moved by Mr. Khadir (Mercier). This motion reads as follows:

THAT the National Assembly severely blame the Government for having presented a budget that will have effects that are totally contrary to the revolution of sustainable development announced by the Premier just two weeks ago.

A recorded division was thereupon demanded.

The motion was negatived on the following vote:

(Division No. 18 in Appendix)

Yeas: 48 Nays: 62 Abstentions: 0

The question was then put on the want of confidence motion moved by Mr. Simard (Richelieu). This motion reads as follows:

THAT the National Assembly severely blame the Premier as well as the Chair of the Conseil du trésor for their mismanagement of the public expenditure before the crisis that led to a structural deficit of close to 4 billion dollars and who announce major cuts in services to citizens in the coming years as well as drastic tariff increases.

A recorded division was thereupon demanded.

The motion was negatived on the following vote:

(Division No. **19** in Appendix)

Yeas: 48 Nays: 62 Abstentions: 0

The question was then put on the want of confidence motion moved by Mrs. Marois, Leader of the Official Opposition. This motion reads as follows:

THAT the National Assembly severely blame the Premier of Québec for having plunged Quebecers into an election campaign at a time when a serious economic crisis was erupting without establishing a profile of the public finances and of the state of the Caisse de dépôt et placement du Québec.

A recorded division was thereupon demanded.

The motion was negatived on the following vote:

Yeas: 48 Nays: 62 Abstentions: 0

The question was then put on the want of confidence motion moved by Mr. Girard (Gouin). This motion reads as follows:

THAT the National Assembly severely blame the Government for not having made any commitment as regards the creation of the 15,000 spaces in subsidized child care promised during the last election campaign.

A recorded division was thereupon demanded.

The motion was negatived on the following vote:

(Division No. 21 in Appendix)

Yeas: 48 Nays: 62 Abstentions: 0

The question was then put on the want of confidence motion moved by Mrs. Bouillé (Iberville). This motion reads as follows:

THAT the National Assembly severely blame the Government for having let the agricultural community down by systematically refusing to increase the budget of La Financière agricole du Québec of 300 million dollars for the past 7 years, and by causing the organization to face a deficit of more than 1.2 billion dollars in 2009.

A recorded division was thereupon demanded.

The motion was negatived on the following vote:

Finally, the question was put on the want of confidence motion moved by Mrs. Jérôme-Forget, Minister of Finance, –That this Assembly approves in general the budgetary policy of the Government.

Government Bills

Passage in Principle

Mrs. Weil, Minister responsible for the administration of legislation respecting the professions, moved, –That Bill 3, An Act to provide for the implementation of the Entente entre le Québec et la France en matière de reconnaissance mutuelle des qualifications professionnelles and similar agreements, do now pass in principle.

After debate thereon, the motion was carried and Bill 3 was accordingly passed in principle.

Mr. Gautrin, Deputy Government House Leader, moved that Bill 3 be referred for clause-by-clause consideration to the Committee on Institutions.

The motion was carried.

Debates Upon Adjournment

The Assembly held three debates upon adjournment:

- the first, on a question by Mr. Cloutier (Lac-Saint-Jean) to Mrs. Jérôme-Forget, Minister of Finance, about the income stabilization programme and the harmonization of sales taxes;
- the second, on a question by Mr. St-Arnaud (Chambly) to Mr. Dupuis, Minister of Public Security, about the lack of resources for Montreal police officers, according to the report of the Commission de la santé et de la sécurité du travail;
- the third, on a question by Mr. Villeneuve (Berthier) to Mrs. Beauchamp, Minister of Sustainable Development, Environment and Parks, about Mont-Orford.

At 6.38 o'clock p.m., Mr. Gendron, Third Vice-President, adjourned the Assembly until Wednesday, 8 April 2009, at 10.00 o'clock a.m.
