RULING FROM THE CHAIR

In pursuance of section 30 of the *Act respecting the National Assembly*, only a minister may present a bill having as its object the commitment of public funds, the creation of a charge on the taxpayers, the remission of a debt owing to the Province or the alienation of property owned by the Province. The measures provided for in the bill do not concern the alientation of property owned by the Province, nor the creation of a charge on the taxpayers, nor the remissino of a debt. As such, the bill, if it were passed, would not have the effect of committing public funds as per the criteria established by parliamentary jurisprudence. In the bill before the National Assembly, the creation of a provisional tax credit will undoubtedly future implications on the expenses and revenues of the Province, but these implications are indirect and approximate. Consequently, the bill does not come under the financial initiative of the Crown and may be introduced by a Member who is not a Minister.
