Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

At the request of the President, Mr. Drainville (Marie-Victorin) withdrew certain words deemed unparliamentary.

Motions Without Notice

Mrs. Roy (Montarville), together with Mrs. Léger (Pointe-aux-Trembles) and Mr. Khadir (Mercier), moved a motion concerning illegal religious private schools; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. H. Plante (Maskinongé), together with Mrs. Poirier (Hochelaga-Maisonneuve), Mr. Martel (Nicolet-Bécancour) and Mrs. Massé (Sainte-Marie–Saint-Jacques), moved:

THAT the National Assembly urge the Federal Government to follow the Québec Government's lead in indemnifying the pyrrhotite victims of the Mauricie region, as it did for the pyrite victims in 2001.

By leave of the Assembly, the motion was carried.

Mrs. Maltais (Taschereau), together with Mr. Charette (Deux-Montagnes) and Mrs. Massé (Sainte-Marie–Saint-Jacques), moved a motion on adding a delimitation criterion to Québec's new electoral map; this motion could not be debated for want of unanimous consent.

Mr. Khadir (Mercier) moved a motion concerning the international agreements signed by the governments of Québec and Canada; this motion could not be debated for want of unanimous consent.

Notices of Proceedings in Committees

Mr. Sklavounos, Deputy Government House Leader, convened the following committees:

- the Committee on Health and Social Services, to continue its clause-byclause consideration of Bill 20, An Act to enact the Act to promote access to family medicine and specialized medicine services and to amend various legislative provisions relating to assisted procreation;
- the Committee on Labour and the Economy, to continue its clause-byclause consideration of Bill 42, An Act to group the Commission de l'équité salariale, the Commission des normes du travail and the Commission de la santé et de la sécurité du travail and to establish the Administrative Labour Tribunal;
- the Committee on Public Finance, to undertake clause-by-clause consideration of Bill 38, An Act to allow the Caisse de dépôt et placement du Québec to carry out infrastructure projects.

Mrs. Gaudreault, Second Vice-President, gave the following notices:

- the Committee on Agriculture, Fisheries, Energy and Natural Resources shall meet to hold a deliberative meeting to prepare the report on the policy directions, activities and administrative management of the Commission de protection du territoire agricole du Québec;
- the Committee on Citizen Relations shall hold a deliberative meeting to discuss the possibility of carrying out an order of initiative.

ORDERS OF THE DAY

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Labour and the Economy on its clause-by-clause consideration of Bill 43, An Act to enhance the communication of hazard-related information concerning products present in the workplace and to amend the Act respecting occupational health and safety.

After debate thereon, the report was concurred in.

The Assembly took into consideration the report from the Committee on Labour and the Economy on its clause-by-clause consideration of Bill 37, An Act to confirm that the cement plant and maritime terminal projects in the territory of Municipalité de Port-Daniel–Gascons are subject solely to the authorizations required under section 22 of the Environment Quality Act, together with the amendments submitted by Mr. Jolin-Barrette (Borduas).

Amendments 4, 5, and 7 to section 1 were declared in order.

Amendments 1, 2 and 3 to section 1, and amendment 6 to section 2, were declared out of order because they deny or contradict the principle of the bill.

A debate arose thereon.

At the request of Mrs. Gaudreault, Second Vice-President, Mr. Jolin-Barrette (Borduas) withdrew certain words deemed unparliamentary.

The debate being concluded, the amendments were negatived.

The question was put for concurrence in the report, and a recorded division was thereupon demanded.

At the request of Mr. Sklavounos, Deputy Government House Leader, the division was deferred until Routine Proceedings on the next sitting day.

At 12.51 o'clock p.m., at the request of Mr. Sklavounos, Deputy Government House Leader, and by leave of the Assembly to set aside Standing Order 20, Mrs. Gaudreault, Second Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.07 o'clock p.m.

Business Standing in the Name of Members in Opposition

Mr. Gaudreault (Jonquière) moved:

THAT the National Assembly acknowledge that Québec does not currently have full jurisdiction over infrastructures within the federal domain;

THAT the National Assembly note that, where the Port of Québec's expansion, the Energy East pipeline project, the Enbridge Line 9B reversal initiative and the rail and marine transportation of oil are concerned, Québec finds itself in the position of a tenant on its own territory;

THAT the National Assembly affirm the primacy of Québec's jurisdiction in environmental matters.

Mr. Gendron, Third Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 10 minutes to the mover of the motion for his reply; approximately 52 minutes to the parliamentary group forming the Government; approximately 30 minutes 35 seconds to the parliamentary group forming the Official Opposition; approximately 21 minutes 25 seconds to the Second Opposition Group; and 6 minutes to the independent Members. Within this framework, any time not used by the independent Members or by any of the parliamentary groups shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

At the end of his address, Mr. Jolin-Barrette (Borduas) moved:

THAT the motion moved by the Member for Jonquière be amended as follows:

By striking out the second paragraph;

By replacing the third paragraph by the following paragraph: "THAT the National Assembly ask the Government of Québec to engage in talks with the Federal Government so that Québec is granted the exclusive jurisdiction to regulate and to hold consultations on the environmental impact assessment of all economic development projects situated on its territory, even those whose infrastructures link it to one or more other provinces and those that extend beyond its borders."

The motion, as amended, would read as follows:

THAT the National Assembly acknowledge that Québec does not currently have full jurisdiction over infrastructures within the federal domain;

THAT the National Assembly ask the Government of Québec to engage in talks with the Federal Government so that Québec is granted the exclusive jurisdiction to regulate and to hold consultations on the environmental impact assessment of all economic development projects situated on its territory, even those whose infrastructures link it to one or more other provinces and those that extend beyond its borders.

Pursuant to Standing Order 98.1, Mr. Gaudreault (Jonquière) refused the amendment proposed by Mr. Jolin-Barrette (Borduas).

The debate continued on the motion moved by Mr. Gaudreault (Jonquière).

The debate being concluded, the question was put on the motion, and a recorded division was thereupon demanded.

The motion was negatived on the following vote:
