At the request of the President, Mr. Arcand, Minister of Energy and Natural Resources, withdrew certain words deemed unparliamentary.

Motions Without Notice

Mrs. Ouellet (Vachon), together with Mrs. David (Gouin), moved a motion on the transport of oil by rail in and through Québec; this motion could not be debated for want of unanimous consent.

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Labour and the Economy on its clause-by-clause consideration of Bill 42, An Act to group the Commission de l'équité salariale, the Commission des normes du travail and the Commission de la santé et de la sécurité du travail and to establish the Administrative Labour Tribunal.
