THAT the National Assembly underline that World Teachers' Day was observed on 5 October 2015 to mark the important role teachers play in academic success and school perseverance.

THAT the Minister of Labour, Employment and Social Solidarity be a member of the said Committee during its proceedings with respect to this order of reference.

Then, Mr. Ouimet, First Vice-President, informed the Assembly that on Wednesday, 7 October 2015, during Business Standing in the Name of Members in Opposition, a debate would be held on the motion moved by Mr. Roberge (Chambly).

This motion reads as follows:

THAT the National Assembly acknowledge that the budget cuts made in direct student services, particularly services to students with learning disabilities, will significantly hinder their success;

THAT it express its strong disagreement with the Minister of Education's statement that it would be misguided to reinvest in the education network at this point;

THAT it demand that the Liberal Government restore direct student services, particularly services to students with learning disabilities, which certain school boards have cut.

ORDERS OF THE DAY

Government Bills

Passage

Mr. Hamad, Minister of Labour, Employment and Social Solidarity, moved the passage of Bill 58, An Act to group the Commission administrative des régimes de retraite et d'assurances and the Régie des rentes du Québec.

A debate arose thereon.

At the request of Mr. Ouimet, First Vice-President, Mr. Therrien (Sanguinet) withdrew certain words deemed unparliamentary.

The debate being concluded, the motion was carried on division and, accordingly, Bill 58 was passed.

At 3.40 o'clock p.m., at the request of Mrs. Vien, Deputy Government House Leader, Mr. Ouimet, First Vice-President, suspended the proceedings until 6.00 o'clock p.m.
