Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

By leave of the Assembly to set aside Standing Orders 53 and 59, Mr. Martel (Nicolet-Bécancour) tabled the following:

A copy of Gouvernement du Québec Order in Council 139-2015, dated 25 February 2015, on maintaining essential services within certain public services in case of a strike.

The President gave a directive in response to a question raised by the Deputy Government House Leader on 6 October 2015 concerning written questions that were made public before being published in the *Order Paper and Notices*.

DIRECTIVE FROM THE CHAIR

Jurisprudence is silent on whether the content of written questions placed on the *Order Paper and Notices* may be disclosed before the *Order Paper and Notices* is published. However, decisions have been handed down on whether a bill can be made public before it is introduced in the Assembly.

In this regard, jurisprudence is clear: a Member may inform citizens of a bill's broad policy directions, but, as the Chair has already mentioned, the Members—not the journalists—must be the first to be informed of a bill's details, despite our great respect for the fundamental role journalists play in our democracy.

While a Member may definitely disclose the subject of a bill he or she intends to introduce and even release a broad outline, he or she must bear in mind that the Members of the National Assembly must be the first to be informed of the actual wording of the bills they are called to vote on. It is a matter of respect for the legislator's role.

With regard to written questions placed on the *Order Paper and Notices*, there are no precedents dealing specifically with whether the content of such questions may be disclosed. Given that written questions must be placed on the *Order Paper and Notices* and that the *Order Paper and Notices* is confidential until published, the text of a written question may not be disclosed before the *Order Paper and Notice's* publication. This way, all Members—Cabinet members and others—receive this information at the same time. However, as in the case of a bill, nothing prevents a Member from discussing the subject matter of a written question.

Motions Without Notice

Mr. Cloutier (Lac-Saint-Jean), together with Mrs. David (Gouin), moved a motion proposing that the Minister of Education, Higher Education and Research visit Commission scolaire de Montréal schools; this motion could not be debated for want of unanimous consent.

Mr. Jolin-Barrette (Borduas), together with Mr. Bédard (Chicoutimi), moved a motion concerning the findings of the in-house inquiry conducted by the Director of Criminal and Penal Prosecutions into the SharQc trial; this motion could not be debated for want of unanimous consent.

Mr. Blais, Minister of Education, Higher Education and Research, together with Mr. Roberge (Chambly), moved a motion concerning opening childcare services on days on which teachers are on strike; this motion could not be debated for want of unanimous consent.

Mrs. Massé (Sainte-Marie–Saint-Jacques), together with Mr. Traversy (Terrebonne), moved a motion concerning Canada’s contribution to the fight against climate change; this motion could not be debated for want of unanimous consent.

Notices of Proceedings in Committees

Mr. Sklavounos, Deputy Government House Leader, convened the following committees:

ORDERS OF THE DAY

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Public Finance on its clause-by-clause consideration of Bill 39, An Act to give effect to the Update on Québec's Economic and Financial Situation presented on 2 December 2014 and to amend various legislative provisions.

After debate thereon, the report was concurred in on division.

Passage

Mr. Blanchette, Minister for Mines, moved the passage of Bill 55, An Act respecting transparency measures in the mining, oil and gas industries.

After debate thereon, the motion was carried on division and, accordingly, Bill 55 was passed.

At 11.57 o'clock a.m., at the request of Mr. Sklavounos, Deputy Government House Leader, and by leave of the Assembly to set aside Standing Order 20, Mr. Gendron, Third Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.03 o'clock p.m.

Business Standing in the Name of Members in Opposition

Mr. Bérubé (Matane-Matapédia) moved:

THAT the National Assembly declare that the recent stay of proceedings against five members of the Hell's Angels in the SharQc trial is a fiasco that undermines the credibility of the "mega-trial" formula, which is considered an important tool in fighting organized crime;

THAT it note that, in his ruling, Justice James L. Brunton criticized Director of Criminal and Penal Prosecutions (DCPP) prosecutors;

THAT it also note that Québec police forces worked for years to gather enough evidence to bring serious charges against these highly criminalized individuals and that the Québec State devoted substantial financial resources to this effort;

THAT it acknowledge that this fiasco has occurred just as the Liberal Government decided to eliminate 40% of the prosecutors who fight organized crime, and that the Liberal Government did not keep its promise to reinvest in resources for the Director of Criminal and Penal Prosecutions;

THAT it stress how extremely serious this situation is, that an in-house DCPP inquiry alone will not restore Quebecers' confidence and that it is the duty of the Minister of Justice, who bears ultimate responsibility for the administration of justice in Québec, to order an independent inquiry;

THAT, lastly, following this inquiry, the National Assembly demand that the Minister of Justice testify before a parliamentary committee to explain the reasons that brought the SharQc trial to a halt and that, at this time, the Minister table a plan of remedial measures to be implemented within the justice system so that similar situations do not occur in future.

Mrs. Gaudreault, Second Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 10 minutes to the mover of the motion for his reply; approximately 51 minutes 30 seconds to the parliamentary group forming the Government; approximately 30 minutes 30 seconds to the parliamentary group forming the Official Opposition; approximately 21 minutes to the Second Opposition Group; and 7 minutes to the independent Members, subject to a maximum of 2 minutes for the Member for Arthabaska. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

By leave of the Assembly to set aside Standing Orders 53 and 59, Mr. Jolin-Barrette (Borduas) tabled the following:

A copy of a memorandum, dated 23 September 2015, addressed to the staff of the Directeur des poursuites criminelles et pénales by Mrs. Annick Murphy, DCCP Director, concerning review of the administrative structure of the Directeur des poursuites criminelles et pénales.
