The Assembly was called to order at 10.02 o'clock a.m.

#### ORDERS OF THE DAY

#### **Debates on Reports from Committees**

The Assembly took into consideration the report from the Committee on Transportation and the Environment, which held public hearings within the framework of special consultations with reference to the discussion paper entitled "Road safety in Québec: the use of cell phones while driving, excessive speed, motorcyclists and winter conditions". This report contains 16 recommendations.

Following a meeting with the House leaders, Mr. Cusano, First Vice-President, announced the allocation of speaking time for the proceedings with respect to this limited debate: ten minutes shall be set aside for the independent Members; the two parliamentary groups shall share equally the rest of the period allotted for this debate; within this framework, any time not used by a parliamentary group will be added to that of the other group, while any time not used by the independent Members may be redistributed equally amongst the parliamentary groups, it having been agreed that this apportionment may not be carried out before the time allotted to both parliamentary groups has entirely expired; and individual addresses shall not be limited.

By leave of the Assembly to set aside Standing Order 20, the proceedings continued beyond 12.00 o'clock p.m.

The debate expired and, pursuant to Standing Order 95, no question was put.
