

#### Information on the Proceedings of the Assembly

Mr. Ouimet, First Vice-President, informed the Assembly that on Wednesday, 18 May 2016, during Business Standing in the Name of Members in Opposition, a debate would be held on the motion moved by Mrs. Massé (Sainte-Marie–Saint-Jacques).

This motion reads as follows:

THAT the National Assembly recognize that, in 2016, only an hourly wage of \$15 or more ensures a viable income for full-time employees;

THAT the National Assembly pledge to pass a law before the end of the current legislature, establishing the hourly minimum wage at \$15 and stipulating the criteria for its annual increase.

#### **Government Bills**

Report Stage

The Assembly took into consideration the report from the Committee on Transportation and the Environment on its clause-by-clause consideration of Bill 76, An Act to modify the organization and governance of shared transportation in the Montréal metropolitan area, together with the amendments transmitted by Mr. Daoust, Minister of Transport, Sustainable Mobility and Transport Electrification, Mrs. Ouellet (Vachon) and Mr. Surprenant (Groulx).

The amendments were declared in order.

After debate thereon, the amendment proposed by Mr. Daoust, Minister of Transport, Sustainable Mobility and Transport Electrification, was carried and the amendments proposed by Mrs. Ouellet (Vachon) and Mr. Surprenant (Groulx) were negatived.

The report, as amended, was concurred in.

Passage

Mr. Leitão, Minister of Finance, moved the passage of Bill 74, An Act respecting mainly the implementation of certain provisions of the Budget Speech of 26 March 2015.

After debate thereon, the motion was carried and, accordingly, Bill 74 was passed.
