Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mr. Charette (Deux-Montagnes), together with Mr. Bergeron (Verchères) and Mrs. Massé (Sainte-Marie-Saint-Jacques), moved:

THAT the National Assembly denounce the Federal Government's intention to reduce the increase in federal health transfers from 6% to 3% beginning in 2017–2018 and that the Assembly demand that the Federal Government keep its campaign promise to renegotiate federal health transfers with the provinces, reminding it that health falls under exclusive provincial jurisdiction.

The question was put on this motion, and a recorded division was thereupon demanded.

Government Bills

Passage in Principle

Mr. Arcand, Minister of Energy and Natural Resources, informed the Assembly that the Honourable J. Michel Doyon, Lieutenant-Governor of Québec, recommended Bill 106, An Act to implement the 2030 Energy Policy and to amend various legislative provisions, for its consideration, and then moved that this Bill do now pass in principle.

A debate arose thereon.

At the end of his address, Mr. Therrien (Sanguinet) moved the following motion to divide the said Bill:

THAT, pursuant to Standing Order 241, Bill 106, An Act to implement the 2030 Energy Policy and to amend various legislative provisions, be divided into four bills:

The first of which shall be entitled "An Act respecting Transition énergétique Québec" and shall comprise sections 1 and 24, except the words "(2) sections 11 to 14, which come into force on the date of coming into force of the rules of procedure applicable to mediation adopted by the Régie de l'énergie under section 113 of the Act respecting the Régie de l'énergie (chapter R-6.01), as amended by section 16; and (3) Chapter IV, which comes into force on the date of coming into force of the first regulation that replaces, after (*insert the date of assent to this Act*), the Regulation respecting petroleum, natural gas and underground reservoirs (chapter M-13.1, r. 1), except sections 38 to 44, 110 to 112, 235 and 249, which come into force on the date to be set by the Government.";

The second of which shall be entitled "An Act respecting governance of the Régie de l'énergie and renewal of energy supply to consumers" and shall comprise sections 2 to 19 and 24, except the words "(1) Chapter I, which comes into force on 1 April 2017, except sections 1, 2, 6, 22 to 24, 27 to 29, 32 to 38, 40 to 42, 44, 47, 48 and 79, which come into force on (*insert the date that is 30 days after the date of assent to this Act*); (3) Chapter IV, which comes into force on the date of coming into force of the first regulation that replaces, after (*insert the date of assent to this Act*), the Regulation respecting petroleum, natural gas and underground reservoirs (chapter M-13.1, r. 1), except sections 38 to 44, 110 to 112, 235 and 249, which come into force on the date to be set by the Government.";

The third of which shall be entitled "An Act respecting financing of the electric infrastructure for a shared transportation project" and shall comprise sections 20, 21, 22 and 24, except the words ", except (1) Chapter I, which comes into force on 1 April 2017, except sections 1, 2, 6, 22 to 24, 27 to 29, 32 to 38, 40 to 42, 44, 47, 48 and 79, which come into force on (insert the date that is 30 days after the date of assent to this Act); (2) sections 11 to 14, which come into force on the date of coming into force of the rules of procedure applicable to mediation adopted by the Régie de l'énergie under section 113 of the Act respecting the Régie de l'énergie (chapter R-6.01), as amended by section 16; and (3) Chapter IV, which comes into force on the date of coming into force of the first regulation that replaces, after (insert the date of assent to this Act), the Regulation respecting petroleum, natural gas and underground reservoirs (chapter M-13.1, r. 1), except sections 38 to 44, 110 to 112, 235 and 249, which come into force on the date to be set by the Government.";

The fourth of which shall be entitled the "Petroleum Resources Act" and shall comprise sections 23 and 24, except the words "(1) Chapter I, which comes into force on 1 April 2017, except sections 1, 2, 6, 22 to 24, 27 to 29, 32 to 38, 40 to 42, 44, 47, 48 and 79, which come into force on (insert the date that is 30 days after the date of assent to this Act); (2) sections 11 to 14, which come into force on the date of coming into force of the rules of procedure applicable to mediation adopted by the Régie de l'énergie under section 113 of the Act respecting the Régie de l'énergie (chapter R-6.01), as amended by section 16;".

At 4.22 o'clock p.m., Mr. Ouimet, First Vice-President, suspended the proceedings.

The proceedings resumed at 4.38 o'clock p.m.

At 4.45 o'clock p.m., after hearing arguments from all sides regarding the receivability of the motion to divide, Mrs. Gaudreault, Second Vice-President, took the matter under advisement.

The proceedings resumed at 5.39 o'clock p.m.

Mrs. Gaudreault, Second Vice-President, ruled on the receivability of the motion to divide moved by Mr. Therrien (Sanguinet).

RULING FROM THE CHAIR

The bill contains more than one principle. It begins by enacting two distinct laws, a legislative drafting technique that inarguably facilitates the receivability of a motion to divide. In addition, the four bills that would result from the motion to divide correspond to four separate chapters of the bill, also an indication that they are concepts that can stand alone.

More specifically, the first law enacted establishes a legal person who will contribute to "energy transition, innovation and efficiency". The second law enacted governs the "development of petroleum resources". In light of the criteria established by jurisprudence, these two enacted laws must be considered two separate, essential elements not simply two terms within a single broader principle. Two other distinct principles are identified in the motion to divide. One amends the *Act respecting the Régie de l'énergie* concerning the distribution of renewable natural gas, promoting the use of mediation and allowing the Régie to hold public information and consultation sessions. The other discusses the proposed electrification of shared transportation services. Once again, while the subject matter is still energy-related, these different amendments are not simply terms and can be considered separately.

Lastly, the motion divides the section that concerns the provisions of coming into force. Amending the content of a section is established practice in parliamentary jurisprudence in order to render a motion to divide receivable.

Consequently, the motion meets the receivability criteria inherent in a motion to divide and is declared receivable.

Mrs. Gaudreault, Second Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to the limited debate on this motion to divide: 57 minutes to the parliamentary group forming the Government; 33 minutes 15 seconds to the parliamentary group forming the Official Opposition; 23 minutes 45 seconds to the Second Opposition Group; and 6 minutes to the independent Members. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

The Assembly entered upon the debate on the motion to divide moved by Mr. Therrien (Sanguinet).

At 6.00 o'clock p.m., Mrs. Gaudreault, Second Vice-President, adjourned the Assembly until Tuesday, 4 October 2016 at 1.40 o'clock p.m.
