Deferred Divisions

Mr. Marceau (Rousseau), together with Mr. Bonnardel (Granby), moved a motion concerning the Federal Government's awarding of a loan guarantee covering the entire Muskrat Falls hydroelectric project; this motion could not be debated for want of unanimous consent.

Mrs. David (Gouin) moved a motion to hold a parliamentary committee on all of the appointments made by the office of various Premiers between 1996 and 2012; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 84.1 and pursuant to Standing Order 146, Mr. Tanguay, Deputy Government House Leader, moved:

THAT, within the framework of the consideration of Bill 108, An Act to facilitate oversight of public bodies' contracts and to establish the Autorité des marchés publics, the Committee on Public Finance hold special consultations and public hearings on 17 November 2016;

THAT, for this purpose, the Committee hear the following:

THAT the presentation by each individual or organization last no longer than 10 minutes and the exchange with the Committee members last no longer than 35 minutes, allocated as follows: 17 minutes 30 seconds to the parliamentary group forming the Government, 10 minutes 30 seconds to the parliamentary group forming the Official Opposition, and 7 minutes to the Second Opposition Group;

THAT the Minister responsible for Government Administration and Ongoing Program Review and Chair of the Conseil du trésor be a member of the said Committee during its proceedings with respect to this order of reference.

Government Bills

Passage in Principle

Mrs. Vallée, Minister of Justice, moved that Bill 62, An Act to foster adherence to State religious neutrality and, in particular, to provide a framework for religious accommodation requests in certain bodies, do now pass in principle.

The proceedings resumed at 3.00 o'clock p.m.

The Assembly continued the debate on the motion moved by Mrs. Vallée, Minister of Justice, that Bill 62, An Act to foster adherence to State religious neutrality and, in particular, to provide a framework for religious accommodation requests in certain bodies, do now pass in principle.

The debate being concluded, the question was put on this motion, and a recorded division was thereupon demanded.

At the request of Mrs. Vien, Deputy Government House Leader, the division was deferred until Routine Proceedings on the next sitting day.
