Moment of reflection

The President made a statement about the recorded division that took place on Thursday, 10 November 2016 on Bill 70, An Act to allow a better match between training and jobs and to facilitate labour market entry.

STATEMENT FROM THE CHAIR

A parliament's role is to deliberate. It is the appropriate venue for voicing one's opposition to an issue or a bill, and each Member may take the floor and participate in its debates.

A recorded division, however, is a solemn event of a sacred nature that must not be distorted. What occurred during the recorded division of 10 November 2016 goes against the principles that are the cornerstones of our democracy and constitutes an unjustified violation of decorum, an insult to parliamentarians and to the institution.

The Chair will never condone such behaviour.

By unanimous leave of the Assembly to set aside its Standing Orders, Mr. Lisée, Leader of the Official Opposition, together with Mr. Paradis, Minister of Agriculture, Fisheries and Food, Mr. Legault, Leader of the Second Opposition Group, and Mrs. David (Gouin), moved:

THAT the National Assembly mark the Member for Abitibi-Ouest's 40-year parliamentary career.

Mr. Lisée, Leader of the Official Opposition, Mr. Paradis, Minister of Agriculture, Fisheries and Food, Mr. Legault, Leader of the Second Opposition Group, Mrs. David (Gouin), Mr. Gendron (Abitibi-Ouest) and the President spoke to this motion.

The motion was then carried.

Introduction of Bills

Deferred Divisions

The Assembly took the division, which had been deferred at the sitting of 10 November 2016, on the motion moved by Mrs. Vallée, Minister of Justice, that Bill 62, An Act to foster adherence to State religious neutrality and, in particular, to provide a framework for religious accommodation requests in certain bodies, pass in principle.

By leave of the Assembly to set aside Standing Order 185, Mrs. Anglade, Minister of Economy, Science and Innovation, together with Mr. LeBel (Rimouski), Mr. Legault, Leader of the Second Opposition Group, and Mrs. Massé (Sainte-Marie–Saint-Jacques), moved:

THAT the National Assembly mark Semaine de l'économie sociale, held from 7 to 17 November 2016 to spotlight the social economy;

THAT it recognize the social economy's important contribution in all Québec regions;

THAT the National Assembly ask the Government to speed up its inspection of the 700 inactive wells throughout Québec and to quickly implement the measures needed to ensure that problem wells are properly closed up.

Information on the Proceedings of the Assembly

Mr. Gendron, Third Vice-President, informed the Assembly that on Wednesday, 16 November 2016, during Business Standing in the Name of Members in Opposition, a debate would be held on the motion moved by Mr. Caire (La Peltrie).

This motion reads as follows:

THAT the National Assembly mandate the Auditor General of Québec to audit the optimization of resources linked to the Société immobilière du Québec's sale of assets between 2003 and 2012;

THAT the Assembly also mandate the Auditor General of Québec to audit all contracts and agreements, including leases, entered into between Québec Government departments and bodies and Mr. Georges Gantcheff's companies.

ORDERS OF THE DAY

Government Motions

By leave of the Assembly and pursuant to section 22.3 of the *Act respecting the Ministère des Relations internationales*, the Assembly held the debate on the motion that arose from the tabling of the Paris Agreement of the Framework Convention on Climate Change, on 8 November 2016, by Mrs. St-Pierre, Minister of International Relations and La Francophonie.

This motion reads as follows:

THAT, pursuant to section 22.3 of the *Act respecting the Ministère des Relations internationales*, the National Assembly approve the Paris Agreement of the Framework Convention on Climate Change.

Mr. Gendron, Third Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 57 minutes to the parliamentary group forming the Government; 33 minutes 15 seconds to the parliamentary group forming the Official Opposition; 23 minutes 45 seconds to the Second Opposition Group; and 6 minutes to the independent Members. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

Pursuant to Standing Order 100, Mrs. Vien, Deputy Government House Leader, moved the adjournment of the debate.

The motion was carried.

Accordingly, the debate on the motion moved by Mrs. St-Pierre, Minister of International Relations and La Francophonie, was adjourned.

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Culture and Education on its clause-by-clause consideration of Bill 105, An Act to amend the Education Act, together with the amendments transmitted by Mr. Cloutier (Lac-Saint-Jean).

The amendments were declared in order.
