**RULING FROM THE CHAIR**

The request for an urgent debate is not receivable. In our parliamentary system, the dissolution of the Assembly is an act which comes under the exclusive initiative of the executive power. Since the Chair may not rule on hypothetical questions, it may not presume that the Assembly will be dissolved and that there will not be any forthcoming opportunity to discuss the matter. Even if the request deals with a specific matter, of distinct importance and which comes under the authority of Assembly, Members could have other opportunities to discuss the matter during the debate on the Budget Speech or the debate on a motion moved by Members in Opposition or the debate on a want of confidence motion, as well as during an interpellation.
