- (220) Mrs. Massé (Sainte-Marie–Saint-Jacques) – **7 February 2017**
To the Minister of Finance

The independent community action groups have been campaigning since fall 2016 under the banner "Take community action" in order to get a significant increase in the core funding of independent community organizations and an end to cutbacks in public services and social programs. At present, by cutting back in public services and social programs, the Minister of Finance is playing with people's living conditions. They find themselves in very difficult situations and must turn to community organizations to get help. The latter are already being crushed under the weight of underfunding. To fulfill their role and carry out their mission, the organizations are asking for \$475M in core funding.

Last 8 November, the Members of the National Assembly, including the Minister of Finance, unanimously carried a motion asking the Government to increase funding for independent community organizations.

- Will the Minister of Finance reply to the request of the 4,000 provincial independent community organizations by providing for an additional 475 million dollars per year in the next budget, so that they may adequately carry out their mission?

- Will the Minister commit to observing the Policy on the recognition of community action adopted in 2001, which stipulates that all Government authorities must observe the independence of groups, implement or maintain funding programs specifically for independent community action and recognize the contribution of community action to Québec society, particularly the contribution of the ACA movement and the importance of the role of collective rights advocacy groups?

(222) Mr. Charette (Deux-Montagnes) – **16 February 2017**

To the Minister of Transport, Sustainable Mobility and Transport Electrification

In May 2012, the Government of Québec awarded a \$120-million contract to the Davie Shipyard for the construction of two ships to replace the Tadoussac–Baie-Ste-Catherine ferries. After several upward revisions to the cost of the project, and almost a two-year delay, we found out last November that the costs could rise to as high as \$100 million more than the initial cost.

In light of these revelations, the Minister of Transport had described the situation as a "dispute" between the Société des traversiers du Québec and the Davie Shipyard. He had stated that an expert was to be dispatched to the shipyard to report on the progress of the project and to evaluate the cost of the work that had been done and that remained to be done.

Over the weekend, La Presse mentioned a report that advocates taking the unfinished ships from Lévis and finishing them in another shipyard.

In this same article, a federal government source reports that another project for the Royal Canadian Navy is proceeding normally, on time and on budget. According to this same article, the Société des traversiers du Québec's management of the project is more at issue here.

Could the Minister release the reports that were submitted to him? Could he also tell us what the final cost will be to replace the Tadoussac–Baie-Ste-Catherine ferries and when the Société des traversiers du Québec will put these new ships into service?

(223) Mrs. Léger (Pointe-aux-Trembles) – **21 February 2017**
To the Chair of the Conseil du trésor

During the clause-by-clause consideration of Bill 87, An Act to facilitate the disclosure of wrongdoings relating to public bodies, I introduced an amendment to create a whistleblowers support fund.

Though your predecessor as Chair of the Conseil du trésor and Member for Robert-Baldwin rejected the said amendment, he had invited me to attend the next prebudget consultations in order to examine this matter, stating "[Translation] I could officially invite you to take part in the prebudget consultations, at which time we would examine that very matter well before the 12 months" (2 December 2016, Committee on Public Finance).

The minister had explicitly conceded that the use of revenues from fines stemming from the application of the law deserved some reflection: "[Translation] I told the committee that I was absolutely open to carrying out this reflection exercise. I think it is relevant to envisage the manner in which sums stemming from fines will be used and to reflect on this matter somewhat more broadly. [...] There is a need for Government reflection on whether it is relevant or not to provide this or another type of financial support to whistleblowers." (2 December 2016, Committee on Public Finance).

My questions are the following:

- Did the new Chair of the Conseil du trésor continue the reflection exercise on the creation of a whistleblowers support fund launched by his predecessor?
- Does he intend to establish a whistleblowers support fund?

(224) Mrs. Fournier (Marie-Victorin) – **21 February 2017**
To the Minister of Justice and to the Minister responsible for the Status of Women

Women generally pay more for certain basic products than men do. Personal care products and cosmetics are at the top of the list of main suspects: shampoo, deodorant, razors, perfume. Colloquially speaking, this is known as a "pink tax".

To one of the questions I asked him last 15 February, the Minister of Finance acknowledged that there was discrimination. He added that "[Translation] these are retailers' price practices", that it is "[Translation] the large retailers that discriminate" (Oral Question Period, 15 February 2017). He also specifically added that the Government was to tackle these price practices.

The Minister of Justice also voiced her concerns in this regard. She added that there was "[Translation] a lack of data preventing us from establishing whether there is indeed and conclusively true discrimination as regards certain price differences" (Oral Question Period, 15 February 2017).

(225) Mr. Traversy (Terrebonne) – **14 March 2017**

To the Minister of Minister of Tourism

The Olympic Stadium is one of Québec's undeniable assets. Owing to its size, it is the only place where large-scale events can be held. But for the past few years – since the first tear in the roof in 1999, in fact – it has been very difficult to hold activities there between 1 November and mid-April, for safety reasons. As a result of this situation, the Régie des installations olympiques (RIO) holds approximately four exhibitions per year, whereas with a safe roof, it could hold twelve. This reduction in activities represents an income loss of over \$50 million annually.

Over a year ago, on 3 November 2015, the RIO tabled its opportunity study on the replacement of the roof. In order to move forward to the implementation phase and prepare the business file, the RIO is still waiting for the Minister's reply. We would therefore like to know:

- Will the Minister give the green light to the RIO so that it may implement the recommendations included in its opportunity study?
- Is this project a priority for the Minister and will it be included in the Québec infrastructure plan, whose update will be published in the next budget?

(226) Mr. Gaudreault (Jonquière) – **14 March 2017**

To the Minister of Transport, Sustainable Mobility and Transport Electrification

On 20 February 2017, the Minister of Transport, Sustainable Mobility and Transport Electrification sent the Committee on Public Administration a document entitled "Sommes du Fonds vert virées au FORT dans le cadre du Plan d'action 2013-2020 sur les changements climatiques – Suivi de la recommandation 7.6 du 34e rapport de la Commission de l'administration publique".

Concerning the graph "Sommes virées du Fonds vert au FORT dans le cadre du Plan d'action 2013-2020 sur les changements climatiques – Effets sur la réduction des émissions de GES » (p. 5):

- How does the Ministère identify the projects that the "Programme d'aide gouvernementale au transport collectif des personnes (PAGTCP) – FORT" would have funded, had it not been for the existence of the Green Fund?

Concerning table 2 "Programmes et mesures financées par le FORT à partir des sommes virées du Fonds vert" (p. 8):

- Why is the Programme d'aide au développement du transport collectif (PADTC) (action 13.7) for 2017 still not in effect?

Concerning table 3 "Quantification de la réduction des émissions de GES – Programme d'aide gouvernementale au transport collectif des personnes (PAGTCP) (action 13.2)" (p. 9):

- What are the Ministère's criteria to establish which "projects having a direct impact on the reduction of GHG emissions" can receive sums transferred from the Green Fund to the FORT?
- Is the "direct impact on the reduction of GHG emissions" criterion the only determining factor for the Ministère's use of the Green Fund sums over the course of the 2013-2020 Climate Change Action Plan?
- What are the direct impact indicators allowing to determine a project's qualification in relation to another project?

(227) Mr. Pagé (Labelle) – **14 March 2017**

To the Minister of Education, Recreation and Sports

On 13 February 2017, the Minister of Education, Recreation and Sports announced a \$57-million grant for the implementation of 80 projects within the framework of the Programme de soutien pour le remplacement ou la modification des systèmes de réfrigération fonctionnant aux gaz R-12 ou R-22 : arénas et centres de curling. The financial assistance granted to the applicants concerns the use of several refrigeration technologies, including CO₂, ammonia and HFO R-513A.

According to the mathematical information contained in the minister's various press releases in relation to this announcement, applicants (particularly municipalities) largely opted for HFO R-513, a refrigerant that goes against the MDDELCC notice issued on 7 December 2015. This notice specifies that to produce an icy surface, the use of this substance should be conditional on the PRP remaining at a level that compares with CO2's PRP level, that is, equivalent to one.

The Government decided to subsidize projects that will in large part use a refrigerant that not only pollutes, but also goes against the MDDELCC notice in a ratio of 600 to 1.

Here are the questions:

- Do all of the announced projects observe the condition stipulated by the MDDELCC in its notice of 7 December 2015, namely that refrigerants used systematically have a PRP that compares with CO2's PRP level?
- How can the Government justify its decision to subsidize these systems, whose ownership cost is more expensive, in addition to going against a MDDELCC notice?
- On 25 November 2016, the Minister of Sustainable Development, the Environment and the Fight Against Climate Change announced that PureSphera will receive an amount of \$5 million for two technologies: first, a project to recover refrigeration system gases and blowing agents used in the insulating foam of refrigerators; and another to safely destroy refrigerants and gases. How can the Government justify the reasons behind its decision to subsidize a type of polluting refrigerant rather than natural refrigerants?

(228) Mr. Martel (Nicolet-Bécancour) – **15 March 2017**
To the Minister of Agriculture, Fisheries and Food

At the beginning of summer 2016, a major fire blight epidemic contaminated thousands of apple trees in Québec. Hundreds of apple growers found themselves in an unenviable situation.

Last July, the industry's stakeholders addressed the problems related to the fight against fire blight. A significant workload is imposed on apple growers, who spend more time treating the epidemic than cultivating their land.

The removal of diseased branches results in production losses. This places a financial burden on apple growers, who must hire additional personnel to fight fire blight and cope with a considerable loss of income.

The Minister of Agriculture at the time had ensured a rapid response and the ministry's help to fight against fire blight. This help never materialized, and the Minister finally admitted that he would wait until Ottawa provided financial assistance before setting up a periodic assistance program.

Yet my colleague who held this position before me had proposed to the Minister a concrete action plan, which was also requested by the producers, a rapid financial response to allow apple growers to hire personnel to fight against fire blight, as well as to facilitate access to agricultural financial security programs to buffer the 2016 harvest losses.

As we near summer 2017, nothing has been done. The ministry of Agriculture remains silent regarding this issue, and we fear that apple growers will again be left to their own devices. Can the Minister inform us of the current state of affairs in his ministry's work concerning forthcoming assistance to apple growers dealing with the fire blight epidemic?
