The Assembly was called to order at 9.45 o'clock a.m.

Motions Without Notice

Pursuant to Standing Order 26.1, Mr. Fournier, Government House Leader, moved:

THAT, in order to proceed with the introduction and all stages of consideration of Bill 142, An Act to ensure the resumption of work in the construction industry and the settlement of disputes for the renewal of the collective agreements, the Assembly appoint the hours of meeting as follows;

THAT the Assembly be permitted to sit every day, beginning at 9.45 o'clock a.m., until it has concluded consideration of the matter for which it was summoned or until it decides to adjourn its proceedings.

Pursuant to Standing Order 26.1, Mr. Fournier, Government House Leader, moved:

THAT, in order to proceed with the introduction and all stages of consideration of Bill 142, An Act to ensure the resumption of work in the construction industry and the settlement of disputes for the renewal of the collective agreements, the Assembly establish the exceptional legislative procedure provided for in Standing Orders 182 to 184.2 and 257.1 to 257.10;

THAT the President be permitted to suspend the proceedings at any time during the sitting at the request of a Minister or Deputy Government House Leader.

At 10.56 o'clock a.m., the President suspended the proceedings to allow the Members to examine the motions moved by Mr. Fournier, Government House Leader.

The proceedings resumed at 11.11 o'clock a.m.

At 11.12 o'clock a.m., the President suspended the proceedings to allow the Members to examine Bill 142, An Act to ensure the resumption of work in the construction industry and the settlement of disputes for the renewal of the collective agreements.

The proceedings resumed at 1.16 o'clock p.m.

Mr. Ouimet, First Vice-President, informed the Assembly that the motions moved by Mr. Fournier, Government House Leader, were receivable.

Limited Debate

Mr. Ouimet, First Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate on the reasons why the Assembly was summoned for extraordinary sittings and on both motions moved by the Government House Leader, namely the motion to appoint the times during which the Assembly shall meet and the motion to introduce an exceptional legislative procedure: 56 minutes 30 seconds to the parliamentary group forming the Government; 32 minutes 57 seconds to the parliamentary group forming the Official Opposition; 23 minutes 32 seconds to the Second Opposition Group; and 7 minutes to the independent Members, subject to a maximum, based on the number of Members who indicated their intention to speak, of 2 minutes each for the Member for Groulx and the Member for Vachon, and 6 minutes for the two Members of Québec solidaire. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

The debate being concluded, the question was put on the motion to appoint the hours during which the Assembly shall meet, and a recorded division was thereupon demanded.

ORDERS OF THE DAY

Introduction of Bills

Mrs. Vien, Minister responsible for Labour, moved that leave be granted to introduce the following bill:

An Act to ensure the resumption of work in the construction industry and the settlement of disputes for the renewal of the collective agreements

The motion was carried on division.

Accordingly, Bill 142 was introduced in the Assembly.

Government Bills

Passage in Principle

Mrs. Vien, Minister responsible for Labour, moved that Bill 142, An Act to ensure the resumption of work in the construction industry and the settlement of disputes for the renewal of the collective agreements, do now pass in principle.

Mrs. Gaudreault, Second Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this debate: 2 hours 21 minutes 15 seconds to the parliamentary group forming the Government; 1 hour 22 minutes 24 seconds to the parliamentary group forming the Official Opposition; 58 minutes 51 seconds to the parliamentary group forming the Second Opposition Group; and 17 minutes 30 seconds to the independent Members, subject to a maximum, based on the number of Members who indicated their intention to speak, of 5 minutes each for the Member for Groulx and the Member for Vachon, and 10 minutes for the two Members of Québec solidaire. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

The debate being concluded, the question was put on the motion, and a recorded division was thereupon demanded.

The motion was carried on the following vote:

Accordingly, Bill 142 was passed in principle.

Committee of the Whole

Since the time allotted to the Committee of the Whole had elapsed, Bill 142, as amended, was thereupon reported.

At 11.43 o'clock p.m., Mr. Gendron, Third Vice-President, suspended the proceedings.

Report Stage

The Assembly took into consideration the report from the Committee of the Whole on its clause-by-clause consideration of Bill 142, An Act to ensure the resumption of work in the construction industry and the settlement of disputes for the renewal of the collective agreements, together with the amendments transmitted by Mr. Bourcier (Saint-Jérôme), Mr. Picard (Chutes-de-la-Chaudière) and Mrs. Massé (Sainte-Marie–Saint-Jacques).

Mr. Ouimet, First Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this debate: 28 minutes 15 seconds to the parliamentary group forming the Government; 16 minutes 29 seconds to the parliamentary group forming the Official Opposition; 11 minutes 46 seconds to the Second Opposition Group; and 3 minutes 30 seconds to the independent Members, subject to a maximum, based on the number of Members who indicated their intention to speak, of 1 minute each for the Member for Groulx and the Member for Vachon, and 2 minutes for the two Members of Québec solidaire. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

The debate being concluded, Mr. Ouimet, First Vice-President, put the question on the amendments.

The amendments proposed by Mr. Bourcier (Saint-Jérôme), on questions put severally thereon, were negatived.

The amendment proposed by Mr. Picard (Chutes-de-la-Chaudière), on the question put thereon, was negatived.

The amendments proposed by Mrs. Massé (Sainte-Marie-Saint-Jacques), on questions put severally thereon, were negatived.

The question was put on the report, and a recorded division was thereupon demanded.
