THAT the National Assembly ask the Government to ensure that, henceforth and as soon as possible, the QST be collected from all foreign companies offering goods and services online, especially in the cultural sector.

Mrs. Roy (Montarville), together with Mrs. Poirier (Hochelaga-Maisonneuve), moved a motion concerning the committee on systemic racism; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Nadeau-Dubois (Gouin), together with Mr. Fortin, Minister of Culture and Communications and Minister responsible for the Protection and Promotion of the French Language, moved:

THAT the National Assembly reiterate its support to the creators and artisans of the Québec cultural industry;

THAT the Assembly reiterate that State support is vital for the development of our French-language culture, which is unique in North America;

THAT the National Assembly strongly condemn the agreement that the Federal Government has entered into with Netflix, as it does not guarantee tax equity or a level regulatory playing field between cultural industry players;

THAT, lastly, the National Assembly ask the Federal Government to enforce compliance with tax laws.

By leave of the Assembly, the motion was carried.
