(1) Pursuant to Standing Orders 275 and 276, continuation of the debate on the motion by the Minister of Finance, –That this Assembly approves the budgetary policy of the Government,

And on the motions stating a grievance moved by:

## The Member for Rousseau:

THAT the National Assembly severely censure the Liberal Government for having presented a completely irresponsible, pre-electoral budget.

## The Member for Granby:

THAT the National Assembly severely censure the Liberal Government for its pre-electoral budgetary policy designed to artificially inflate the expenditures resulting from the increased tax burden on Québec families since beginning its term of office in 2014.

## The Member for René-Lévesque:

THAT the National Assembly severely censure the Liberal Government for having presented a budget that consolidates Air Canada's monopoly, that favours the high cost of airfares in the regions and that penalizes citizens who want to travel throughout Québec at a reasonable price.

#### The Member for La Peltrie:

THAT the National Assembly severely censure the Liberal Government for the 4-year delay in carrying out work related to the third link between Québec City and Lévis and for misleading the people of Québec City and its environs about its true intentions regarding realization of the third link project.

## The Member for Chicoutimi:

THAT the National Assembly severely censure the Liberal Government for having presented a pre-electoral budget funded by using a stabilization reserve accounting entry to avoid having to post a deficit.

#### The Member for Saint-Jérôme:

THAT the National Assembly severely censure the Liberal Government for having presented a budget that contains no measures to improve electric fast-charging infrastructure.

#### The Member for Berthier:

THAT the National Assembly severely censure the Liberal Government for having presented a budget that ignores the next generation of Québec farmers.

## The Member for Sainte-Marie-Saint-Jacques:

THAT the National Assembly censure the Liberal Government for its 2018–2019 budget, which perpetuates the unfair tax treatment of Québec businesses compared to digital platforms based abroad as concerns collection of the Québec sales tax.

THAT the National Assembly severely censure the Liberal Government for presenting a budget that will bring about a return to austerity after the general election.

#### The Member for Levis:
