304) Mrs. Roy (Montarville) – **9 May 2018**

To the Minister responsible for Access to Information and the Reform of Democratic Institutions

The chief scientist, in a brief entitled "Orientations gouvernementales pour un gouvernement plus transparent, dans le respect de la vie privée et de la protection des renseignements personnels" (Government policy directions for a more transparent government, respectful of a person's right to privacy and the protection of personal information), and Québec's community of clinician researchers maintain that it is immediately possible to save lives by accessing medical data contained in the government's health databases. However, owing to the restrictive character of the *Act respecting Access to documents held by public bodies and the Protection of personal information*, health databases are rarely made available to Québec researchers.

While the Commission d'accès à l'information's work is irreproachable regarding managing individual rights and protecting personal health information, some might wonder whether the Commission's restrictive rulings and decisions run counter to the moral and ethical precedence of the sanctity of life. The Commission's decisions seem to interfere with the common good and break the social contract in the name of a legal satisfaction that does not resonate within Québec society.

All political and legal stakeholders have a clear understanding of the required counterbalance to the *Act respecting Access* to ensure balance with legitimate societal interests, such as public safety and the administration of justice for instance, but these very stakeholders remain blocked in relation to access to health information, whose capacity to immediately save lives has been proved time and again. It is evident that the current Act is therefore too restrictive vis-à-vis access to health data and that an administrative tribunal's rulings (such as those handed down by the Commission d'accès à l'information) are an inadequate means of arbitrating complex situations and seizing the opportunity to save lives and improve the health of Québec's population.



From the perspective that Québec lags behind in access to government medical data and that access to this data saves lives, notably through innovative research designs, and also taking into consideration the progress made in several countries, including Ontario's leadership, I would like to know if the minister plans to amend the act in order to:

1. Allow university researchers and academics to link medical files directly to government health databases (including survival, data derived from hospitalization – including International Classification of Diseases (ICD) codes particularly –, prescription drug use, physician billing, medical testing) to enable a pragmatic administrative follow-up that will respond to medical issues of common interest;
2. Divert from the court system, therefore remove the process for accessing government data task from the Commission d'accès à l'information to allow for more flexibility in the process and facilitate collaboration between the government and researchers. To achieve this, reviewing the relevance of a request for access to information and educating applicants on regulatory aspects could be carried out through a panel of peers;
3. Promote the creation of secured government and university co-institutes dedicated to research and capable of carrying out government, academic and public mandates, for the sake of Quebecers' health and to improve the governance of the health system (such as the Institute for Clinical Evaluative Sciences – or ICES – in Ontario);
4. Modernize the individual consent process for access to government data to adapt it to the current digital environment, technological advances and new data dynamics.

(305) Mr. Jolin-Barrette (Borduas) – **10 May 2018**

To the Minister for Rehabilitation, Youth Protection, Public Health and Healthy Living

The Association des Arches du Québec is made up of eight communities in the province. The Arches enable persons with or without intellectual disabilities to live together. This closeness helps break down barriers and create strong ties among members of the community.

As a member of the provincial association, Arche Beloeil's mission is to provide support services and a living environment to persons with intellectual disabilities. Since 1981, it has accommodated 17 residents and assistants in one of the three houses adapted to their needs. Also, thanks to visual arts, it gives these individuals an opportunity to grow and achieve their potential in Le Pot-en-ciel art workshop.

The organization currently receives an annual amount of \$389,709 through the Programme de soutien aux organismes communautaires (PSOC), which represents \$62.81 per day/resident. The Québec average is \$67.71, which places Arche Beloeil below the average.

Although the PSOC is regionalized, the amounts allocated among the organizations having a similar mission should be fair and equitable. Arche Saint-Malachie, a comparable organization, receives an amount of \$598,990 annually, which is equal to \$91.17 per day/resident.

Well aware of this discrepancy, representatives of the provincial association took steps to underline this injustice and demand that equity be restored among Québec's Arches.

What does the Minister intend to do ensure that the amounts allocated through the Programme de soutien aux organismes communautaires are distributed equitably among Québec's Arches?

(306) Mr. Turcotte (Saint-Jean) – **16 May 2018**

To the Minister of Transport, Sustainable Mobility and Transport Electrification

Built in 1915, the Gouin Bridge in the Vieux-Saint-Jean sector was declared a bridge of strategic importance by your department on 25 May 2005. The heavy traffic load, the cost of rebuilding the bridge and its availability as an alternative route for Highway 35 make the rebuilding of this infrastructure a major issue for the Haut-Richelieu region.

Following one of my many interventions on this issue, one of your predecessors had confirmed, in a reply tabled in the National Assembly on 24 May 2016, that the department recommended the decommissioning of the current bridge by December 2018. On 6 February 2017, your colleague the Minister responsible for the Montérégie region hastily announced that the bridge would be rebuilt. Unfortunately, the detailed schedule was never made public, even though this has a more than considerable impact on the residents and businesses in the sector. Furthermore, the rebuilding of the bridge has seriously delayed the revitalization of the Vieux-Saint-Jean sector.

- Can you confirm that the original schedule for the opening of the new bridge in December 2018 is still valid?
- If not, can you explain the reasons justifying additional delays?
- In the event that there are additional delays, can you put a figure on the associated cost overruns?
- In the event that there are additional delays, were and will new safety assessments be carried out on the current Gouin Bridge structure?

(308) Mr. Nadeau-Dubois (Gouin) – **17 May 2018**  
To the Minister responsible for Higher Education

The Conseil supérieur de l'éducation (CSÉ) is an important organization for our public education network. Yet, for almost two years now, the Government has declined to appoint a chair of this independent and therefore separate body from the Ministère de l'Éducation et de l'Enseignement supérieur.

The Minister responsible for Higher Education should value the CSÉ. This recognition has not materialized in recent years.

Will the Minister responsible for Higher Education commit to appointing a chair of the Conseil supérieur de l'éducation as soon as possible?

(309) Mr. Roberge (Chambly) – **5 June 2018**  
To the Minister of Education, Recreation and Sports

Dysphasia is a little-known disorder to this day. This disorder, now referred to as developmental language disorder, is defined as a persistent disorder that affects comprehension and the generation of speech. This is not the result of a lack of stimulation, a sensory deficiency, nor of an intellectual disability. This language disorder may affect several areas of children's lives, particularly during school attendance, since these children have difficulty expressing themselves and understanding anything relating to language. In Québec, an estimated 9.4% of five-year-old children have this disorder. Of these, 72% will still suffer from dysphasia at the age of twelve. This represents over 100,000 young Quebecers under 19 years of age.

Almost a year and a half ago, the association Parlons Dysphasie launched a petition on its website in which it asked that the Government of Québec and the Minister of Education:

- 1) Recognize dysphasia as a genuine health disorder;
- 2) Recognize all persons suffering from dysphasia, including those without code 34 attending school;
- 3) Develop professional services for children beyond the age of five who suffer from dysphasia;
- 4) Establish a national network on dysphasia and related disorders, consisting of specialists hailing from the education, health and social services sectors, in partnership with families.

On 18 May 2017, on behalf of Parlons Dysphasie, I handed the Minister of Education, Sébastien Proulx, a copy of this petition containing 3014 signatures as well as documentation pertaining thereto. However, to date, its originators still have not received a reply from the Minister of Education.

In the meantime, the association's representatives have also expressed the wish to meet with the Minister of Education, Sébastien Proulx, to raise his awareness of these issues.

- 1) Will the Minister commit to promptly providing a formal reply to Parlons Dysphasie representatives regarding their petition, which I personally delivered to him last year?
- 2) Will the Minister commit to meeting Parlons Dysphasie representatives to get a better understanding of the problems that young people suffering from dysphasia and the persons close to them face?

(310) Mrs. Fournier (Marie-Victorin) – **6 June 2018**

To the Minister of Health and Social Services

On 17 February 2014, the Ombudsman tabled in the Committee on Health and Social Services of Québec a brief on the living conditions of adults staying in residential and long-term care centres. Noting that 11% of users living in public and private long-term residential care centres (CHSLD) under agreement were under 65 years of age, the Ombudsman highlighted the lack of information available regarding this specific clientele as well as the problems regarding accessibility to a living environment that is adapted to their special needs.

Two recommendations were then made:

S-7 Ask the Minister of Health and Social Services to designate an institutional stakeholder or a recognized research group that will be able to establish the clientele profiles of persons under 65 years of age staying in residential and long-term care centres under agreement.

S-8 Ask the Minister of Health and Social Services to promptly take the necessary measures to tailor the living environment approach to the profiles of persons under 65 years of age staying in residential and long-term care centres under agreement as well as the available service provision by means of tools such as the individualized service plan.

Four years later, the conclusion is clear: as no concrete action has been taken to address the recommendations issued in 2014 and the rare residential resources for this seemingly orphan clientele are hardly able to meet demands and ensure their sustainability, questions arise:

- Did the Ministère de la Santé et des services sociaux put measures into place to address recommendations S-7 and S-8 in the Ombudsman's report dated 17 February 2014? If so, what are these measures?
- Did the Ministère provide for recurrent budgets to address the Ombudsman's S-7 and S-8 recommendations? If so, what are these amounts and how are they allocated?
- What is the Ministère's action plan and time frame to specifically address the needs of this particular clientele having to stay in residential and long-term care centres, owing to the lack of residential resources subsidized by the health network?
- According to the latest available data, what number and what percentage of the clientele living in residential and long-term care centres under agreement are under 65 years of age?
- According to the latest available data, what number and what percentage of persons waiting for a place in a residential and long-term care centre under agreement are under 65 years of age?
- What is the Ministère's estimate of the number, per year, of new cases of young adults under 65 years of age who cannot live alone?

(311) Mr. Nadeau-Dubois (Gouin) – **6 June 2018**  
To the Minister of Education, Recreation and Sports

Considering that for several cultural bodies, contracts with the education sector are necessary;

Considering that the latest reinvestment in education does not amount to the numerous cutbacks in recent years and that we can conclude that school boards' and schools' room for manoeuvre has been completely removed in terms of educational initiatives having operating costs;

Considering that with the recent changes made to school taxation, the Liberal Government finished its work of financially draining school boards by even preventing them from taking any initiative to find other sources of income;

Considering that the class action against school boards concerning fees charged to parents results in cultural and scientific bodies' contracts with schools being cancelled for fear of reprisals;

How will school boards and schools be able to continue fostering direct and frequent contact of elementary and high school students with Québec's and the world's artistic events and scientific workshops?

How will the Minister ensure that cultural and scientific bodies will not have to pay for this situation? Has the Minister been in contact with his colleague the Minister of Culture regarding this issue?
