Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mrs. Charlebois, Minister for Rehabilitation, Youth Protection, Public Health and Healthy Living, together with Mr. Turcotte (Saint-Jean), Mr. Paradis (Lévis), Mrs. Massé (Sainte-Marie-Saint-Jacques), Mr. Lelièvre (Gaspé), Mr. Surprenant (Groulx), Mr. Sklavounos (Laurier-Dorion) and Mrs. Ouellet (Vachon), moved:

THAT the National Assembly mark the 30th edition of the "Semaine québécoise de la déficience intellectuelle", held this year under the banner "Apprendre à se connaître", which helps our society move toward an even more inclusive model for persons with an intellectual disability;

THAT it express its solidarity with persons with an intellectual disability and their families, who show determination in overcoming the associated challenges;

THAT, lastly, it highlight the daily commitment of the community as a whole to making our society increasingly inclusive for persons with a disability.

By leave of the Assembly, the motion was carried.

Mrs. Lavallée (Repentigny), together with Mr. Turcotte (Saint-Jean), Mrs. Massé (Sainte-Marie-Saint-Jacques), Mr. Lelièvre (Gaspé) and Mr. Surprenant (Groulx), moved a motion on the fight against child prostitution and the sexual exploitation of youngsters; this motion could not be debated for want of unanimous consent.

Mrs. Massé (Sainte-Marie–Saint-Jacques), together with Mr. Therrien (Sanguinet), Mr. Lelièvre (Gaspé) and Mrs. Ouellet (Vachon), moved a motion on the remuneration of heads of major corporations and private companies that receive public funds; this motion could not be debated for want of unanimous consent.

Notices of Proceedings in Committees

Mr. Tanguay, Deputy Government House Leader, convened the following committees:

- the Committee on Labour and the Economy, to conclude its public hearings within the framework of special consultations on Bill 162, An Act to amend the Building Act and other legislative provisions mainly to give effect to certain Charbonneau Commission recommendations;
- the Committee on Health and Social Services, to continue its clause-byclause consideration of Bill 157, An Act to constitute the Société québécoise du cannabis, to enact the Cannabis Regulation Act and to amend various highway safety-related provisions;
- the Committee on Institutions, to continue its clause-by-clause consideration of Bill 164, An Act respecting access to certain documents held by the Conseil exécutif or intended for the Conseil exécutif;
- the Committee on Transportation and the Environment, to continue its clause-by-clause consideration of Bill 165, An Act to amend the Highway Safety Code and other provisions;

- the Committee on Planning and the Public Domain, to continue its clause-by-clause consideration of Bill 155, An Act to amend various legislative provisions concerning municipal affairs and the Société d'habitation du Québec;
- the Committee on Public Finance, to continue its clause-by-clause consideration of Bill 141, An Act mainly to improve the regulation of the financial sector, the protection of deposits of money and the operation of financial institutions.

Information on the Proceedings of the Assembly

Mr. Ouimet, First Vice-President, informed the Assembly that on Wednesday, 14 March 2018, during Business Standing in the Name of Members in Opposition, a debate would be held on the motion moved by Mr. Paradis (Lévis).

This motion reads as follows:

THAT the National Assembly recognize that, according to data published by the Canadian Institute for Health Information, the average remuneration of Québec's medical specialists has exceeded that of their Canadian counterparts since 2014–2015;

THAT it also acknowledge the Health Minister's remarks of 15 February 2018 to the effect that Québec's medical specialists now earn more than Ontario's;

THAT it recognize that Quebecers will pay medical specialists more than necessary and that it therefore ask the Québec Government not to sign the new agreement with the medical specialists before the next general election in 2018.
