# **ORDERS OF THE DAY**

Mr. Bissonnet, Vice-President, rendered the following decision on the receivability of the motion to divide that was moved on Tuesday, 30 May 2000, by Mr. Paradis, Official Opposition House Leader, during the debate on the passage in principle of Bill 116, An Act to amend the Act respecting the Régie de l'énergie and other legislative provisions:

# RULING FROM THE CHAIR

The motion to divide is not receivable. That which the Official Opposition House Leader identifies as being two distinct principles are but two aspects of the same principle concerning surveillance of price and transportation conditions, of distribution or provision of energy materials as a whole which at the present time come under the authority of the Régie de l'énergie.

Even if the bill had contained two principles, the motion to divide would not meet the receivability requirement according to which each part of the bill must be able to stand alone. Furthermore, bills resulting from such a division would not constitute coherent bills that could exist independently.

#### **Government Bills**

### Passage in Principle

Resuming the debate on the motion by Mr. Brassard, Minister of Natural Resources, –That Bill 116, An Act to amend the Act respecting the Régie de l'énergie and other legislative provisions, do now pass in principle;

At the request of Mr. Bissonnet, Vice-President, Mr. Sirros (Laurier-Dorion) withdrew certain words deemed unparliamentary.

The debate being concluded, the question was put on this motion; a recorded division was thereupon demanded.

At the request of Mr. Brassard, Government House Leader, the division was deferred until Routine Proceedings on the next sitting day.

Mr. Trudel, Minister of Agriculture, Fisheries and Food, moved, –That Bill 120, An Act to amend the Animal Health Protection Act and other legislative provisions and to repeal the Bees Act, do now pass in principle.

And debate arising;

At 12.58 o'clock p.m., Mr. Bissonnet, Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.05 o'clock p.m.

Passage in Principle

And debate continuing on the motion by Mr. Trudel, Minister of Agriculture, Fisheries and Food, –That Bill 120, An Act to amend the Animal Health Protection Act and other legislative provisions and to repeal the Bees Act, do now pass in principle;

The debate being concluded, the motion was carried and Bill 120 was accordingly passed in principle.

On motion by Mr. Boulerice, Deputy Government House Leader, Bill 120 was referred for clause-by-clause consideration to the Committee on Agriculture, Fisheries and Food.

Mr. Trudel, Minister of Agriculture, Fisheries and Food, moved, –That Bill 123, An Act to amend the Agricultural Products, Marine Products and Food Act and other legislative provisions and to repeal the Dairy Products and Dairy Products Substitutes Act, do now pass in principle.

After debate thereon, the motion was carried and Bill 123 was accordingly passed in principle.

On motion by Mr. Boulerice, Deputy Government House Leader, Bill 123 was referred for clause-by-clause consideration to the Committee on Agriculture, Fisheries and Food.

Mr. Landry, Minister of Finance, moved, –That Bill 125, An Act respecting Nasdaq Stock exchange activities in Québec, do now pass in principle.

After debate thereon, the motion was carried and Bill 125 was accordingly passed in principle.

On motion by Mr. Boulerice, Deputy Government House Leader, Bill 125, An Act respecting Nasdaq Stock exchange activities in Québec, was referred for clause-byclause consideration to the Committee on Public Finance.

Mr. Landry, Minister of Finance, moved, –That Bill 126, An Act respecting financial services cooperatives, do now pass in principle.

After debate thereon, the motion was carried and Bill 126 was accordingly passed in principle.

On motion by Mr. Boulerice, Deputy Government House Leader, Bill 126, An Act respecting financial services cooperatives, was referred for clause-by-clause consideration to the Committee on Public Finance.

# Report Stage

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 109, An Act respecting the Office Québec-Amériques pour la jeunesse, together with the amendments handed in by Mrs. Beaudoin, Minister of International Relations.

The amendments were declared in order.

After debate thereon, the amendments were carried.

The motion to renumber the Bill was carried.

The report, as amended, was concurred in.

The Assembly took into consideration the report from the Committee on Social Affairs on its clause-by-clause consideration of Bill 128, An Act to amend the Act respecting the Ministère de la Famille et de l'Enfance.

After debate thereon, the report was concurred in.

The Assembly took into consideration the report from the Committee on Labour and the Economy on its clause-by-clause consideration of Bill 127, An Act to amend the Tourist Establishments Act.

After debate thereon, the report was concurred in.

At 5.52 o'clock p.m., by leave of the Assembly, Mr. Brouillet, Vice-President, suspended the proceedings until 8.00 o'clock p.m.

The proceedings resumed at 8.06 o'clock p.m.

Passage in Principle

Resuming the debate on the motion by Mrs. Goupil, Minister of Justice, –That Bill 115, An Act to amend the Civil Code and other legislative provisions relating to land registration, do now pass in principle;

The debate being concluded, the motion was carried on division and Bill 115 was accordingly passed in principle.

On motion by Mr. Brassard, Government House Leader, Bill 115 was referred for clause-by-clause consideration to the Committee on Institutions.

## Report Stage

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 87, An Act to amend the Professional Code and other legislative provisions.

After debate thereon, the report was concurred in.

Passage in Principle

Mrs. Marois, Minister of Health and Social Services, moved, –That Bill 117, An Act to amend the Act respecting prescription drug insurance and the Act respecting the Régie de l'assurance maladie du Québec, do now pass in principle.

And debate arising;

At 12.00 o'clock a.m., the debate on the motion by the Minister of Health and Social Services was adjourned. Mr. Brouillet, Vice-President, adjourned the Assembly until Friday, 2 June 2000, at 10.00 o'clock a.m.
