Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

By leave of the Assembly to set aside Standing Orders 53 and 59, Mrs. Anglade (Saint-Henri–Sainte-Anne) tabled the following:

A bundle of excerpts from the *Gazette officielle du Québec*, published between 2014 and 2019, on immigration file processing, and an excerpt from an article by Mrs. Véronique Prince, parliamentary correspondent for Radio-Canada, dated 24 January 2019, on the massive challenge that the 18,000 unprocessed immigration files represent for the Legault plan entitled "18 000 dossiers d'immigration non traités : un casse-tête pour le plan Legault".

By leave of the Assembly to set aside Standing Orders 53 and 59, Mr. Polo (Laval-des-Rapides) tabled the following:

Motions Without Notice

Mrs. Lessard-Therrien (Rouyn-Noranda-Témiscamingue), together with Mrs. Montpetit (Maurice-Richard), Mr. Gaudreault (Jonquière) and Mr. Ouellette (Chomedey), moved a motion on the Australian company Sayona Mining's Authier mining project; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Lacombe, Minister of Families, together with Mrs. Labrie (Sherbrooke) and Mr. Ouellette (Chomedey), moved:

THAT the National Assembly support the Government in its desire to continue developing educational childcare services, which include CPE childcare centres, daycare centres and home childcare providers;

THAT the National Assembly recognize the role that early childhood educational services play in giving children an equal opportunity and enabling them to develop their full potential;

THAT, lastly, the National Assembly recognize early childhood educators' essential contribution to our children's development and that it applaed their outstanding work.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Mr. Fortin (Pontiac), together with Mrs. McCann, Minister of Health and Social Services, Mr. Gaudreault (Jonquière), Mr. Zanetti (Jean-Lesage) and Mr. Ouellette (Chomedey), moved:

THAT the National Assembly underscore the fact that shingles is a severe illness that affects approximately one in three people over their lifetime;

THAT it recall that the Comité sur l'immunisation du Québec has recommended setting up a public shingles vaccination program;

THAT it ask the Government to implement the committee's recommendations and set up a program as soon as possible.

By leave of the Assembly, the motion was carried.

Mr. Ouellet (René-Lévesque), together with Mr. Marissal (Rosemont), moved a motion on fighting tax evasion; this motion could not be debated for want of unanimous consent.

Notices of Proceedings in Committees

Mr. Schneeberger, Deputy Government House Leader, convened the following committees:

- the Committee on Health and Social Services, to continue its public hearings within the framework of special consultations on Bill 2, An Act to tighten the regulation of cannabis;
- the Committee on Public Finance, to continue its clause-by-clause consideration of Bill 3, An Act to establish a single school tax rate.

Information on the Proceedings of the Assembly

Mr. Picard, First Vice-President, informed the Assembly that the motion by the Government House Leader placed on the *Order Paper and Notices* of 14 February 2019, under Standing Order 146, had been withdrawn from the Order Paper at his request.

ORDERS OF THE DAY

At 11.14 o'clock a.m., at the request of Mr. Schneeberger, Deputy Government House Leader, and by leave of the Assembly to set aside Standing Order 20, Mr. Picard, First Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.00 o'clock p.m.

Business Standing in the Name of Members in Opposition

Mrs. Rizqy (Saint-Laurent) moved:

THAT the National Assembly ask the Government to allocate the necessary budgetary resources first and foremost to student services and to improving teachers' working conditions;

THAT the National Assembly ask the Government not to halt any expansion or renovation projects already approved in accordance with the *Act respecting contracting by public bodies*.

Mrs. Soucy, Second Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 10 minutes to the mover of the motion for her reply; 54 minutes 15 seconds to the parliamentary group forming the Government; 32 minutes 6 seconds to the parliamentary group forming the Official Opposition; 11 minutes 4 seconds to the Second Opposition Group; 11 minutes 4 seconds to the Third Opposition Group, and 1 minute 30 seconds to the independent Member. Within this framework, any time not used by the independent Member or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

At the end of her address, Mrs. Labrie (Sherbrooke) moved:

THAT the motion moved by the Member for Saint-Laurent be amended as follows:

By replacing the words "and to improving teachers' working conditions" at the end of the first paragraph by the words ", to improving the working conditions of teachers, professionals and support staff and to upgrading infrastructures".

The motion, as amended, would read as follows:

THAT the National Assembly ask the Government to allocate the necessary budgetary resources first and foremost to student services, to improving the working conditions of teachers, professionals and support staff and to upgrading infrastructures;

THAT the National Assembly ask the Government not to halt any expansion or renovation projects already approved in accordance with the *Act respecting contracting by public bodies*.

The debate continued on the main motion moved by Mrs. Rizqy (Saint-Laurent) and on the amendment motion moved by Mrs. Labrie (Sherbrooke), subject to the permission of its author.

Pursuant to Standing Order 98.1, Mrs. Rizqy (Saint-Laurent) accepted the amendment proposed by Mrs. Labrie (Sherbrooke).

The debate being concluded, the question was put on the amendment motion, and a recorded division was thereupon demanded.

At the request of Mr. Schneeberger, Deputy Government House Leader, the divisions on the amendment motion moved by Mrs. Labrie (Sherbrooke) and on the motion moved by Mrs. Rizqy (Saint-Laurent) were deferred until Routine Proceedings on the next sitting day.

Mr. Schneeberger, Deputy Government House Leader, moved the adjournment of the Assembly until Thursday, 21 February 2019 at 9.40 o'clock a.m.

The motion was carried.

Accordingly, at 4.56 o'clock p.m., Mrs. Gaudreault, Third Vice-President, adjourned the Assembly until Thursday, 21 February 2019 at 9.40 o'clock a.m.
