THAT the National Assembly mark the 50th anniversary of Mirabel residents' expropriation;

THAT it demand that the Government of Canada formally and officially apologize to the Québec citizens who were expropriated by the Federal Government in 1969 for the construction of the Mirabel airport.

The question was put on this motion, and a recorded division was thereupon demanded.

Government Bills

Passage in Principle

Mr. Roberge, Minister of Education and Higher Education, moved that Bill 12, An Act to clarify the scope of the right to free education and to allow the regulation of certain financial contributions that may be required, do now pass in principle.

A debate arose thereon.

At 1.01 o'clock p.m., Mrs. Soucy, Second Vice-President, suspended the proceedings until 3.00 o'clock p.m.

Accordingly, pursuant to Standing Order 97, the debate on the motion moved by Mr. Roberge, Minister of Education and Higher Education, was adjourned in the name of Mrs. Labrie (Sherbrooke).

The proceedings resumed at 3.00 o'clock p.m.

Business Standing in the Name of Members in Opposition

Mrs. Massé, Leader of the Second Opposition Group, moved:

THAT the National Assembly ask the CAQ Government to propose, by 1 October 2020, a greenhouse gas emissions reduction plan approved by an independent non-government expert that makes it possible to achieve the targets recommended by the Intergovernmental Panel on Climate Change (IPCC) for 2030;

THAT the National Assembly also ask the Government to prohibit all oil and gas development and exploration projects on Québec territory.

Mrs. Gaudreault, Third Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 10 minutes to the mover of the motion for her reply; 48 minutes 30 seconds to the parliamentary group forming the Government; 28 minutes 30 seconds to the parliamentary group forming the Official Opposition; 21 minutes 9 seconds to the Second Opposition Group; 8 minutes 51 seconds to the Third Opposition Group; and 1 minute 30 seconds to each independent Member. However, if only one independent Member takes part in the debate, that Member's speaking time is 2 minutes. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

At the end of his address, Mr. Gaudreault (Jonquière) moved:

THAT the motion moved by the Leader of the Second Opposition Group be amended as follows:

By replacing, in the first paragraph, the words "achieve the targets recommended by the Intergovernmental Panel on Climate Change (IPCC)" by the words "meet Québec's international commitments":

By adding, after the first paragraph, the words "THAT the National Assembly ask the Government to call Bill 194, An Act to ensure compliance with Québec's climate change-related obligations, before a parliamentary committee in order to hold special consultations;".

The motion, as amended, would read as follows:

THAT the National Assembly ask the CAQ Government to propose, by 1 October 2020, a greenhouse gas emissions reduction plan approved by an independent non-government expert that makes it possible to meet Québec's international commitments for 2030;

THAT the National Assembly ask the Government to call Bill 194, An Act to ensure compliance with Québec's climate change-related obligations, before a parliamentary committee in order to hold special consultations;

THAT the National Assembly also ask the Government to prohibit all oil and gas development and exploration projects on Québec territory.

The debate continued on the main motion moved by Mrs. Massé, Leader of the Second Opposition Group, and on the amendment motion moved by Mr. Gaudreault (Jonquière), subject to the permission of its author.

At the end of his address, Mr. Nadeau-Dubois (Gouin) moved:

THAT the motion moved by the Leader of the Second Opposition Group be amended as follows:

By adding, after the first paragraph, the words "THAT the National Assembly ask the Government to call Bill 194, An Act to ensure compliance with Québec's climate change-related obligations, before a parliamentary committee in order to hold special consultations;".

The motion, as amended, would read as follows:

THAT the National Assembly ask the CAQ Government to propose, by 1 October 2020, a greenhouse gas emissions reduction plan approved by an independent non-government expert that makes it possible to achieve the targets recommended by the Intergovernmental Panel on Climate Change (IPCC) for 2030;

THAT the National Assembly ask the Government to call Bill 194, An Act to ensure compliance with Québec's climate change-related obligations, before a parliamentary committee in order to hold special consultations;

THAT the National Assembly also ask the Government to prohibit all oil and gas development and exploration projects on Québec territory.

Pursuant to Standing Order 98.1, Mrs. Massé, Leader of the Second Opposition Group, refused the amendments proposed by Mr. Gaudreault (Jonquière) and accepted the amendment proposed by Mr. Nadeau-Dubois (Gouin).
