27 An Act respecting mainly government organization as regards the economy and innovation

An Act to simplify the process for establishing electricity distribution rates

An Act to amend the Civil Code to provide that an action for damages for bodily injury resulting from a sexual aggression, from childhood violence or from the violent behaviour of a spouse or former spouse cannot be prescribed during the lifetime of the author of the act

Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mr. Fortin (Pontiac), together with Mrs. McCann, Minister of Health and Social Services, Mr. Zanetti (Jean-Lesage), Mrs. Hivon (Joliette), Mr. Ouellette (Chomedey) and Mrs. Fournier (Marie-Victorin), moved:

THAT the National Assembly recall that the debate surrounding medical assistance in dying is a delicate societal debate, which must be approached in a non-partisan way;

THAT it recall the CAQ Government's commitment in September 2018 to hold public consultations in the National Assembly to examine the possibility of expanding medical assistance in dying to people with Alzheimer's disease and related disorders;

THAT, consequently, it ask the Minister of Health and Social Services to make the report by a panel of experts on access to medical assistance in dying for incapacitated persons public as soon as possible and that it ask the Government to confirm its intention to hold consultations in committee before introducing a bill.

The question was put on this motion, and a recorded division was thereupon demanded.

By leave of the Assembly to set aside Standing Order 185, Mr. Zanetti (Jean-Lesage), together with Mr. Carmant, Minister for Health and Social Services, Mrs. David (Marguerite-Bourgeoys), Mrs. Richard (Duplessis) and Mrs. Fournier (Marie-Victorin), moved:

THAT the National Assembly note the heartfelt cry launched by DYP workers who deplore the glaring lack of resources to protect Québec's children;

THAT it recall the remarks made by the Premier on 30 May 2019, when referring to the Minister for Health and Social Services, to the effect that he had asked the Minister to immediately begin making the changes that can already be made;

THAT the National Assembly ask the Minister for Health and Social Services to commit to providing additional resources to the DYP network, as soon as possible, to hire additional social workers, improve their conditions of employment and reduce waiting lists.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

Mrs. Perry Mélançon (Gaspé), together with Mrs. Labrie (Sherbrooke) and Mrs. Fournier (Marie-Victorin), moved a motion on the national sports teams of Québec; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Boulet, Minister of Labour, Employment and Social Solidarity, together with Mrs. Robitaille (Bourassa-Sauvé), Mr. Leduc (Hochelaga-Maisonneuve), Mr. Ouellet (René-Lévesque), Mr. Ouellette (Chomedey) and Mrs. Fournier (Marie-Victorin), moved:

THAT the National Assembly mark World Day Against Child Labour by reaffirming the right of children to be protected from economic exploitation and from any work that may endanger them;

THAT it denounce the fact that, according to the United Nations, close to 152 million children worldwide are forced to work:

THAT it affirm its commitment to offering all our children a healthy environment in which they have access to quality education and are able to thrive.

By leave of the Assembly, the motion was carried.

Mrs. Fournier (Marie-Victorin), together with Mrs. Rizqy (Saint-Laurent) and Mr. Marissal (Rosemont), moved a motion on GST on online products; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 84.1 and pursuant to Standing Order 146, Mr. Schneeberger, Deputy Government House Leader, moved:

THAT, within the framework of the consideration of Bill 15, An Act respecting the Société de développement et de mise en valeur du Parc olympique, the Committee on Labour and the Economy hold special consultations and public hearings on Tuesday, 27 August 2019 from 9.30 o'clock a.m. to 12.00 o'clock noon and from 2.00 o'clock p.m. to 5.45 o'clock p.m.; and on Wednesday, 28 August 2019 from 9.30 o'clock a.m. to 12.30 o'clock p.m. and from 2.00 o'clock p.m. to 5.45 o'clock p.m.;

THAT, for this purpose, the Committee hear the following organizations:

Ville de Montréal Space for Life Mercier-Hochelaga-Maisonneuve Chamber of Commerce of Metropolitan Montreal Tourisme Montréal **Desigrations** Group Alliance de l'industrie touristique Les Jardineries / La Pépinière Héritage Montréal Stade Saputo Institut national du sport du Québec Régie des installations olympiques Regroupement Loisir et Sport du Québec Montreal Alouettes Société des transports de Montréal Centre Pierre-Charbonneau Major International Events Network;

THAT a period of 12 minutes be set aside for opening statements, allocated as follows: 6 minutes to the parliamentary group forming the Government, 4 minutes to the parliamentary group forming the Official Opposition, 1 minute to the Second Opposition Group and 1 minute to the Third Opposition Group;

THAT the presentation by each organization last no longer than 10 minutes and the exchange with the Committee members last no longer than 35 minutes, allocated as follows: 17 minutes 30 seconds to the parliamentary group forming the Government, 11 minutes 40 seconds to the Official Opposition, 2 minutes 55 seconds to the Second Opposition Group and 2 minutes 55 seconds to the Third Opposition Group;

THAT the Minister of Tourism be a member of the said Committee during its proceedings with respect to this order of reference.

ORDERS OF THE DAY

Debates on Reports from Committees

A debate arose thereon.

The Assembly took into consideration the report from the Committee on Public Administration, which met on 14 and 28 February and 5 June 2019 to hear Deputy Ministers and heads of public bodies on the Auditor General of Québec's administrative management and financial commitments, Chapter 3 of the Auditor General of Québec's June 2018 report entitled "Contaminated Sites Under the Responsibility of the State", and Chapter 3 of the Auditor General of Québec's November 2018 report entitled "End-of-Life Tire Management". The report contains observations, conclusions and seven recommendations.

Mr. Picard, First Vice-President, informed the Assembly of the allocation of speaking time for this debate: 58 minutes 30 seconds to the parliamentary group forming the Government; 35 minutes 21 seconds to the parliamentary group forming the Official Opposition; 12 minutes 11 seconds to the Second Opposition Group; 10 minutes 58 seconds to the Third Opposition Group; and 1 minute 30 seconds to each independent Member. However, if only one independent Member takes part in the debate, that Member's speaking time is 2 minutes. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.
