Motions Without Notice

After consultation with the Opposition parties and the independent Members, Mr. Legault, Premier, moved the following:

THAT, pursuant to section 26 of the *Act respecting the National Assembly*, Mr. Siegfried Peters, Director of Legal and Legislative Affairs and Parliamentary Procedure, be appointed Secretary General of the National Assembly to replace Mr. François Arsenault, Acting Secretary General.

The question was put on this motion, and a recorded division was thereupon demanded.

The motion was carried on the following vote:

By leave of the Assembly to set aside Standing Order 185, Mr. Boulet, Minister of Labour, Employment and Social Solidarity, together with Mrs. Sauvé (Fabre), Mr. Leduc (Hochelaga-Maisonneuve), Mr. LeBel (Rimouski), Mr. Ouellette (Chomedey) and Mrs. Fournier (Marie-Victorin), moved:

> THAT the National Assembly underline the Semaine nationale de l'action communautaire autonome by recognizing the contribution of thousands of independent community organizations both to Québec's socioeconomic development and to the fight against poverty and social exclusion;

> THAT it recognize the worth of the dedication of the workers and volunteers who moilize every day to improve Quebecers' quality of life by offering services adapted to their needs and reflecting their realities;

> THAT it continue its commitment to supporting the organizations and their mission to maintain a strong, adaptable and inclusive social safety net into the future.

By leave of the Assembly, the motion was carried.

Mr. Fortin (Pontiac), together with Mr. Zanetti (Jean-Lesage), Mr. Gaudreault (Jonquière), Mr. Ouellette (Chomedey) and Mrs. Fournier (Marie-Victorin), moved a motion on the closure of the Hôpital du Sacré-Coeur's Organ Retrieval Centre; this motion could not be debated for want of unanimous consent.

Mrs. Massé, Leader of the Second Opposition Group, together with Mrs. Girault, Minister of International Relations and La Francophonie, Mr. Bérubé, Leader of the Third Opposition Group, Mr. Ouellette (Chomedey) and Mrs. Fournier (Marie-Victorin), moved a motion on the political situation in Catalonia; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Gaudreault (Jonquière), together with Mr. Fortin (Pontiac), Mr. Zanetti (Jean-Lesage), Mr. Ouellette (Chomedey) and Mrs. Fournier (Marie-Victorin), moved:

THAT the Assembly urge the Government to broaden the scope, as soon as possible, of the Régie de l'assurance maladie du Québec's public coverage to include continuous positive airway pressure machines, required by people suffering from sleep apnea, after the conclusion of the work of the working committee recently formed by the Government and made up of the Ministère de la Santé et des Services sociaux, physicians, managers and the Association des pneumologues du Ouébec.

By leave of the Assembly, the motion was carried.

Information on the Proceedings of the Assembly

Mrs. Soucy, Second Vice-President, informed the Assembly that on Wednesday, 23 October 2019, during Business Standing in the Name of Members in Opposition, a debate would be held on the motion moved by Mrs. Montpetit (Maurice-Richard).

This motion reads as follows:

THAT the National Assembly solemnly reiterate that Anticosti Island is a natural jewel which is home to a geological and paleontological heritage with exceptional universal value that is recognized worldwide;

THAT it recall that, in the past, all oil and gas exploration rights were bought back by the State to preserve the island's singular beauty and heritage;

THAT it recall that, following a request made by the Québec Government in 2017, the Federal Government put Anticosti Island on Canada's Tentative List for World Heritage Sites and that this is the preliminary step for official nomination for inscription on UNESCO's World Heritage List;

THAT it recognize that the Ministère de la Forêt, de la Faune et des Parcs has, on many occasions, submitted recommendations opposing the creation of a buffer strip to protect the island's banks;

THAT, lastly, the National Assembly ask the CAQ Government to establish a buffer strip to protect the island's banks without delay and to formally commit to protecting Anticosti Island, preserving its exceptional natural features and supporting its nomination for inscription on the UNESCO World Heritage List by taking the necessary measures.
