Motions Without Notice

Mr. Leitão (Robert-Baldwin), together with Mr. Ouellette (Chomedey), moved a motion on the independence of the Caisse de dépôt et placement du Québec; this motion could not be debated for want of unanimous consent.

Mrs. Ghazal (Mercier), together with Mrs. Montpetit (Maurice-Richard), Mr. Gaudreault (Jonquière), Mr. Ouellette (Chomedey) and Mrs. Fournier (Marie-Victorin), moved a motion on municipalities' decisions regarding the distribution of circulars; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mrs. Perry Mélançon (Gaspé), together with Mrs. Melançon (Verdun), Mr. Marissal (Rosemont), Mr. Ouellette (Chomedey) and Mrs. Fournier (Marie-Victorin), moved:

THAT the National Assembly ask the Government to take the necessary steps to require Netflix and other foreign digital platforms to have original productions filmed in Canada dubbed in Québec;

THAT it ask the Government to take the necessary steps to require Netflix and other foreign digital platforms to use the Québec-dubbed French version when available for all content streamed in Québec. The question was put on this motion, and a recorded division was thereupon demanded.

THAT it highlight the structuring contribution by the heads of our educational institutions to school organization, staff support and student perseverance and success;

THAT it recognize the rigour, commitment and competence of these leaders, who are so essential to our schools;

THAT, lastly, it recognize the dedication and commitment they provide daily with respect to students, parents and the community to ensure each child reaches his or her full potential.

The debate being concluded, the motion was carried.

ORDERS OF THE DAY

Government Bills

Passage in Principle

The Assembly resumed the debate, which had been adjourned on 22 October 2019, on the motion moved by Mr. Fitzgibbon, Minister of Economy and Innovation, that Bill 27, An Act respecting mainly government organization as regards the economy and innovation, do now pass in principle.

The debate being concluded, the motion was carried and, accordingly, Bill 27 was passed in principle.

Mr. Caire, Deputy Government House Leader, moved that Bill 27 be referred to the Committee on Labour and the Economy for clause-by-clause consideration.

The motion was carried.

Report Stage

The Assembly took into consideration the report from the Committee on Culture and Education on its clause-by-clause consideration of Bill 5, An Act to amend the Education Act and other provisions regarding preschool education services for students 4 years of age, together with the amendments transmitted by Mr. Roberge, Minister of Education and Higher Education, and Mrs. Rizqy (Saint-Laurent).

The amendments were declared in order.

A debate arose thereon.

At 1.00 o'clock p.m., Mr. Picard, First Vice-President, suspended the proceedings until 3.00 o'clock p.m.

Accordingly, pursuant to Standing Order 97, the debate on the motion moved by Mr. Roberge, Minister of Education and Higher Education, was adjourned in the name of Mrs. Hivon (Joliette).

The proceedings resumed at 3.00 o'clock p.m.

Business Standing in the Name of Members in Opposition

Mrs. Montpetit (Maurice-Richard) moved:

THAT the National Assembly solemnly reiterate that Anticosti Island is a natural jewel which is home to a geological and paleontological heritage with exceptional universal value that is recognized worldwide;

THAT it recall that, in the past, all oil and gas exploration rights were bought back by the State to preserve the Island's singular beauty and heritage;

THAT it recall that, following a request made by the Québec Government in 2017, the Federal Government put Anticosti Island on Canada's Tentative List for World Heritage Sites and that this is the preliminary step for official nomination for inscription on UNESCO's World Heritage List;

THAT it recognize that the Ministère de la Forêt, de la Faune et des Parcs has, on many occasions, submitted recommendations opposing the creation of a buffer strip to protect the island's banks; THAT, lastly, the National Assembly ask the CAQ Government to establish a buffer strip to protect the island's banks without delay and to formally commit to protecting Anticosti Island, preserving its exceptional natural features and supporting its nomination for inscription on the UNESCO World Heritage List by taking the necessary measures.

Mr. Picard, First Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 10 minutes to the mover of the motion for her reply; 53 minutes 30 seconds to the parliamentary group forming the Government; 31 minutes 52 seconds to the parliamentary group forming the Official Opposition; 11 minutes 23 seconds to the Second Opposition Group; 10 minutes 15 seconds to the Third Opposition Group; and 1 minute 30 seconds to each independent Member. However, if only one independent Member takes part in the debate, that Member's speaking time is 2 minutes. Within this framework, any time not used by independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

At the end of his address, Mr. Charette, Minister of the Environment and the Fight Against Climate Change, moved:

THAT the motion by the Member for Maurice-Richard be amended as follows:

By replacing "has, on many occasions, submitted recommendations opposing the creation of a buffer strip to protect the island's banks" by "has sent its approval for the Island's inscription as a UNESCO World Heritage Site to the Ministère de l'Environnement et de la Lutte contre les changements climatiques, and that it take steps to that effect". The motion, as amended, would read as follows:

THAT the National Assembly solemnly reiterate that Anticosti Island is a natural jewel which is home to a geological and paleontological heritage with exceptional universal value that is recognized worldwide;

THAT it recall that, in the past, all oil and gas exploration rights were bought back by the State to preserve the Island's singular beauty and heritage;

THAT it recall that, following a request made by the Québec Government in 2017, the Federal Government put Anticosti Island on Canada's Tentative List for World Heritage Sites and that this is the preliminary step for official nomination for inscription on UNESCO's World Heritage List;

THAT it recognize that the Ministère de la Forêt, de la Faune et des Parcs has sent its approval for the Island's inscription as a UNESCO World Heritage Site to the Ministère de l'Environnement et de la Lutte contre les changements climatiques, and that it take steps to that effect;

At the end of his address, Mr. Gaudreault (Jonquière) moved:

THAT the motion by the Member for Maurice-Richard be amended as follows:

In the first paragraph, by adding the word "historical" after the words "which is home to a";

In the last paragraph, by replacing the words "its exceptional natural features" by the words "its exceptional natural and historical features".

The motion, as amended, would read as follows:

THAT the National Assembly solemnly reiterate that Anticosti Island is a natural jewel which is home to a historical, geological and paleontological heritage with exceptional universal value that is recognized worldwide;

THAT it recall that, in the past, all oil and gas exploration rights were bought back by the State to preserve the Island's singular beauty and heritage;

THAT it recall that, following a request made by the Québec Government in 2017, the Federal Government put Anticosti Island on Canada's Tentative List for World Heritage Sites and that this is the preliminary step for official nomination for inscription on UNESCO's World Heritage List;

THAT it recognize that the Ministère de la Forêt, de la Faune et des Parcs has, on many occasions, submitted recommendations opposing the creation of a buffer strip to protect the island's banks;

THAT, lastly, the National Assembly ask the CAQ Government to establish a buffer strip to protect the island's banks without delay and to formally commit to protecting Anticosti Island, preserving its exceptional natural and historical features and supporting its nomination for inscription on the UNESCO World Heritage List by taking the necessary measures.

Pursuant to Standing Order 98.1, Mrs. Montpetit (Maurice-Richard) refused the amendment proposed by Mr. Charette, Minister of the Environment and the Fight Against Climate Change, and accepted the amendment proposed by Mr. Gaudreault (Jonquière).

The debate being concluded, the question was put on the amendment motion, and a recorded division was thereupon demanded.

At the request of Mr. Schneeberger, Deputy Government House Leader, the divisions on the amendment motion moved by Mr. Gaudreault (Jonquière) and on the motion moved by Mrs. Montpetit (Maurice-Richard) were deferred until Routine Proceedings on the next sitting day.
