Complaints of Breach of Privilege or Contempt and Personal Explanations

The President informed the Assembly that he had, within the prescribed time, received a request from Mr. Tanguay, Official Opposition House Leader, to be heard on an alleged breach of privilege.

In his notice, the Official Opposition House Leader alleged that the rules of the National Assembly had been violated with respect to communications sent by the Government to third parties regarding the bill to strengthen the complaint examination process of the health and social services network, in particular for users receiving services from private institutions.

The notice further stated the Official Opposition House Leader's intention to move a motion under Standing Orders 315 and following.

The President took the matter under advisement.

Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

Private Members' Public Bills

Passage in Principle

Mr. Picard (Chutes-de-la-Chaudière) moved that Bill 390, An Act to replace the Act respecting the Amicale des anciens parlementaires du Québec, do now pass in principle.

The proceedings resumed at 4.51 o'clock p.m.
Committee of the Whole Bill 390 was considered in Committee of the Whole, then amended an thereupon reported.
The report was concurred in.

Passage

By leave of the Assembly to set aside Standing Order 230, Mr. Picard (Chutes-de-la-Chaudière) moved the passage of Bill 390, An Act to replace the Act respecting the Amicale des anciens parlementaires du Québec.

A debate arose thereon.

The debate being concluded, the motion was carried and, accordingly, Bill 390 was passed.

Debates on Reports from Committees

The Assembly resumed the debate, which had been adjourned on 29 November 2019, on consideration of the report from the Committee on Public Administration, which met on 9 and 30 October and on 14 November 2019, to hear deputy ministers and heads of public bodies on Chapter 5 entitled "Computer Recovery" and Chapter 7 entitled "Information Technology Contracts – Follow-Up on a Special Audit" of the Auditor General of Québec's May 2018 report; on the administrative management and financial commitments of the Ministère de la Santé et des Services sociaux; and on the administrative management and financial commitments of the Ministère de l'Éducation et de l'Enseignement supérieur. The report contains observations, conclusions and nine recommendations.

At 6.00 o'clock p.m., Mrs. Gaudreault, Third Vice-President, suspended the proceedings until 7.30 o'clock p.m.

The proceedings resumed at 7.31 o'clock p.m.

The Assembly continued the debate on consideration of the report from the Committee on Public Administration.

The debate expired and, pursuant to Standing Order 95, no question was put.

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Planning and the Public Domain on its clause-by-clause consideration of Bill 16, An Act mainly to regulate building inspections and divided co-ownership, to replace the name and improve the rules of operation of the Régie du logement and to amend the Act respecting the Société d'habitation du Québec and various legislative provisions concerning municipal affairs, together with the amendments transmitted by Mrs. Thériault (Anjou–Louis-Riel) and Mr. Fontecilla (Laurier-Dorion).

The amendments proposed by Mrs. Thériault (Anjou-Louis-Riel) were declared in order.

The amendments proposed by Mr. Fontecilla (Laurier-Dorion) were declared out of order, as the Standing Orders provide that, in order to be deemed in order, amendments must be relevant to the subject matter of a bill and consistent with its spirit and must not be contrary to its principle or introduce new ones. The first of the amendments proposed by the Member for Laurier-Dorion modifies the responsibilities of the Régie du logement by adding a rent registry. The second provides for the Minister to impose a moratorium on evictions in sectors where the rate of available housing is 3% or less. Although generally related to the housing sector, the proposed amendments introduce elements other than the measures contained in the bill.

A debate arose thereon.

The debate was adjourned in the name of Mr. Fontecilla (Laurier-Dorion).
