THAT it ask the Government to amend the *Charter of the French language* in order to strengthen it and ensure its application throughout Québec, so as to better protect our official language;

THAT, lastly, it ask Ville de Montréal to adopt a similar resolution.

THAT, in this regard, it ask the Government to take concrete and immediate action to stop this trend;

THAT it ask the Government to amend the *Charter of the French language* in order to strengthen it and ensure its application throughout Québec, so as to better protect our official language;
