By leave of the Assembly to set aside Standing Order 185, Mr. Lafrenière, Minister Responsible for Indigenous Affairs, together with Mr. Kelley (Jacques-Cartier), Ms. Massé, Leader of the Second Opposition Group, Mr. Ouellet (René-Lévesque), Mr. Ouellette (Chomedey) and Ms. Fournier (Marie-Victorin), moved:

THAT the National Assembly underline the contribution of Indigenous veterans on the occasion of their day, which is 8 November:

THAT it also highlight the courage of the nearly 12,000 First Nations, Métis and Inuit men and women who served during the great conflicts of the 20th century;

THAT it pay tribute to the Indigenous veterans who have served the cause of freedom, justice and respect for human rights;

THAT it recall that this day of commemoration has been observed throughout Canada since 1994;

THAT it emphasize the fact that the Indigenous and Inuit peoples have had to overcome more challenges than others to wear a uniform because they have had to learn a new language, adapt to cultural differences and move away from their communities;

THAT it take this opportunity to acknowledge and thank the Indigenous peoples who protected our freedom and rights during the wars and for their contribution to Canada's military efforts;

THAT, lastly, it observe a minute of silence to honour those who lost their lives.

Government Bills

Passage in Principle

The Assembly resumed the debate, which had been adjourned on 3 November 2020, on the motion moved by Ms. Laforest, Minister of Municipal Affairs and Housing, that Bill 67, An Act to establish a new development regime for the flood zones of lakes and watercourses, to temporarily grant municipalities powers enabling them to respond to certain needs and to amend various provisions, do now pass in principle.

At 1:00 p.m., Ms. Soucy, Second Vice-President, suspended the proceedings until 3:00 p.m.

Accordingly, pursuant to Standing Order 97, the debate on the motion moved by Ms. Laforest, Minister of Municipal Affairs and Housing, was adjourned in the name of Ms. Charbonneau (Mille-Îles).

The proceedings resumed at 3:00 p.m.

Business Standing in the Name of Members in Opposition

Ms. Anglade, Leader of the Official Opposition, moved:

THAT the National Assembly acknowledge that the pandemic and its many impacts have significantly increased the level of distress among Quebecers, whether they be seniors deprived of contact with their loved ones, young people deprived of places to socialize, families and entrepreneurs affected by an unexpected source of economic insecurity, health workers or women who bear an increased mental load as a result of all the upheaval;

THAT it recognize that despite the recent announcements, mental health resources are struggling to meet all the needs within reasonable time frames, be they for access to adult and child psychiatrists or psychologists who can treat anxiety, distress and serious mental illness;

THAT it affirm the need to hold a societal debate on the issue of access to mental health care and to initiate this debate soon in the National Assembly, in collaboration with subject matter experts;

THAT the Assembly ask the four parliamentary group House leaders to meet in a timely manner to set up a non-partisan special parliamentary committee to hear from experts on mental health issues, in particular in the context of the pandemic, and to make recommendations to support the Government's short- and mid-term actions to carefully determine the scope of the problem, evaluate best practices from around the world, raise public awareness of the magnitude of the problem and engage civil society so that everyone does their part to help people around them who are vulnerable;

THAT the independent Members be able to take part in the committee's proceedings;

THAT the special parliamentary committee report to the National Assembly not later than 18 February 2021, unless the committee decides otherwise;

THAT, lastly, the Assembly call on the Government to continue its efforts by allocating all the necessary resources so that people who require psychotherapy to recover can receive it without financial hurdles and within similar time frames in both private practice and the public sector.

Ms. Gaudreault, Third Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 10 minutes to the mover of the motion for his reply; 53 minutes 30 seconds to the parliamentary group forming the Government; 31 minutes 52 seconds to the parliamentary group forming the Official Opposition; 11 minutes 23 seconds to the Second Opposition Group; 10 minutes 15 seconds to the Third Opposition Group; and 1 minute 30 seconds to each independent Member. However, if only one independent Member takes part in the debate, that Member's speaking time is 2 minutes. Within this framework, any time not used by an independent Member or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

The debate being concluded, the question was put on the motion; in accordance with the motion carried by the Assembly on 20 October 2020, a vote was held in accordance with the procedure for recorded divisions.

The motion was negatived on the following vote:
