By leave of the Assembly to set aside Standing Order 185, Mr. Jolin-Barrette, Minister of Justice, together with Mr. Leduc (Hochelaga-Maisonneuve), Ms. Hivon (Joliette), Mr. Ouellette (Chomedey) and Ms. Fournier (Marie-Victorin), moved:

THAT, on the occasion of Victims and Survivors of Crime Week, the National Assembly express its unwavering support for all victims and survivors of crime;

## Passage in Principle

The Assembly resumed the debate, which had been adjourned on 26 November 2020, on the motion moved by Ms. Guilbault, Minister of Public Security, that Bill 72, An Act to amend various legislative provisions concerning mainly bodies in the field of public safety, do now pass in principle.

A debate arose thereon.

At the end of his address, Mr. Birnbaum (D'Arcy-McGee) moved the following motion to divide the said Bill:

THAT, pursuant to Standing Order 241, Bill 72, An Act to amend various legislative provisions concerning mainly bodies in the field of public safety, be divided into two bills:

The first of which shall be entitled "An Act to amend various legislative provisions concerning the Commission québécoise des libérations conditionnelles and the manner for appointing investigators of specialized police forces", and shall comprise sections 1 to 50 and 66, except the words "except sections 52 and 53, which come into force on the date of coming into force of section 27 of the Act respecting liquor permits (chapter P-9.1), enacted by section 2 of the Act to modernize the legal regime applicable to liquor permits and to amend various other legislative provisions with regard to alcoholic beverages (2018, chapter 20)";

The second of which shall be entitled "An Act to amend various legislative provisions concerning liquor permits and alcoholic beverages", and shall comprise sections 51 to 65 and 66.

Ms. Gaudreault, Third Vice-President, ruled on the receivability of the motion to divide moved by Mr. Birnbaum (D'Arcy-McGee).

## **RULING FROM THE CHAIR**

Parliamentary jurisprudence has established that, for a motion to divide to be declared receivable, two conditions must be met. First, a bill must contain more than one principle. Second, each bill resulting from the division must be coherent, complete and able to stand alone.

The Chair has also mentioned on numerous occasions that the principle is an essential element of a bill, whereas the terms are ancillary elements. It is important that the bill's principle or principles not be confused with the area to which it applies.

There is also an important distinction between a principle and an area of state responsibility that is under a minister's authority. The fact that the bill concerns that particular area of activity does not necessarily imply that this bill contains only one principle.

The government also sometimes introduces a bill called an omnibus bill, which aims to incorporate various amendments relating to the same area. The government's intention may then be to efficiently respond to various amendment requests. However, the Standing Orders make no provision that a motion to divide is out of order because the bill's author calls it an omnibus bill. In fact, the bill's author's intention is not in itself a receivability criterion that the Chair must take into account. The Chair must instead abide by the Standing Orders and parliamentary jurisprudence and base its analysis primarily on the provisions of the bill.

After reading and analyzing the bill, the Chair notes that the provisions contained in each chapter of the bill deal with different subjects, respectively investigators of specialized police forces, the Commission québécoise des libérations conditionnelles and liquor permits. Jurisprudence has established that this type of structure is a clear indication that the bill contains multiple principles.

Lastly, the bills proposed by the motion are separate, coherent and can be considered independently.

Given the aforementioned, the Chair declares that the motion to divide is receivable.

Ms. Gaudreault, Third Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to the limited debate on this motion to divide: 58 minutes 30 seconds to the parliamentary group forming the Government; 34 minutes 51 seconds to the parliamentary group forming the Official Opposition; 12 minutes 27 seconds to the Second Opposition Group; 11 minutes 12 seconds to the Third Opposition Group; and 1 minute 30 seconds to each independent Member. However, if only one independent Member takes part in the debate, that Member's speaking time is 2 minutes. Within this framework, any time not used by an independent Member or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

The Assembly entered upon the debate on the motion to divide moved by Mr. Birnbaum (D'Arcy-McGee).
