The Assembly was called to order at 10:00 a.m.

#### ORDERS OF THE DAY

Moment of reflection

By leave of the Assembly, Mr. Jolin-Barrette, Government House Leader, moved:

#### **Common Provisions**

THAT the following terms and conditions be applicable exclusively to all the regular sittings of the Assembly and the meetings of parliamentary committees that are to be held between 2 February 2021 and 19 February 2021;

THAT the wearing of procedure masks be mandatory at all times during Assembly sittings and parliamentary committee meetings other than virtual sittings and meetings, except when taking the floor to speak during proceedings;

#### Sittings of the Assembly

General Provisions

THAT the Assembly sit with a reduced number of Members in order to comply with physical distancing measures in line with public health recommendations, according to the following distribution:

- No more than 20 Members from the parliamentary group forming the Government;
- No more than 8 Members from the parliamentary group forming the Official Opposition;
- No more than 3 Members from the Second Opposition Group;
- No more than 3 Members from the Third Opposition Group;
- No more than 2 independent Members;

THAT, for the purposes of the period of Routine Proceedings, the distribution be modified to increase the number of Members from the Official Opposition from 8 to 10, and the number of Members from the Second Opposition Group and the Third Opposition Group from 3 to 4, and to reduce the number of Government Members by as many as those added to the other groups;

THAT, during any given period of Routine Proceedings, a Member from the Second Opposition Group be entitled to fill in for a first absent independent Member;

THAT, if a third independent Member wishes to take part in the period of Routine Proceedings, the Government may yield one of its seats;

THAT the independent Members indicate to the House Secretariat and the House Leaders of the parliamentary groups, not later than Monday, 6:00 p.m., which periods of Routine Proceedings they wish to take part in that week;

THAT not later than 6:00 p.m. on the evening preceding a sitting, the Government House Leader communicate to the opposition groups a preliminary list of the ministers who will be present during Oral Questions and Answers the following day;

THAT ministers be entitled to participate in the Oral Questions and Answers period in two groups, one being present during Tuesday and Thursday sittings and the other during Wednesday sittings;

THAT every Member be entitled to take the floor and to vote from a seat that is not the one assigned to him or her;

Hours of Sittings

#### THAT the Assembly meet on:

- (1) Tuesdays from 10:00 a.m. to 6:30 p.m., the proceedings being suspended from 12:00 p.m. to 1:40 p.m.;
- (2) Wednesdays from 9:40 a.m. to 6:00 p.m., the proceedings being suspended from 1:00 p.m. to 2:30 p.m.;
- (3) Thursdays from 9:40 a.m. to 4:30 p.m., the proceedings being suspended from 1:00 p.m. to 2:30 p.m.;

#### THAT the Assembly hold Routine Proceedings on:

- (1) Tuesdays beginning at 1:40 p.m.;
- (2) Wednesdays and Thursdays beginning at 9:40 a.m.:

THAT to ensure a quorum for the purpose of beginning the Tuesday morning sitting, the parliamentary groups undertake to have 7 Members from the parliamentary group forming the Government, 3 Members from the parliamentary group forming the Official Opposition, 1 Member from the Second Opposition Group and 1 Member from the Third Opposition Group present in the National Assembly Chamber;

THAT during debates on Orders of the Day, with the exception of debates on Business Standing in the Name of Members in Opposition, lack of quorum may not be raised if not less than 7 Members from the parliamentary group forming the Government are present in Chamber;

THAT the schedule established for Tuesday sittings under this motion as well as the provisions regarding the quorum required to begin the sitting shall also apply if the Assembly decides to sit on a Monday;

THAT a motion for the adjournment of the proceedings may only be made during the Orders of the Day following the period of Routine Proceedings;

Debates upon Adjournment

THAT the debates upon adjournment scheduled to be held on Tuesdays be held instead beginning at 6:30 p.m. and that the adjournment of the sitting be delayed accordingly;

THAT the debates upon adjournment scheduled to be held on Thursdays be held instead beginning at 1:30 p.m. and that the suspension of proceedings be delayed accordingly;

Wednesday Motion

THAT on Wednesdays, debates on Business Standing in the name of Members in Opposition be held from 2:30 p.m. to 4:30 p.m.;

THAT, during debates on Business Standing in the Name of Members in Opposition, lack of quorum may not be raised unless,

- in the case of a motion moved by the Official Opposition, less than 3 Members from the parliamentary group forming the Official Opposition are present in Chamber;
- in the case of a motion moved by the Second Opposition Group, less than 1 Member from the parliamentary group forming the Second Opposition Group is present in Chamber;

- in the case of a motion moved by the Third Opposition Group, less than 1 Member from the parliamentary group forming the Third Opposition Group is present in Chamber;
- in the case of a motion moved by an independent Member, less than 1 opposition Member is present in Chamber;

#### Recorded Divisions

THAT all questions be put in accordance with the procedure for recorded divisions;

THAT, for that purpose, the vote of the House Leader or the Deputy House Leader of a parliamentary group or, where applicable, of a Member whose name was notified by the latter to the Secretariat of the Assembly beforehand, is valid for all Members from his or her group;

THAT a Member be entitled to individually record a vote that differs from the vote of his or her parliamentary group or choose not to vote;

THAT the Member, if present, express such an intention immediately after the vote of his or her parliamentary group and, if not present, inform the House Leader of his or her parliamentary group of such an intention so that the latter may notify the President during the taking of the division or notify the President in writing before the division is taken;

THAT, unless they indicate otherwise, the vice-presidents do not vote in a recorded division;

THAT the names of all the Members having voted be recorded in the *Votes and Proceedings* of the sitting;

THAT all questions within the framework of a Committee of the Whole be put in accordance with this same procedure;

THAT, if an independent Member is absent, the Government House Leader be authorized to record the Member's vote regarding a stage in the consideration of a bill according to the instructions transmitted to the Government House Leader, if applicable, and whose transmission is the responsibility of the independent Member;

Suspension of Proceedings to Vote in the Assembly

THAT the proceedings be suspended for no longer than 10 minutes, when a question is put in the Assembly, if a parliamentary group is not represented by a House Leader or Deputy House Leader, or by a Member designated to act on their behalf for the purposes of the vote, and has not notified the President that it will not take part in the vote;

THAT the Secretary General or a Table officer notify the House Leaders and Whips of the parliamentary groups, as well as their offices, and the independent Members and committee clerks of the suspension of proceedings for the purpose of putting a question to the Assembly;

THAT the committee on which a House Leader or a Deputy House Leader, or a Member designated to act on their behalf for voting purposes, is sitting suspend its proceedings, at the latter's request, to allow that person to make his or her way to the National Assembly Chamber;

THAT the Secretary General or a Table officer notify the committee secretariat after the President has declared the result of the vote or, in the event of successive votes, after the President has declared the results of the last vote so that the committee may resume its proceedings not later than 5 minutes afterwards;

#### **Parliamentary Committees**

General Provisions

THAT, with the exception of the Committee on Public Administration, no committee be allowed to hold deliberative meetings;

THAT the time limits provided for in Standing Orders 64.3 and 64.6, for a committee to decide whether to examine a petition or to table its report, be suspended for as long as the preceding paragraph applies;

THAT the Members participating in the proceedings of a parliamentary committee be entitled to take the floor and vote from any desk set up for that purpose by the Chair;

THAT a parliamentary committee be allowed to hold any given meeting simultaneously in the Louis-Joseph-Papineau Room and the Louis-Hippolyte-LaFontaine Room, using the technological means necessary;

#### Committee Hours of Meeting

#### THAT committees may meet on:

- (1) Mondays from 2:00 p.m. until 6:00 p.m.;
- (2) Tuesdays from 9:30 a.m. until 7:00 p.m., the proceedings being suspended from 12:00 p.m. noon until the end of Routine Proceedings;
- (3) Wednesdays from the end of Routine Proceedings until 6:30 p.m., the proceedings being suspended from 1:00 p.m. to 2:30 p.m.;
- (4) Thursdays from the end of Routine Proceedings until 4:30 p.m., the proceedings being suspended from 1:00 p.m. to 2:00 p.m.;
- (5) Fridays from 9:30 a.m. until 12:30 p.m.;

Procedure for Recorded Divisions in Non-Virtual Parliamentary Committees

THAT quorum for non-virtual parliamentary committees be three Members;

THAT during those committee meetings, all votes be held in accordance with the procedure for recorded divisions;

THAT the vote expressed by a government Member designated for that purpose by the Government House Leader be valid for all Members from his or her group, with the exception of the ministers and the President, who vote in their own name;

THAT the vote expressed by the Member of the Official Opposition designated for that purpose by the Official Opposition House Leader be valid for all the Members of his or her group, with the exception of the President, who votes in his or her own name;

THAT a Member be entitled to individually record a vote that differs from the vote of his or her parliamentary group or choose not to vote;

THAT the Member, if present, express such an intention immediately after the vote of his or her parliamentary group and, if not present, inform the Member designated to vote on behalf of his or her parliamentary group of such an intention so that the latter may notify the Committee secretariat during the taking of the division:

THAT the names of all the Members having voted be recorded in the minutes of the proceedings of the committee meeting;

THAT an independent Member who wishes to participate in the proceedings of a parliamentary committee of which he or she is not a member so notify that committee's clerk and the House Leaders of the parliamentary groups, not later than noon on the Monday preceding the date of the committee meeting or on the same day, if it is a Monday;

THAT, if the independent Member is informed later than noon Monday that a committee will be meeting that week, the deadline provided for in the preceding paragraph be extended to three hours after the time the Member is informed that a meeting is to be held;

#### Virtual Committees

THAT the proceedings of the Committee on Public Administration may be held by video conference;

THAT the hearings of other parliamentary committees may be held by video conference;

THAT a virtual committee be considered to be a committee which meets in the precincts of the Assembly for the purposes of Standing Order 145;

THAT during these meetings, the Member who chairs the committee as well as the staff of the committee secretariat be present in person at the Parliament Building;

THAT the other Members as well as the individuals and organizations summoned may participate by using the technological means necessary;

THAT the Members who participate in these meetings by video conference be considered to be committee members who are present for the purposes of Standing Order 156;

THAT these meetings be broadcast by television and livestreamed on the National Assembly website;

THAT no vote may be held during these meetings except for those of the Public Administration Committee, for which decisions may be taken unanimously by the members taking part in them;

THAT the rules pertaining to parliamentary committees be observed in these meetings insofar as they are not in variance with the provisions of this motion;

#### Final Provision

THAT this motion take precedence over any incompatible provisions of the Standing Orders.

The motion was carried.

#### **Debates on Reports from Committees**

#### **Oral Questions and Answers**

The President gave a directive on modifications in the distribution of certain measures and speaking times having become necessary following changes in the composition of the Assembly, which has had two additional independent Members since the adjournment of proceedings in December.

#### RULING FROM THE CHAIR

As regards Question Period, the new independent Member from the Third Opposition Group will be granted three questions per 10-sitting cycle, as in the case of the other independent Members. These questions will be in 7th place, in substitution for the questions previously granted to the Third Opposition Group.

In addition, given that the Third Opposition Group now has eight Members, the questions that belonged to this group in the 8th place will now be given to the Second Opposition Group in order to better reflect the relative proportion of these groups. Furthermore, because of the difference in the number of Members between the Second and Third Opposition Group, it is necessary to change the order of the questions assigned to these groups. The Second Opposition Group will therefore now have the right to ask questions in the 4th place of a Question Period for six sittings per cycle of 10, instead of half the time. Accordingly, the Third Opposition Group will now have the right to questions in the 4th place for four sittings in 10.

Regarding Statements by Members, all independent Members will continue to be entitled to make one statement per cycle of 10 sittings, in 8th place. Members who not intend to exercise this right must inform their parliamentary group, and the Chair, no later than 12:30 p.m. on the day before the sitting for which they had the right to make a statement. The parliamentary group thus notified will be able to make use of this statement.

As for the distribution of Business Standing in the Name of Members in Opposition and interpellations, which was conducted based on a cycle of 10, it will now be conducted based on a cycle of 13. The parliamentary group forming the Official Opposition will therefore have two additional measures per cycle and the Second Opposition Group will have one additional measure.

Lastly, as regards the distribution of speaking times during limited debates, the time allotted for independent Members is increased, so that the new independent Members will have the right to times equivalent to those that were until now granted to the other independent Members. For good time management, given that any time not used by independent Members will be returned to the parliamentary groups based on the usual proportions, the independent Members will always have 10 minutes starting from the beginning of a limited debate to notify the Chair of their intention to speak during the debate.

#### Information on the Proceedings of the Assembly

- Allowing university students to submit their candidacy for the tutoring program, regardless of their program of study;

- Adding a financial or tax incentive to entice retired teachers to return to work;
- Negotiating with teachers in good faith to avoid penalizing students; and
- Undertaking to convene, during the spring break, an emergency summit with all the stakeholders involved in educational success and academic perseverance to establish a 3-year crisis recovery plan to maximize Québec students' chances for success.
