For the purposes of subparagraph 3 of the first paragraph, members who qualify as independent directors within the meaning of section 4 of the Act respecting the governance of state-owned enterprises (chapter G-1.02) are independent. Sections 5 to 8 of that Act apply to those members, with the necessary modifications. The independent members are appointed taking into consideration the expertise and experience profiles approved by the board and their interest in training and agri-food and after consultation with the education, agri-food and

labour sectors. The independent members must include at least one member of the Ordre professionnel des comptables professionnels agréés du Québec;

For the purposes of subparagraphs 4 and 5 of the first paragraph, if the Institute has more than two campuses, the members are appointed on an alternating basis from the different campuses.

For the purposes of subparagraph 5 of the first paragraph, in the absence of an accredited students' association or students' association alliance, the two student members are elected by a majority of the votes cast by their peers at a meeting called and presided over by the director general at each of the campuses concerned.
