Moment of reflection

The President informed the Assembly that he had, within the prescribed time, received a request for an urgent debate from Mr. Fortin, Official Opposition House Leader, with respect to Québec's public health situation, which has alarmingly deteriorated extremely rapidly in the past few days.

RULING FROM THE CHAIR

To determine whether a request for an urgent debate is receivable, the Chair must examine the criteria stipulated in the Standing Orders and in jurisprudence. To be receivable, a request for an urgent debate must concern a specific, important matter that falls under the Assembly's jurisdiction. Furthermore, the object of the debate must concern a sudden, acute crisis or the worsening of such a crisis. The Chair must also take into consideration whether the matter has been discussed in other circumstances and whether there will be upcoming opportunities to do so.

However, before examining these criteria, the Chair must also take into account Standing Order 54, which sets out the order of priority of the debates that may take place during a given sitting. In this regard, Urgent Debates rank second after Business Having Precedence.

In addition, the House undertook the debate on the Budget Speech yesterday, which has priority under paragraph 5 of Standing Order 87. An urgent debate can therefore not be held while the Assembly is seized of a matter of greater priority. Consequently, the Chair is not required to examine the receivability criteria as such, given that no urgent debate may be held while the debate on the Budget Speech is in progress.

Accordingly, the request for an urgent debate is out of order.

Introduction of Bills

Ms. Fournier (Marie-Victorin) moved that leave be granted to introduce the following bill:

An Act to promote integration of immigrants by organizing welcome ceremonies for newcomers

The question was put on this motion; in accordance with the motion carried by the Assembly on 9 March 2021, a vote was held in accordance with the procedure for recorded divisions.

Complaints of Breach of Privilege or Contempt and Personal Explanations

The President informed the Assembly that he had, within the prescribed time, received a request from Mr. Nadeau-Dubois, House Leader of the Second Opposition Group, to be heard on an alleged breach of privilege.

In his notice, the House Leader of the Second Opposition Group alleged that the Minister of Education acted in contempt of Parliament for having misled the Assembly by declaring in the House that the protocol for measuring the quality of air in schools had been developed following the recommendation of the Direction générale de la santé publique du Ouébec.

The notice further stated the Official Opposition House Leader's intention to move a motion under Standing Orders 315 and following.

The President informed the Assembly that he would hear arguments at a later sitting.

Motions Without Notice

THAT, in support of the Canadian Cancer Society's Daffodil Month, the Assembly encourage all Quebecers to make a meaningful gesture toward someone touched by cancer.

THAT the National Assembly denounce, within the framework of the 2021–2022 budget, the submission of the CAQ government to the Canadian regime, depriving Québec of levers that are key to fighting the pandemic and to making a fair and green recovery.
