#### **Oral Questions and Answers**

The Assembly proceeded to Oral Question Period.

#### **Motions Without Notices**

Mr. Dubé, Minister of Health and Social Services, together with Mr. Thouin (Rousseau), moved a motion on modernizing infrastructure and funding health and social services in the Laurentides region; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Polo (Laval-des-Rapides), together with Ms. Girault, Minister of International Relations and La Francophonie, Mr. Fontecilla (Laurier-Dorion), Mr. Arseneau (Îles-de-la-Madeleine), Mr. Ouellette (Chomedey), Ms. Fournier (Marie-Victorin) and Mr. Thouin (Rousseau), moved:

THAT the National Assembly express its concern regarding the current situation in Colombia, where protests against the Government have given rise to violent clashes between the population and security forces, resulting in the death, injury and disappearance of many people;

THAT it add its voice to that of the European Union, which has deemed that ending the escalation of violence and avoiding the disproportionate use of force by security forces is a priority;

THAT it recall that the Office of the United Nations High Commissioner for Human Rights stated that it is "deeply alarmed" by the current situation in Colombia, in particular in the city of Cali;

THAT it express its solidarity with the more than 25,000 Quebecers of Colombian origin who are living in anguish;

THAT it express its hope for a peaceful resolution of these events, based on dialogue and the respect of human rights;

THAT, lastly, it observe a minute of silence in memory of the victims and in respect for their families.

The question was put on this motion; in accordance with the motion carried by the Assembly on 13 April 2021, a vote was held in accordance with the procedure for recorded divisions.

By leave of the Assembly to set aside Standing Order 185, Mr. Nadeau-Dubois, House Leader of the Second Opposition Group, together with Ms. Montpetit (Maurice-Richard), Mr. Arseneau (Îles-de-la-Madeleine), Mr. Ouellette (Chomedey), Ms. Fournier (Marie-Victorin) and Mr. LeBel (Rimouski), moved:

Whereas there are blatant inequalities between Global North and Global South countries regarding access to COVID-19 vaccines;

Whereas it is to the advantage of all countries that the vaccination campaign continue internationally, because the COVID-19 pandemic will not end until the planet's entire population has been vaccinated;

Whereas Québec has a tradition of international solidarity;

THAT the National Assembly welcome and support the decision by the President of the United States to support the World Trade Organization's resolution to suspend COVID-19 vaccine patents;

THAT it call on the Québec government to pressure the Canadian government to vote in favour of this resolution.

By leave of the Assembly to set aside Standing Order 185, Mr. Ouellette (Chomedey), together with Ms. St-Pierre (Acadie) and Ms. Fournier (Marie-Victorin), moved:

THAT the National Assembly recognize the Laurentides region as an administrative region that has undergone constant and exponential growth over the last three decades and whose population's proportionate aging is accelerating at one of the fastest rates in all of the Québec regions;

THAT it underscore the fact that these specific characteristics result in major challenges, in particular with respect to funding and organizing the region's health and social services system;

THAT it acknowledge that, although investment has resumed in recent years, the Laurentides region has fallen significantly behind, because public funding of health and social services and infrastructure has not kept pace with the growing population;

THAT it recall that this situation has had various impacts on the development of health and social services that meet the needs of Laurentides residents, in particular with respect to the ability to meet the MSSSQ's targets for delivering care;

THAT, lastly, it underscore how important it is for the Québec government to support the Laurentides region by focusing on closing the funding gap and accelerating the projects to modernize and expand its hospital centres, including its flagship, the Hôpital régional de Saint-Jérôme.
