> Whereas every minute counts during cardiopulmonary arrest and that early CPR intervention by trained bystanders makes it possible to significantly increase the chances of survival;

Whereas a multitude of different health conditions and the aging of the population are causing increasing pressure on emergency rooms as well as on pre-hospital services;

Whereas the traditional standard response to pre-hospital requests, that is to say "a 911 call = systematic transport by ambulance to Emergency", is not adequately serving the needs of all network users and that it is therefore necessary to rethink this for their benefit;

Given advances in the paramedic profession over the last 30 years and the need to fully utilize their expertise to guide patients in distress to the appropriate health resource for their condition;

THAT the National Assembly highlight the holding of the national pre-hospital summit on Monday, 10 May 2021, the first in 20 years and the first step towards a reform of this sector, which will make it possible to harness the contribution of both pre-hospital responders and citizens in order to meet the needs of patients in distress.

#### **Government Bills**

Passage

The Assembly resumed the debate, which had been adjourned on 12 May 2021, on the motion moved by Mr. Jolin-Barrette, Minister of Justice, for the passage of Bill 84, An Act to assist persons who are victims of criminal offences and to facilitate their recovery.

The debate being concluded, the question was put on this motion; at 11:42 a.m., in accordance with the motion carried by the Assembly on 13 April 2021, Ms. Soucy, Second Vice-President, suspended the proceedings for no longer than 10 minutes so that a recorded division could be held.

The proceedings resumed at 11:46 a.m.

A vote was held in accordance with the procedure for recorded divisions.

The motion was carried on the following vote:

Accordingly, Bill 84 was passed.

#### Passage in Principle

The Assembly resumed the debate, which had been adjourned on 11 May 2021, on the motion moved by Ms. Laforest, Minister of Municipal Affairs and Housing, that Bill 49, An Act to amend the Act respecting elections and referendums in municipalities, the Municipal Ethics and Good Conduct Act and various legislative provisions, do now pass in principle.

A debate arose thereon.

At the end of her address, Ms. Melançon (Verdun) moved the following motion to divide the said Bill:

THAT, pursuant to Standing Order 241, Bill 49, An Act to amend the Act respecting elections and referendums in municipalities, the Municipal Ethics and Good Conduct Act and various legislative provisions, be divided into two bills:

The first of which shall be entitled "An Act to amend the Act respecting elections and referendums in municipalities", and shall comprise sections 1 to 68, sections 121, 122, 128, 129, 141, 144 and 145 and paragraphs 4 and 5 of section 146;

The second of which shall be entitled "An Act to amend the Municipal Ethics and Good Conduct Act and various legislative provisions", and shall comprise sections 69 to 140, except sections 121, 122, 128 and 129, sections 142 and 143 and paragraphs 1, 2 and 3 of section 146.

At 12:14 p.m., Ms. Soucy, Second Vice-President, suspended the proceedings.

The proceedings resumed at 12:36 p.m.

At 12:59 p.m., after hearing arguments from all sides regarding the receivability of the motion to divide, Ms. Soucy, Second Vice-President, took the matter under advisement and suspended the proceedings for a few minutes.

#### **Debates upon Adjournment**

At 1:04 p.m., in accordance with the motion carried by the Assembly on 13 April 2021, the Assembly held two debates upon adjournment:

- the first, on a question from Mr. Derraji (Nelligan) to Ms. Girault, Minister of International Relations and La Francophonie, about the failure of the CAQ's immigration reform. Mr. Lamontagne, Minister of Agriculture, Fisheries and Food, replaced the Minister for this debate;
- the second, on a question from Mr. Barrette (La Pinière) to Ms. Girault, Minister of International Relations and La Francophonie, about expired large sums for integration and francization. Mr. Lamontagne, Minister of Agriculture, Fisheries and Food, replaced the Minister for this debate.

#### **Government Bills**

Passage in Principle

Ms. Soucy, Second Vice-President, ruled on the receivability of the motion to divide moved by Ms. Melançon (Verdun).

#### RULING FROM THE CHAIR

Parliamentary jurisprudence has recognized that, for a motion to divide to be declared receivable, a bill must contain more than one principle and each bill resulting from the division must be coherent, complete and able to stand alone.

The Chair has also mentioned on numerous occasions that analysis of the receivability of a motion to divide should not be based on the purpose of the bill's author, but rather should consider the bill's provisions to determine whether it contains more than one principle.

After having read and analyzed the bill's provisions, the Chair has ascertained that this bill clearly contains more than one principle. While the bill proposes to implement a set of measures related to municipal affairs, one can see that it groups these principles under two main subjects, one being elections and referendums in municipalities and the other, municipal ethics. Once it has been determined that a bill contains more than one principle, the Chair must determine if the way the sections are divided among the different bills resulting from the division generates separate bills that are coherent and can be considered independently.

In the present case, both bills resulting from the division would be coherent, complete and able to stand alone, as set out in the jurisprudence, despite the fact that they concern two very closely related subjects.

For example, a section of the bill inserts into the *Act respecting elections and referendums in municipalities* a reference to a new section of the *Municipal Ethics and Good Conduct Act*. That new section is introduced by another section of the bill, which would be found in the other bill resulting from the division. However, jurisprudence has established that this situation is no different from a situation where two bills go through the steps of the legislative process at the same time.

The original intent of the bill's author is irrelevant. Parliamentary jurisprudence has established that, to the extent that the provisions are grouped in a way forming a coherent whole able to stand alone, a division may be possible. It is then up to the Assembly to determine whether it wishes to introduce two new bills or to continue its consideration of the initial bill.

Consequently, the motion to divide is declared receivable.

Ms. Soucy, Second Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to the limited debate on this motion to divide: 57 minutes to the parliamentary group forming the Government; 34 minutes 42 seconds to the parliamentary group forming the Official Opposition; 12 minutes 23 seconds to the Second Opposition Group; 9 minutes 55 seconds to the Third Opposition Group; and 6 minutes to the independent Members, subject to a maximum of 2 minutes each. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

The Assembly entered upon the debate on the motion to divide moved by Ms. Melançon (Verdun).

The debate was adjourned in the name of Mr. Birnbaum (D'Arcy-McGee).

Accordingly, at 4:30 p.m., Mr. Picard, First Vice-President, adjourned the Assembly until Tuesday, 25 May 2021 at 1:40 p.m.
