Mr. Jolin-Barrette, Government House Leader, then moved:

THAT, pursuant to Standing Order 280, the 2022–2023 estimates of expenditure be referred to a Committee of the Whole for consideration and for concurrence in one quarter of the said estimates.

The motion was carried.

By leave of the Assembly to set aside Standing Order 53, the Assembly proceeded to hear a motion without notice.

Motions Without Notice

Mr. Jolin-Barrette, Government House Leader, moved:

THAT, pursuant to the provisions of subparagraph 4.1 of the first paragraph of Standing Order 87 and Standing Orders 280 and 281, the Assembly consider and concur in Interim Supply for the 2022–2023 fiscal year as provided hereinafter;

THAT, as soon as Orders of the Day for the Wednesday, 23 March 2022 sitting are called, the Assembly resolve itself into a Committee of the Whole and consider Interim Supply as follows:

THAT, for a period not exceeding 1 hour, an exchange take place between the Minister of Energy and Natural Resources and the Members in opposition;

THAT, immediately thereafter, for a period not exceeding 1 hour, an exchange take place between the Minister of Health and Social Services and the Members in opposition;

THAT, at 1:00 p.m., the Committee of the Whole suspend its proceedings and that the proceedings of the Assembly be suspended until 3:00 p.m.;

THAT, at 3:00 p.m., the Committee of the Whole continue its proceedings and, if necessary, be able to conclude the exchange between the Minister of Health and Social Services and the Members in opposition;

THAT, immediately thereafter, for a period not exceeding 1 hour, an exchange take place between the Minister Responsible for Government Administration and the Chair of the Conseil du trésor and the Members in opposition;

THAT, immediately thereafter, for a period not exceeding 1 hour, an exchange take place between the Minister of the Environment and the Fight Against Climate Change and the Members in opposition;

THAT, immediately thereafter, for a period not exceeding 1 hour, an exchange take place between the Minister of Education and the Members in opposition;

THAT, immediately upon the conclusion of this exchange, the Chair of the Committee of the Whole put the question for concurrence in one quarter of the estimates of expenditure for the 2022–2023 fiscal year;

THAT the Chair of the Committee of the Whole then report to the Assembly and that the question for concurrence in such report and then the question for passage of the consequent appropriation bill be put without debate, pursuant to the first paragraph of Standing Order 281;

THAT, lastly, pursuant to the second paragraph of Standing Order 281, the Government House Leader be permitted to move a motion without notice that may not be debated, stating that the main estimates of expenditure, save those of the National Assembly, be referred to the Standing Committees for consideration;

THAT the opening statements for each of the exchanges with the aforementioned Ministers not exceed 5 minutes 34 seconds for the parliamentary group forming the Government; 3 minutes 43 seconds for the parliamentary group forming the Official Opposition; 56 seconds for the Second Opposition Group; 56 seconds for the Third Opposition Group; and 51 seconds for the independent Members as a whole;

THAT, for each of the exchanges with the aforementioned Ministers, a period of 3 minutes 45 seconds per hour be set aside for exchanges with the independent Members;

THAT any time not used by the independent Members be redistributed proportionally among the parliamentary groups forming the Official Opposition, the Second Opposition Group and the Third Opposition Group;

THAT the President of the Assembly or the Chair of the Committee of the Whole be permitted to suspend the proceedings at any time;

THAT, despite the provisions of the special order adopted on 15 March 2022, the Committee of the Whole and the Assembly be permitted to continue their proceedings until the latter has voted on the appropriation bill and on the motion for referral of all of the estimates of expenditure, save those of the National Assembly, to the Standing Committees for consideration;

THAT this motion become an order of the Assembly and take precedence over any incompatible provisions of the Standing Orders and the special order adopted on 15 March 2022.

By leave of the Assembly, the motion was carried.

Presenting Reports from Committees

Mr. Simard (Montmorency), Committee Chair, tabled the following:

By leave of the Assembly to set aside Standing Orders 53 and 59, Ms. Anglade, Leader of the Official Opposition, tabled the following:

Deferred Divisions

The Assembly took the division, which had been deferred on 17 March 2022, on the motion moved by Mr. Birnbaum (D'Arcy-McGee) for the passage in principle of Bill 498, An Act to proclaim the National Day for the Promotion of Positive Mental Health.

The motion was carried on the following vote:

Accordingly, Bill 498 was passed in principle.

Mr. Schneeberger, Deputy Government House Leader, moved that Bill 498 be referred to the Committee on Health and Social Services for clause-by-clause consideration.

The motion was carried.

Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mr. Bérubé (Matane-Matapédia), together with Mr. Fortin, Official Opposition House Leader, Mr. Zanetti (Jean-Lesage), Mr. Ouellette (Chomedey), Mr. Roy (Bonaventure) and Mr. LeBel (Rimouski), moved:

THAT the National Assembly reiterate that the Québec government must give equal attention and support to the issues of all Québec ridings, regardless of the political affiliations of the people duly elected to represent the ridings in this Assembly;

THAT it affirm that it should not be more difficult for opposition Members to advance the issues of their communities than it is for Members of the governing party.

The question was put on this motion and a recorded division was thereupon demanded.

The motion was carried on the following vote:

By leave of the Assembly to set aside Standing Order 185, Ms. LeBel, Minister Responsible for Canadian Relations and the Canadian Francophonie, together with Mr. Birnbaum (D'Arcy-McGee), Mr. Zanetti (Jean-Lesage), Mr. Ouellette (Chomedey), Mr. Roy (Bonaventure) and Mr. LeBel (Rimouski), moved:

THAT the National Assembly recall that it is important that the Québec nation take action to ensure a strong, united and committed Canadian Francophonie;

THAT it affirm its support for strengthening the bonds between Quebecers and the other francophones of Canada in order to build bridges and establish sustainable cooperation between us;

THAT it recognize that Québec, which has a vested historical responsibility toward the use, promotion and vitality of the French language, intends to play a leading role within the Canadian Francophonie;

THAT it designate 22 March as Québec Day for the Canadian Francophonie.

By leave of the Assembly, the motion was carried.

Ms. Melançon (Verdun), together with Mr. Ouellette (Chomedey), Mr. Roy (Bonaventure) and Mr. LeBel (Rimouski), moved a motion on World Water Day and water preservation; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Fontecilla (Laurier-Dorion), together with Mr. Charette, Minister Responsible for the Fight Against Racism, Ms. Maccarone (Westmount–Saint-Louis), Ms. Perry Mélançon (Gaspé), Mr. Ouellette (Chomedey), Mr. Roy (Bonaventure), Mr. LeBel (Rimouski) and Ms. Montpetit (Maurice-Richard), moved:

THAT the National Assembly mark the 23rd edition of Action Week Against Racism and for Equal Opportunities, held this year from 21 to 31 March under the theme "Welcoming refugees and migrants to Québec";

THAT it strongly reiterate that racism in all its forms is unacceptable, that it has socio-economic impacts and impacts on the right to health, housing and the security and dignity of the individuals and communities who experience it;

THAT it strongly condemn the alarming increase in hate crimes over the past year;

THAT it reiterate its commitment to ensuring equal opportunities for all, in particular for newcomers;

THAT the National Assembly call on the Québec government and Quebecers to continue and step up the fight against racism.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Mr. Roy (Bonaventure), together with Mr. Dubé, Minister of Health and Social Services, Mr. Marissal (Rosemont), Mr. Arseneau, Leader of the Third Opposition Group, Mr. Ouellette (Chomedey) and Mr. LeBel (Rimouski), moved:

Whereas pressure on the health care system is reflected in waiting lists, overworked staff and a shortage of beds;

Whereas one effective way to reduce pressure on the health care system is to proactively work to protect the health of the population;

Whereas, for decades, many reports have recommended that constructive actions be taken to reduce the growing impact of chronic diseases;

Whereas the 2022 report of the Commission à la santé et au bien-être included a recommendation to build the capacities of the public health system (human, informational and financial resources) based on needs and targeted outcomes, to achieve levels comparable to those seen elsewhere in Canada and around the world:

Whereas the Government has affirmed its intention to implement the Health and Welfare Commissioner's recommendations;

Whereas the collective position taken on 17 March by 26 professional associations and orders, including the Collège québécois des médecins de famille, the Ordre des infirmières et infirmiers du Québec and the Association des cardiologues du Québec, calls for an emergency prevention plan;

THAT the National Assembly recognize the importance of taking action to strengthen disease prevention and health promotion in Québec;

THAT the National Assembly recognize that preventive health requires tools such as the Government's preventive health policy;

THAT, lastly, the National Assembly call on the Government to make public health a priority in the overhaul of the health care system.

By leave of the Assembly, the motion was carried.
