The Assembly proceeded to Oral Question Period.

Deferred Divisions

The Assembly took the division, which had been deferred at the sitting of 2 June 2022, on the motion moved by Mr. Girard, Minister of Finance, for the passage of Bill 4, An Act to reinforce the governance of state-owned enterprises and to amend other legislative provisions.

The motion was carried on the following vote:

Yeas: 88 Nays: 8 Abstentions: 0

Accordingly, Bill 4 was passed.

The Assembly took the division, which had been deferred at the sitting of 2 June 2022, on the motion moved by Ms. Roy, Minister of Culture and Communications, for the passage of Bill 35, An Act to harmonize and modernize the rules relating to the professional status of artists.

The motion was carried on the following vote:

Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Ms. Massé (Sainte-Marie-Saint-Jacques), together with Mr. Dubé, Minister of Health and Social Services, Ms. Maccarone (Westmount-Saint-Louis), Mr. Arseneau, Leader of the Third Opposition Group, and Ms. Montpetit (Maurice-Richard), moved:

THAT the National Assembly acknowledge Health Canada's decision to allow blood donations from men who are sexually active with other men;

THAT it be concerned about the cyclical decline in the number of blood donations;

THAT the National Assembly ask the Government to accelerate its efforts with Héma-Québec to expedite the change to the blood donation eligibility criteria for men who have had sex with men.

By leave of the Assembly, the motion was carried.

Mr. Gaudreault (Jonquière), together with Mr. Leduc (Hochelaga-Maisonneuve), Mr. LeBel (Rimouski) and Ms. Montpetit (Maurice-Richard), moved a motion on the work done by children in Québec; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Jolin-Barrette, Minister of the French Language, together with Ms. David (Marguerite-Bourgeoys), Ms. Ghazal (Mercier), Mr. Bérubé (Matane-Matapédia) and Ms. Montpetit (Maurice-Richard), moved:

THAT the National Assembly recall that the French language is the common thread that unites us all as a people;

THAT it affirm that it is a means by which Quebecers can talk together, live together and work together.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Ms. St-Pierre (Acadie), together with Ms. Roy, Minister of Culture and Communications, Mr. Marissal (Rosemont) and Mr. Bérubé (Matane-Matapédia), moved:

THAT the National Assembly pay tribute to Mr. Denis Lévesque, prolific communicator and public affairs program host;

THAT it underline the success of his eponymous program, a flagship program on the LCN TV channel, which has spanned 16 years with more than 3,000 daily shows;

THAT it underline with admiration his talent as a popularizer, his great versatility, and his ability to arouse interest in all subjects and to make them accessible to all audiences;

THAT, lastly, it thank Mr. Lévesque for his contribution to our democratic life and wish him great success in his future career endeavors.

By leave of the Assembly, a debate arose thereon.

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 2, An Act respecting family law reform with regard to filiation and amending the Civil Code in relation to personality rights and civil status, together with the amendments transmitted by Mr. Jolin-Barrette, Minister of Justice, Ms. Maccarone (Westmount–Saint-Louis) and Ms. Massé (Sainte-Marie–Saint-Jacques).

The amendments were declared in order.

After debate thereon, the amendments proposed by Mr. Jolin-Barrette, Minister of Justice, were carried.

Then, by leave of the Assembly, Ms. Soucy, Second Vice-President, put the question individually on the amendments proposed by Ms. Maccarone (Westmount–Saint-Louis) and Ms. Massé (Sainte-Marie–Saint-Jacques) and on the reading thereof.

First, the question was put on the amendment proposed by Ms. Maccarone (Westmount–Saint-Louis) introducing section 47.1.

The amendment was negatived.

The question was then put on the amendment proposed by Ms. Massé (Sainte-Marie–Saint-Jacques) introducing section 2.1.

The amendment was negatived.

Lastly, the report, as amended, was concurred in.

The Assembly took into consideration the report from the Committee on Public Finance on its clause-by-clause consideration of Bill 33, An Act to amend the Taxation Act, the Act respecting the Québec sales tax and other provisions.

After debate thereon, the report was concurred in on division.

Mr. Caire, Deputy Government House Leader, moved the adjournment of the Assembly until Tuesday, 7 June 2022 at 1:40 p.m.
