THAT, on the occasion of the International Day for the Elimination of Racial Discrimination, the National Assembly mark the necessity to continue our actions and to mobilize the bone and sinew of all regions of Québec in this formidable challenge to make Québec, by 2013, one of the industrialized societies having the least number of persons living in poverty and social exclusion.
