# Information on the Proceedings of the Assembly

Pursuant to Standing Order 299, Mr. Chagnon, Second Vice-President, reminded the Assembly that no interpellations may be held while the Assembly stands adjourned for more than five days.

Hence, as provided for in the new calendar of the Assembly tabled on 16 September 2009, the Assembly will not be sitting during the week of Monday, 12 October to Friday, 16 October since this week is set aside for local riding work. Accordingly, the Assembly will be required to adjourn its proceedings tomorrow, Thursday, 8 October 2009, and no interpellation may be held on the following two Fridays, 9 and 16 October.

Furthermore, an interpellation may be held on the first Friday upon the resumption of proceedings, on Friday, 23 October 2009. As the Assembly will not be sitting at that time, the notice must be placed on tomorrow's *Order Paper and Notices*, that is, on Thursday, 8 October 2009, to permit the holding of the interpellation on Friday, 23 October 2009.

# ORDERS OF THE DAY

### **Government Bills**

Passage in Principle

Mrs. Weil, Minister of Justice, moved, —That Bill 60, An Act to amend the Consumer Protection Act and other legislative provisions, do now pass in principle.

After debate thereon, the motion was carried and Bill 60 was accordingly passed in principle.

Mr. Gautrin, Deputy Government House Leader, moved that Bill 60 be referred for clause-by-clause consideration to the Committee on Citizen Relations.

The motion was carried.

At 11.58 o'clock a.m., at the request of Mr. Gautrin, Deputy Government House Leader, Mr. Chagnon, Second Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.03 o'clock p.m.

**Business Standing in the Name of Members in Opposition** 

Mrs. Bouillé (Iberville) moved:

THAT the Committee on Agriculture, Energy and Natural Resources hold special consultations and public hearings on Thursday, 8 October 2009, to examine the new agricultural provisions contained in the Agreement on Internal Trade, before their ratification scheduled for 15 October 2009.

Pursuant to the provisions envisaged in the parliamentary reform adopted on 21 April 2009, Mr. Gendron, Third Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this motion: 10 minutes shall be allotted for a reply by its mover; 5 minutes shall be allotted for the independent Member and 11 minutes shall be allotted to the Members of the Second Opposition Group; the remaining time shall be distributed equally between the parliamentary group forming the Government and the parliamentary group forming the Official Opposition. Within this framework, any time not used by the independent Member or by the Members of the Second Opposition Group shall be redistributed equally between the parliamentary group forming the Government and the parliamentary group forming the Official Opposition; and any time not used by the parliamentary group forming the Government shall go the parliamentary group forming the Official Opposition and vice versa. Lastly, individual addresses shall not be limited.

The debate arose thereon.

The debate being concluded, the question was put on this motion; a recorded division was thereupon demanded.

At the request of Mr. Béchard, Deputy Government House Leader, the division was deferred until Routine Proceedings on the next sitting day.

Mrs. Maltais, Deputy Opposition House Leader, raised a point of order as to the possibility of deferring the division on the present motion.

### **RULING FROM THE CHAIR**

The possibility of deferring the division on a motion does not depend on the content of the latter. Standing Order 223 stipulates that only divisions on motions for adjournment or for the previous question may not be deferred, while for other types of motions, divisions may be deferred. The division on the present motion may therefore be deferred.

### **Government Bills**

Report Stage

The Assembly took into consideration the report from the Committee on Health and Social Services on its clause-by-clause consideration of Bill 6, An Act to establish a seniors caregiver support fund, together with the amendments handed in by Mr. Khadir (Mercier).

The amendments were declared in order.

After debate thereon, the amendments were negatived.

The report was concurred in on division, Mr. Khadir (Mercier) recording his dissent.
