RULING FROM THE CHAIR

This request for an urgent debate is not receivable. The request concerns a definite and important matter involving the responsibility of the Assembly. Today is the first sitting day of a new sessional period and there will be numerous opportunities to debate this matter. Complaints of Breach of Privilege or Contempt and Personal Explanations

Mr. President informed the Assembly that he had received a notice from Mrs. Léger, Chief Opposition Whip, indicating her intention to rise on a matter of privilege. In her notice, Mrs. Léger, Chief Opposition Whip, alleged that the numerous statements made by the Minister of Natural Resources and Wildlife, Mrs. Nathalie Normandeau, regarding the dismantling of the Shell refinery in East-end Montreal had the effect of misleading the House and thus violated the rights of the Members of this Assembly.

Mr. President took the matter under advisement.

Mr. President gave a directive on the organization of Oral Question Period and the allocation of measures and speaking times following the arrival of new independent Members in the composition of the Assembly:

DIRECTIVE FROM THE CHAIR

At the beginning of each new legislature, and whenever necessary during a legislature, the President allocates control measures and the speaking times in accordance with parliamentary jurisprudence and precedents in the matter to foster the efficient exercise of the role of Member.

In this regard, one of the Member's main roles is to represent their constituents in the National Assembly. Citizens must have a voice regardless of the political allegiance of the Member representing their riding. Also, the Chair must respect the choice of the electors who, when it is time to vote in an election, grant the status of Official Opposition to the second political party having had the most members returned in an election after the Government. This Official Opposition status provides advantages that go beyond a simple calculation of the number of Members composing this parliamentary group.

Following the general election of December 2008, the parliamentary group forming the Government, that forming the Official Opposition and all of the other Members negotiated together the allocation of control measures and the recognition of the Action démocratique du Québec as a parliamentary group. The results of these negotiations are entrenched in the document entitled "Reconnaissance de l'Action

démocratique du Québec comme groupe parlementaire et répartition des mesures entre les députés de l'opposition pour la durée de la 39^e législature". This document was adopted unanimously on 21 April 2009 within the framework of the parliamentary reform.

However, with the arrival of new independent Members, the logic behind this document adopted by the Assembly as regards the allocation of measures no longer holds. In this special situation, the Chair is required to modify the allocation of measures and speaking times during the legislature.

To do so, the Chair is guided by the main principles found in parliamentary jurisprudence concerning the management of Oral Question Period. These principles are as follows: all Members may question the Government, including Government Members; questions are mainly granted to Members sitting in opposition; the notion of parliamentary group constitutes a principle that must be applied to the first two; a key role must be given to the Official Opposition; the Chair must also take into account the presence of independent Members.

Following these principles, independent Members henceforth are granted a total of 9 questions per cycle of 8 sittings. The Member for Mercier will ask his question in 6th place and the other independent Members will ask theirs in 7th place.

The Member for Mercier benefits from the same number of questions as the other independent Members. Nonetheless, so as to limit the impact of the new allocation on his rights, he will enjoy, as for the other control measures, greater latitude regarding the time when he may exercise them.

To ensure the observance of the principle of preponderance that must be granted to the Official Opposition and, owing to the fact that at least one question per sitting is henceforth granted to an independent Member, the Official Opposition will enjoy two consecutive groups of questions per sitting. It is for this reason that the 5th and 6th questions are granted to the Official Opposition, subject to the question by the Member for Mercier and a question by a Government Member.

Moreover, the cycles have now been increased from 7 to 8 sittings, thus enabling all questions granted to the independent Members to be asked in 7th place, excepting the question by the Member for Mercier that will remain in 6th place.

This directive in no way affects the rights that have until now been granted to the Second Opposition Group, the latter henceforth being granted 6 questions per cycle of 8 sittings, in 4th place, which remains proportionately identical to the 5 questions per cycle of 7 sittings it enjoyed previously.

By increasing the cycles from 7 to 8 sittings, the Chair equitably maintains the right of the independent Members to ask one question to the Government, while respecting the other aforementioned criteria that apply as regards the allocation of questions, including particularly the impact of the recognition of a party as a parliamentary group and the key role that must be given to the Official Opposition.

The new allocation of questions will be tested for a period of two cycles, that is until the sitting of next 1 November inclusively.

So as to facilitate the allocation of questions among the independent Members, a new mechanism has been put into place, which is a random draw procedure.

A random draw procedure has also been implemented to allocate the other measures which are the Wednesday motions, interpellations and statements by Members.

The random draw procedure is explained in a document tabled along with the tables indicating the allocation of all of the measures and speaking times for all limited debates. These tables illustrate the allocation of these measures and speaking times. This allocation is deemed to form part of this directive.

In conclusion, for the purpose of ensuring the proper conduct of proceedings, the Chair strongly suggests that the texts of the motions without notice be forwarded to the independent Members and to the parliamentary groups on the eve of their presentation. Such a mechanism will enable all Members to make an informed decision, when required to do so, on the advisability of giving their consent.
