By leave of the Assembly to set aside Standing Order 185, Mr. Bonnardel (Granby), together with Mrs. Malavoy, Minister of Education, Recreation and Sports, Mr. Iracà (Papineau) and Mrs. David (Gouin), moved:

THAT the National Assembly warmly congratulate all of the Québec athletes and coaches who took part in the Paralympic Games of London in 2012;

THAT it applaud the determination, perseverance and courage they demonstrated throughout these Games and which represent a source of pride for the people of Québec;

THAT it recognize that their performances, their commitment and their sportsmanship are an example for our young people and promote Québec worldwide.

By leave of the Assembly to set aside Standing Order 185, Mr. Lisée, Minister of International Relations, La Francophonie and External Trade, together with Mr. Khadir

THAT the National Assembly invite the Government of Canada to take note of the United Nations' decision to grant Palestine non-member observer State status and to continue providing invaluable Canadian aid toward building a state of law on Palestinian territory;

THAT it reaffirm Québec's staunch support of a negotiated solution that embodies both the necessity for Israel to live in peace within secure and recognized borders as well as the right of Palestinians to self-determination and the creation of a State.

By leave of the Assembly to set aside Standing Orders 84.1 and 185, Mrs. De Courcy, Minister of Immigration and Cultural Communities, together with Mrs. St-Pierre (Acadie), Mr. Duchesneau (Saint-Jérôme) and Mrs. David (Gouin), moved:

THAT the National Assembly underline the 20 years of work accomplished by the Corporation de développement économique communautaire Ahuntsic-Cartierville.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

Mr. St-Arnaud, Deputy Government House Leader, moved a motion concerning the examination of a draft regulation in committee; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 84.1 and pursuant to Standing Order 146, Mr. St-Arnaud, Deputy Government House Leader, moved:

THAT, within the framework of the examination of Bill 9, An Act to establish the Health and Social Services Information Resources Fund, the Committee on Health and Social Services hold special consultations on 5 December 2012, from 3.00 o'clock p.m. to 6.00 o'clock p.m., and that, for this purpose, it hear the following groups:

Dr. Levreault, medical specialist at Saint-Jérôme hospital Chief Information Officer

THAT a period of 12 minutes be set aside for opening statements;

THAT the time set aside for the opening statements by the party forming the Government and by the party forming the Official Opposition be of 5 minutes each and the time set aside for the Second Opposition Group be of 2 minutes;

THAT the presentation of each of the groups last no longer than 10 minutes and the exchange with the Committee members last no longer than 40 minutes;

THAT the time set aside for the party forming the Government be of 18 minutes and the time set aside for the opposition Members be of 22 minutes;

THAT a period of 12 minutes be set aside for closing statements allocated in the same manner as for the opening statements;

THAT the Minister of Health and Social Services be a member of the said Committee during its proceedings with respect to this order of reference.

By leave of the Assembly, the motion was carried.

ORDERS OF THE DAY

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 2, An Act to amend the Election Act in order to limit elector contributions to \$100 and to revise public financing of political parties, together with the amendment handed in by Mr. Drainville, Minister responsible for Democratic Institutions and Active Citizenship.

The amendment was declared in order.

After debate thereon, the amendment was carried.

The report, as amended, was concurred in.

Passage in Principle

Mr. Marceau, Minister of Finance and the Economy, moved, —That Bill 5, An Act to amend the Act respecting the Québec sales tax and other legislative provisions, do now pass in principle.

After debate thereon, the motion was carried and Bill 5 was accordingly passed in principle.

Mr. St-Arnaud, Deputy Government House Leader, moved that Bill 5 be referred for clause-by-clause consideration to the Committee on Public Finance.

The motion was carried.

By leave of the Assembly to set aside Standing Order 237, Mrs. Maltais, Minister of Employment and Social Solidarity, moved, —That Bill 15, An Act to provide for the establishment of target-benefit pension plans in certain pulp and paper sector enterprises, do now pass in principle.

A debate arose thereon.

By leave of the Assembly to set aside Standing Order 53, Mrs. Maltais, Minister of Employment and Social Solidarity, tabled the following:
