Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mrs. Marois, Premier, together with Mr. Fournier, Leader of the Official Opposition, Mr. Legault, Leader of the Second Opposition Group, and Mr. Khadir (Mercier), moved:

THAT the National Assembly of Québec express its solidarity and support to the American people, to the victims and their families affected by the deadly attack in Boston yesterday.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

At the invitation of Mrs. Poirier, First Vice-President, the Assembly observed a minute of silence.

Notices of Proceedings in Committees

Mr. Traversy, Deputy Government House Leader, convened the following Committees:

Information on the Proceedings of the Assembly

Mrs. Poirier, First Vice-President, informed the Assembly that on Wednesday, 17 April 2013, during Business Standing in the Name of Members in Opposition, a debate will be held on the motion by Mr. Deltell (Chauveau).

This motion reads as follows:

THAT the National Assembly demand that the Government expand the mandate of the Committee on the conditions of employment of persons holding senior positions and who are not part of the public service, to include hiring criteria related to the experience and skills required of these persons to fill these positions;

THAT it promptly instruct the Committee on Public Administration to hold public hearings to hear the members of the Committee established by the Premier last 19 December.

Mr. Cousineau, Second Vice-President, then gave a directive with regard to the questions raised by the Official Opposition House Leader on 28 March 2013, concerning the documents relating to the Expenditure Budget 2013-2014 tabled by the Chair of the Conseil du trésor the same day.

DIRECTIVE FROM THE CHAIR

The documents tabled last 28 March by the Chair of the Conseil du trésor aimed to complete the information contained in the documents relating to the Expenditure Budget 2013-2014 tabled in the National Assembly on 6 December 2012. They contain, among other things, the following information: the presentation of the ministerial portfolios, the budgetary choices made by each department as well as the staff associated with each department and agency.

These documents do not contain any new expenses or any new investments that have not received prior approval from the Assembly. Further approval from the Assembly is therefore unnecessary.

Though the law does not specify when these documents are to be tabled, practice in recent years has shown that they are integrated to the documents tabled with the estimates of expenditure, so that Members may exercise better parliamentary control during the examination of the estimates of expenditure. This practice also complies with the Parliament's intent expressed during the debates leading up to the passage of the *Public Administration Act*.

The information contained in the documents tabled with the estimates of expenditure in December 2012 provided parliamentarians with a less detailed picture of the budgetary situation in comparison with that which is usually found in these documents during the consideration of the estimates. This situation also occurred in June 2003, with the arrival of a new government following a general election.

Since this is the second time that, following a change in government, the documents accompanying the estimates are much less detailed than usual, the Chair would like to remind all Members, and especially those who hold executive power, that in order to exercise optimal parliamentary control, Members must be able to have the most complete information possible when they examine the estimates.

In future, it would therefore be preferable, for control purposes on the budgetary process exercised by parliamentarians, to make available all the information regarding the expenditure budget for the fiscal year concerned when the estimates are tabled.

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 13, An Act to amend the Election Act with regard to on-campus voting outside a voter's electoral division.

After debate thereon, the report was concurred in.

Passage in Principle

By leave of the Assembly to set aside Standing Order 236, Mr. Gaudreault, Minister of Municipal Affairs, Regions and Land Occupancy, moved, —That Bill 26, An Act to amend the Act respecting elections and referendums in municipalities with respect to financing, do now pass in principle.

After debate thereon, the motion was carried and Bill 26 was accordingly passed in principle.

Mr. Traversy, Deputy Government House Leader, moved that Bill 26 be referred for clause-by-clause consideration to the Committee on Planning and the Public Domain.

The motion was carried.

Debates Upon Adjournment

At 6.00 o'clock p.m., the Assembly held two debates upon adjournment:

- the first, on a question by Mrs. Thériault (Anjou–Louis-Riel) to Mrs. Marois, Premier, about the partisan appointment of Jean-Yves Duthel to Investissement Québec in Munich. Mrs. Zakaïb, Minister for Industrial Policy and the Banque de développement économique du Québec, replaced the Premier for this debate.

By leave of the Assembly to set aside Standing Orders 53 and 59, Mrs. Thériault (Anjou–Louis-Riel) tabled the following:

A document entitled "Citation de Pauline Marois".

- the second debate, on a question by Mr. Tanguay (LaFontaine) to Mrs. De Courcy, Minister responsible for the Charter of the French language, about the concerns of the various organizations that came to demonstrate their discontent, including the Canadian Federation of Independent Business and the Barreau du Québec.
