Mr. Lessard (Lotbinière-Frontenac), together with Mr. Marcotte (Portneuf) and Mr. Khadir (Mercier), moved a motion concerning the Northern development territory; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mrs. Trudel (Charlesbourg), together with Mrs. Malavoy, Minister of Education, Recreation and Sports, Mr. Bachand (Outremont), Mr. Iracà (Papineau) and Mr. Khadir (Mercier), moved:

THAT the National Assembly congratulate the organizers, the volunteers and the 4,000 athletes who took part in the 30th edition of the Défi sportif AlterGo special games held from April 22 to 28, 2013;

THAT the National Assembly salute the exemplary work of Chaplain Lucien Ouellet, of the Sûreté du Québec, who has devoted the last 50 years to helping and supporting over 10,000 police officers and their families.

THAT the time set aside for the party forming the Government be of 24 minutes and the time set aside for the opposition Members be of 26 minutes;

THAT a period of 15 minutes be set aside for closing statements allocated in the same manner as for the opening statements;

THAT the Minister of Municipal Affairs, Regions and Land Occupancy be a member of the said Committee during its proceedings with respect to this order of reference.

By leave of the Assembly, the motion was carried.

Mr. Traversy, Deputy Government House Leader, convened the following Committees:

Information on the Proceedings of the Assembly

Mr. Cousineau, Second Vice-President, informed the Assembly that on Wednesday, 15 May 2013, during Business Standing in the Name of Members in Opposition, a debate will be held on the motion by Mr. Poëti (Marguerite-Bourgeoys).

This motion reads as follows:

THAT the National Assembly recall that police services work daily to protect the public, and to enforce laws and regulations within Québec society;

THAT it reaffirm its confidence in the mechanisms to ensure discipline and the observance of the professional conduct rules governing the work of police officers;

THAT, lastly, it enjoin the Parti Québécois Government to make responsible, vigilant and non-partisan use of public funds by abandoning its decision to establish the special commission to examine the events of spring 2012.

ORDERS OF THE DAY

Government Bills

Report Stage

Following the passage in principle of Bill 32, An Act to amend the Act respecting the Pension Plan of Peace Officers in Correctional Services and other legislative provisions, on the recommendation of His Honour the Lieutenant-Governor, the Assembly took into consideration the report from the Committee on Public Finance on its clause-by-clause consideration of Bill 32, An Act to amend the Act respecting the Pension Plan of Peace Officers in Correctional Services and other legislative provisions.

After debate thereon, the report was concurred in.

Passage in Principle

Mr. Bédard, Minister responsible for Government Administration and Chair of the Conseil du trésor, informed the Assembly that His Honour the Lieutenant-Governor recommended to its consideration Bill 38, An Act respecting the governance of public infrastructures, establishing the Société québécoise des infrastructures and amending various legislative provisions, and then moved, —That this Bill do now pass in principle.

A debate arose thereon.

Debates Upon Adjournment

At 6.00 o'clock p.m., the Assembly held three debates upon adjournment:

- the first, on a question by Mr. Kelley (Jacques-Cartier) to Mrs. Larouche, Minister for Aboriginal Affairs, about the failure to act in concert with the First Nations in developing the North;
- the second, on a question by Mr. Lessard (Lotbinière-Frontenac) to Mr. Blanchet, Minister of Sustainable Development, Environment, Wildlife and Parks, about the setback in the Parti Québécois Government's targets with regard to protected areas;
- the third, on a question by Mr. Bolduc (Jean-Talon) to Mr. Hébert, Minister of Health and Social Services, about the Parti Québécois Government's plan to authorize alcoholic beverages in gaming areas. Mrs. Hivon, Minister for Social Services and Youth Protection, replaced the Minister of Health and Social Services for this debate.

At 6.38 o'clock p.m., Mr. Ouimet, Third Vice-President, suspended the proceedings until 7.30 o'clock p.m.

The proceedings resumed at 7.30 o'clock p.m.

Government Bills

Passage in Principle

The Assembly continued the debate on the motion by Mr. Bédard, Minister responsible for Government Administration and Chair of the Conseil du trésor, for the passage in principle of Bill 38, An Act respecting the governance of public infrastructures, establishing the Société québécoise des infrastructures and amending various legislative provisions.

The debate being concluded, the motion was carried and Bill 38 was accordingly passed in principle.

Mr. Traversy, Deputy Government House Leader, moved that Bill 38 be referred for clause-by-clause consideration to the Committee on Public Finance.

The motion was carried.

Report Stage

The Assembly took into consideration the report from the Committee on Planning and the Public Domain on its clause-by-clause consideration of Bill 26, An Act to amend the Act respecting elections and referendums in municipalities with respect to financing, together with the amendments handed in by Mr. Carrière (Chapleau).

The amendments were declared in order.

A debate arose thereon.

At the request of Mrs. Poirier, First Vice-President, Mr. Spénard (Beauce-Nord) withdrew certain words deemed unparliamentary.

At the request of Mrs. Poirier, First Vice-President, Mr. Deltell (Chauveau) withdrew certain words deemed unparliamentary.

The debate being concluded, the question was put on the amendments; a recorded division was thereupon demanded on these amendments and on the report.

At the request of Mr. Traversy, Deputy Government House Leader, Deputy Government House Leader, these divisions were deferred until Routine Proceedings on the next sitting day.

Mr. Traversy, Deputy Government House Leader, moved the adjournment of the Assembly until Wednesday, 15 May 2013, at 9.45 o'clock p.m.

The motion was carried.
