Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

Deferred Divisions

The Assembly took the division, which had been deferred at the sitting of 29 May 2013, on the motion moved by Mrs. De Courcy, Minister responsible for the Charter of the French language, for the passage in principle of Bill 14, An Act to amend the Charter of the French language, the Charter of human rights and freedoms and other legislative provisions.

The motion was carried on the following vote:

(Division No. 44 in Appendix)

Yeas: 67 Nays: 42 Abstentions: 0

Accordingly, Bill 14 was passed in principle.

Mr. Traversy, Deputy Government House Leader, moved that Bill 14 be referred for clause-by-clause consideration to the Committee on Culture and Education.

The motion was carried.

The Assembly then took the division, which had been deferred during Business Standing in the Name of Members in Opposition at the sitting of 29 May 2013, on the motion moved by Mr. Hamad (Louis-Hébert).

This motion reads as follows:

Concerning Enbridge's Line 9 reversal project, that the National Assembly demand that the Parti Québécois Government take the necessary measures to ensure that the economic, environmental and social analyses, as well as the consultations, are completed by 1 December 2013;

THAT, in the meantime, all studies and reports produced by the joint committee or at the Québec Government's initiative be made public within fifteen days of their receipt, including the economic report that the Minister of Finance has had for more than a month.

The motion was carried on the following vote:

THAT it extend its condolences to Dr. Morgentaler's family and friends.

By leave of the Assembly to set aside Standing Order 185, Mrs. Daneault (Groulx), together with Mrs. Hivon, Minister for Social Services and Youth Protection, Mrs. Vallée (Gatineau) and Mrs. David (Gouin), moved:

THAT the National Assembly ask the Government both to ensure that health institutions have adequate resources at their disposal to detect and treat PDD (pervasive developmental disorder) and to put every effort into reducing waiting times for those services.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Mrs. St-Amand (Trois-Rivières), together with Mrs. Léger, Minister of Families, Mrs. Roy (Arthabaska) and Mrs. David (Gouin), moved:

THAT the National Assembly mark Québec Daycare Week, held this year under the theme "My world is child's play";

THAT it underscore the work and devotion of the men and women who take care of our children;

THAT it stress the essential role childcare services play in Québec society.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Orders 84.1 and 185, Mr. Hébert, Minister of Health and Social Services, together with Mr. Bolduc (Jean-Talon), Mrs. Daneault (Groulx) and Mrs. David (Gouin), moved:

THAT the National Assembly of Québec mark World No Tobacco Day;

THAT it salute this annual World Health Organization initiative, to be held this year on May 31, and that it take the opportunity to stress the ill effects of tobacco on health and the fact that tobacco kills over 10,000 people in Québec each year.

By leave of the Assembly, the motion was carried.

Government Bills

Passage in Principle

Mr. Hébert, Minister of Health and Social Services, moved, –That Bill 30, An Act to amend the Civil Code and other legislative provisions with respect to research, do now pass in principle.

A debate arose thereon.

At 12.59 o'clock p.m., Mr. Ouimet, Third Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.01 o'clock p.m.

The Assembly continued the debate on the motion by Mr. Hébert, Minister of Health and Social Services, for the passage in principle of Bill 30, An Act to amend the Civil Code and other legislative provisions with respect to research.

The debate being concluded, the motion was carried and Bill 30 was accordingly passed in principle.

Mr. Traversy, Deputy Government House Leader, moved that Bill 30 be referred for clause-by-clause consideration to the Committee on Health and Social Services.

The motion was carried.

Report Stage

The Assembly took into consideration the report from the Committee on Culture and Education on its clause-by-clause consideration of Bill 24, An Act to amend the Act respecting school elections.

After debate thereon, the report was concurred in.

Passage in Principle

The Assembly resumed the debate, which had been adjourned on 29 May 2013, on the motion by Mr. Drainville, Minister responsible for Democratic Institutions and Active Citizenship, for the passage in principle of Bill 33, An Act to amend the Act respecting the conditions of employment and the pension plan of the Members of the National Assembly.

The debate was adjourned in the name of Mrs. St-Pierre (Acadie).

Debates Upon Adjournment

By leave of the Assembly to set aside Standing Orders 309 and 312, the debates upon adjournment scheduled to be held between Mr. D'Amour (Rivière-du-Loup–Témiscouata) and Mrs. Ouellet, Minister of Natural Resources, about the false consensus and the uncertainty of Bill 43, Mining Act; and between Mrs. Houda-Pepin (La Pinière) and Mr. Gaudreault, Minister of Municipal Affairs, Regions and Land Occupancy, about the establishment of an assistance program for owner-occupied houses with fissures located on the South Shore and in the Montérégie region, were deferred until Tuesday, 4 June 2013.

At 6.00 o'clock p.m., Mr. Cousineau, Second Vice-President, adjourned the Assembly until Tuesday, 4 June 2013, at 1.45 o'clock p.m.
