Motions Without Notice

Mr. Marceau, Minister of Finance and the Economy, together with Mrs. David (Gouin), moved a motion concerning the federal government's decision to refuse the block transfer of infrastructure budgets; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mrs. Blais (Saint-Henri-Sainte-Anne), together with Mr. Hébert, Minister of Health and Social Services and Minister responsible for Seniors, Mrs. Roy (Arthabaska) and Mr. Khadir (Mercier), moved:

THAT the National Assembly mark World Elder Abuse Awareness Day;

THAT it reiterate the need to work with the elderly and the general public in order to raise awareness and identify cases of elder abuse and to intervene with a view to putting an end to such abuse.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Orders 84.1 and 185, Mrs. Léger, Minister of Families, together with Mrs. St-Amand (Trois-Rivières), Mrs. Roy (Arthabaska) and Mr. Khadir (Mercier), moved:

THAT the National Assembly mark Québec's first Fatherhood Week, which takes place from June 10 to 16, under the theme, "Dad, you give me wings";

THAT it recognize and commend the increased commitment of Québec fathers to their children;

THAT it invite all fathers, mothers and families to participate in large numbers in the activities organized throughout Québec.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Orders 84.1 and 185, Mr. Kelley (Jacques-Cartier), together with Mrs. Larouche, Minister for Aboriginal Affairs, Mrs. St-Laurent (Montmorency) and Mrs. David (Gouin), moved:

THAT the National Assembly mark National Aboriginal Day, celebrated on June 21 every year and dedicated to promoting the rich and unique culture of the First Nations and Inuit;

THAT this special day be an opportunity to celebrate the important contribution of Aboriginal peoples to Québec society, as well as their exceptional heritage, cultural and linguistic diversity and outstanding achievements;

THAT we join our Aboriginal sisters and brothers in the many traditional activities and ceremonies held to highlight, share and honour our common history.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Orders 84.1 and 185, Mr. Ouimet (Fabre), together with Mr. St-Arnaud, Minister of Justice, Mr. Duchesneau (Saint-Jérôme) and Mrs. David (Gouin), moved:

THAT the National Assembly highlight the appointment of the Honourable Elizabeth Corte, Chief Justice of the Court of Québec, as Chair of the Canadian Council of Chief Judges and Chief Justices for a two-year term.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Orders 84.1 and 185, Mr. Duchesne, Minister of Higher Education, Research, Science and Technology, together with Mrs. Ménard (Laporte), Mr. Deltell (Chauveau) and Mr. Khadir (Mercier), moved:

THAT the National Assembly highlight the outstanding work carried out by Mr. Pierre Fournier, cameraman with Radio-Canada for the past 35 years, including 28 years on Parliament Hill

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Orders 84.1 and 185, Mr. Khadir (Mercier) moved:

THAT the National Assembly urge the Minister of Health and Social Services to end the practice of charging accessory costs, through, among other things, an information campaign aimed at physicians and patients, a more rigorous application of the *Health Insurance Act*, and the prohibition of annual fixed fees:

THAT the Assembly mandate the Minister of Health and Social Services to see that medically necessary care is covered.

By leave of the Assembly, the motion was carried.

ORDERS OF THE DAY

Government Bills

Passage

Mr. Lelièvre, Minister for Regions, moved the passage of Bill 42, An Act establishing the Eeyou Istchee James Bay Regional Government and introducing certain legislative amendments concerning the Cree Nation Government.

After debate thereon, the motion was carried and, accordingly, Bill 42 was passed.

Report Stage

The Assembly took into consideration the report from the Committee on Public Finance on its clause-by-clause consideration of Bill 25, An Act respecting mainly the implementation of certain provisions of the Budget Speech of 20 November 2012.

By leave of the Assembly to set aside Standing Order 21, the proceedings continued beyond 1.00 o'clock p.m.

At the request of Mrs. Poirier, First Vice-President, Mr. Dubé (Lévis) withdrew certain words deemed unparliamentary.

After debate thereon, the report was concurred in.

At 1.10 o'clock p.m., Mrs. Poirier, First Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.02 o'clock p.m.

Report Stage

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 3, An Act to amend the Election Act for the purpose of establishing fixed-date elections.

After debate thereon, the report was concurred in.

Debates on Reports from Committees

The Assembly took into consideration the report from the Committee on Health and Social Services, which, on 29 and 30 May as well as on 4 June 2013, held public hearings within the framework of special consultations in reference to the draft rules repealing the provision that prohibits the sale, service and consumption of alcoholic beverages inside gaming areas. The report contains one recommendation.

Mr. Ouimet, Third Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 50 minutes 29 seconds shall be allotted to the parliamentary group forming the Government; 46 minutes 45 seconds shall be allotted to the parliamentary group forming the Official Opposition; 17 minutes 46 seconds shall be allotted to the Second Opposition Group; and 5 minutes shall be allotted to the independent Members. Within this framework, any time not used by the independent Members or by any of the parliamentary groups shall be redistributed among the parliamentary groups in proportion to their representation in the Assembly. Lastly, individual addresses shall not be limited.

The debate arose thereon.

The debate expired and, pursuant to Standing Order 95, no question was put.

Mr. St-Arnaud, Deputy Government House Leader, moved the adjournment of the Assembly until Friday, 14 June 2013, at 9.45 o'clock a.m.

The motion was carried.

Accordingly, at 5.55 o'clock p.m., Mr. Cousineau, Second Vice-President, adjourned the Assembly until Friday, 14 June 2013, at 9.45 o'clock a.m.
