Complaints of Breach of Privilege or Contempt and Personal Explanations

Mr. President notified the Assembly that he had received, within the prescribed time, a complaint of breach of privilege or contempt from the Second Opposition Group House Leader.

In his notice, the Second Opposition Group House Leader invoked that the Chief Executive Officer of the Fondation du Centre hospitalier de l'Université de Montréal, Mr. Ekram Antoine Rabbat, during his testimony before the Committee on Health and Social Services, allegedly violated paragraph 2 of section 55 of the Act respecting the National Assembly by repeatedly denying having been informed of the additional compensation paid by the Fondation to the Director General of the CHUM, whereas information provided to the Commission contradict this testimony.

Mr. President took the matter under advisement.
