THAT these modifications enter into effect immediately.

The motion was carried.

Passage in Principle

The Assembly resumed the debate, which had been adjourned on 30 May 2013, on the motion moved by Mr. Drainville, Minister responsible for Democratic Institutions and Active Citizenship, for the passage in principle of Bill 33, An Act to amend the Act respecting the conditions of employment and the pension plan of the Members of the National Assembly.

At the end of her address, Mrs. Charlebois (Soulanges) moved the following hoist motion:

THAT the motion under debate be amended by striking out the word "now" and by adding at the end thereof the words "this day three months hence".

The hoist motion was ruled in order.

Following a meeting with the House leaders, Mr. Ouimet, Third Vice-President, announced the allocation of speaking time for the limited debate on this hoist motion: 51 minutes 15 seconds shall be allotted to the parliamentary group forming the Government; 45 minutes 30 seconds shall be allotted to the parliamentary group forming the Official Opposition; 17 minutes shall be allotted to the Second Opposition Group; and 6 minutes shall be allotted to the independent Members. Within this framework, any time not used by the independent Members or by any of the parliamentary groups shall be redistributed among the parliamentary groups in proportion to their representation in the Assembly. Lastly, individual addresses shall not be limited.

The Assembly entered upon the debate on the hoist motion moved by Mrs. Charlebois (Soulanges).

The debate was adjourned in the name of Mr. Villeneuve (Berthier).
