Introduction of Bills

Mr. St-Arnaud, Minister of Justice, moved that leave be granted to introduce the following Bill:

61 An Act mainly to recover amounts paid unjustly by public bodies in relation to certain contracts in the construction industry

The motion was carried.

Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

Motions Without Notice

Mr. Ouellette (Chomedey), together with Mr. Dubé (Lévis) and Mr. Ratthé (Blainville), moved a motion concerning a mandate to the Committee on Public Finance on the hearing with the Fonds de solidarité FTQ's head officers; this motion could not be debated for want of unanimous consent.

Mr. Martel (Nicolet-Bécancour), together with Mr. Sklavounos (Laurier-Dorion) and Mr. Ratthé (Blainville), moved a motion concerning the proposed moratorium on shale gas exploration and development; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Blanchet, Minister of Sustainable Development, Environment, Wildlife and Parks and Member for Johnson, together with Mr. Bolduc (Jean-Talon), Mr. Schneeberger (Drummond–Bois-Francs), Mrs. David (Gouin) and Mr. Ratthé (Blainville), moved: THAT the National Assembly underline Kindness Day today, 13 November;

THAT the National Assembly commend the sustained efforts made by the AQDR Centre-du-Québec for the past three years to raise Québec's awareness regarding this day, which could lead to the official recognition of this day.

THAT, beginning on 26 November 2013, the Committee on Agriculture, Fisheries, Energy and Natural Resources hold special consultations to examine the acceptability, for Québec, of the project proposed by Enbridge Pipelines Inc. to reverse the flow of Pipeline 9B eastward between North Westover and Montréal, described in particular in the document entitled "Inversion du flux de l'oléoduc 9B d'Enbridge";

THAT the Committee assess, where required, the necessary conditions to make this project acceptable in accordance with the principles of sustainable development, namely the indivisibility of the environmental, social and economic dimensions for Québec;

THAT for this purpose the Committee hear the following:

THAT the time set aside for the opening statements by the party forming the Government and by the party forming the Official Opposition be of 6 minutes each and the time set aside for the Second Opposition Group be of 3 minutes;

THAT the presentation by Enbridge last no longer than 60 minutes and that the exchange with the Committee members last no longer than 90 minutes;

THAT the time set aside for the party forming the Government be of 41 minutes and the time set aside for the opposition Members be of 49 minutes;

THAT the presentation by the Minister of Sustainable Development, Environment, Wildlife and Parks, the Minister of Natural Resources, the Minister of Finance and the Economy, and the Minister of Transport and Minister of Municipal Affairs, Regions and Land Occupancy last no longer than 10 minutes respectively and the exchange with the Committee members last no longer than 35 minutes;

THAT the time set aside for the party forming the Government be of 16 minutes and the time set aside for the opposition Members be of 19 minutes;

THAT the presentation by each of the other individuals last no longer than 10 minutes and the exchange with the Committee members last no longer than 35 minutes;

THAT the time set aside for the party forming the Government be of 16 minutes and the time set aside for the opposition Members be of 19 minutes;

THAT a period of 15 minutes be set aside for closing statements allocated in the same manner as for the opening statements;

THAT the Committee report to the Assembly no later than 6 December 2013;

THAT the Minister for Industrial Policy and the Banque de développement économique du Québec be a member of the said Committee during its proceedings with respect to this order of reference;

THAT this motion become an order of the National Assembly.

By leave of the Assembly, the motion was carried.

ORDERS OF THE DAY

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Public Finance on its clause-by-clause consideration of Bill 41, An Act to amend the Public Service Act mainly with respect to staffing.

After debate thereon, the report was concurred in.

Passage in Principle

The Assembly resumed the debate, which had been adjourned on 12 November 2013, on the motion by Mr. Blanchet, Minister of Sustainable Development, Environment, Wildlife and Parks, for the passage in principle of Bill 37, An Act to prohibit certain shale natural gas exploration and production activities.

At 1.00 o'clock p.m., Mr. Cousineau, Second Vice-President, suspended the proceedings until 3.00 o'clock p.m.

Accordingly, in pursuance of Standing Order 97, the debate on the motion by Mr. Blanchet, Minister of Sustainable Development, Environment, Wildlife and Parks, was adjourned in the name of Mrs. St-Pierre (Acadie).

The proceedings resumed at 3.02 o'clock p.m.

Business Standing in the Name of Members in Opposition

Mr. Tanguay (LaFontaine) moved:

THAT the Committee on Institutions hear the Minister of Justice, on Thursday, 28 November 2013, beginning at 3.00 o'clock p.m., concerning the comments of the Commission des droits de la personne et des droits de la jeunesse made public on 17 October 2013 on the Government's policy directions regarding the proposed charter of Québec values as well as on the unconstitutionality of the Government's proposal;

THAT a period of 15 minutes be set aside for opening statements;

THAT the presentation by the Minister of Justice last no longer than 10 minutes and the exchange with the Committee members last no longer than 120 minutes;

THAT a period of 15 minutes be set aside for closing statements;

THAT the Committee report to the Assembly on 4 December 2013 unless the Committee decides otherwise.

Mr. Cousineau, Second Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this motion: 10 minutes shall be allotted to the mover of the motion for his reply; approximately 43 minutes 12 seconds shall be allotted to the parliamentary group forming the Government; approximately 38 minutes 24 seconds shall be allotted to the parliamentary group forming the Official Opposition; approximately 14 minutes 24 seconds shall be allotted to the Second Opposition Group; and 6 minutes shall be allotted to the independent Members. Within this framework, any time not used by the independent Members or by any of the parliamentary groups shall be redistributed among the parliamentary groups in proportion to their representation in the Assembly. Lastly, individual addresses shall not be limited.

After debate thereon, the question was put on this motion; a recorded division was thereupon demanded.

At the request of Mr. Traversy, Deputy Government House Leader, the division was deferred until Routine Proceedings on the next sitting day.
