Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

At the request of Mr. President, Mr. Fournier, Leader of the Official Opposition, withdrew certain words deemed unparliamentary.

At 11.13 o'clock a.m., Mr. President suspended the proceedings.

The proceedings resumed at 11.55 o'clock a.m.

The Minister of Justice requested a directive from the Chair concerning his having been summoned to appear before the Committee on Institutions on Thursday, 28 November 2013, at 3.00 o'clock p.m., with regard to the comments of the Commission des droits de la personne et des droits de la jeunesse, made public on 17 October 2013, on the Government's policy directions regarding the proposed charter of Québec values, as well as on the unconstitutionality of the Government's proposal. More specifically, he asked whether Standing Order 164, which states that a minister will be notified not less than fifteen days before he is to be heard, applies since he was convened last 14 November, which is 14 days before the scheduled date for the Committee order to be carried out. Mr. President gave a directive on this question.

DIRECTIVE FROM THE CHAIR

In the directive given by the Chair last 14 November, when the Assembly took the deferred division on the motion by the Member for LaFontaine instructing the Committee on Institutions to hear the Minister of Justice, the Chair insisted on the fact that the intent of the deferred division procedure was not to prevent the Assembly from carrying out its business, but rather to foster the proper conduct of proceedings.

Drawing on Lavoie's Standing Order 106, which states that the vote is considered to have taken place during the sitting when the motion was first put to the vote and the entry of names requested, the Chair mentioned that while the motion by the Member for LaFontaine, which was valid when it was first put to the vote, could not become invalid because the division was deferred until the next sitting.

In this case, the vote on the motion is presumed to have been taken on Wednesday, 13 November 2013. For obvious reasons, the Minister could not be convened to appear on this date since the division was deferred until the following day, at the Government's request.

The Committee is therefore instructed to hear the Minister of Justice today and it must comply with this order. It must therefore be convened today to carry out this order.

Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mrs. Trudel (Charlesbourg), together with Mr. Bérubé, Minister for Tourism, Mrs. Charlebois (Soulanges), Mrs. David (Gouin) and Mr. Ratthé (Blainville), moved:

THAT the Committee on Labour and the Economy hold special consultations on the inappropriate use of public funds by Tourisme Montréal and that, for this purpose, the Committee hear the former chief executive officer of Tourisme Montréal, Mr. Charles Lapointe, the chairman of the board of directors of Tourisme Montréal, Mr. Jacques Parisien, the Minister for Tourism, the Member for Laporte, as well as any person it may deem necessary to summon;

THAT the presentation by the former chief executive officer of Tourisme Montréal last no longer than 10 minutes and the exchanges with the Committee members last no longer than 90 minutes;

THAT the presentation by the chairman of the board of directors of Tourisme Montréal last no longer than 10 minutes and the exchanges with the Committee members last no longer than 90 minutes;

THAT the maximum length of the presentation and exchanges for each of the other speakers, if any, be established by the Committee members;

THAT the Committee report to the Assembly no later than on 11 February 2014, unless the Committee decides otherwise;

Lastly, that this motion become an order of the Assembly.

By leave of the Assembly, the motion was carried.

Mr. St-Arnaud, Minister of Justice, moved a motion concerning the severance pay of Mr. Emmanuel Dubourg, former Member for Viau and new Federal Member for Bourassa; this motion could not be debated for want of unanimous consent.

Mr. Moreau, Official Opposition House Leader, moved a motion concerning the severance pay allocated to the former Member for Taillon, Mrs. Pauline Marois; this motion could not be debated for want of unanimous consent.

Notices of Proceedings in Committees

Mr. Traversy, Deputy Government House Leader, convened the following Committees:

- the Committee on Planning and the Public Domain, to continue its clause-by-clause consideration of Bill 64, An Act to amend various legislative provisions concerning municipal affairs;
- the Committee on Health and Social Services, to continue its clause-byclause consideration of Bill 52, An Act respecting end-of-life care.

And, by leave of the Assembly to set aside Standing Order 145, he convened the following Committee:

— the Committee on Institutions, to hold public hearings within the framework of special consultations on Bill 61, An Act mainly to recover amounts paid unjustly by public bodies in relation to certain contracts in the construction industry.

Mr. Ouimet, Third Vice-President, gave the following notices:

- the Committee on Culture and Education shall hear the head officers of the Institut national de la recherche scientifique, of the HEC Montréal and of Concordia University;
- the Committee on Citizen Relations shall hold a deliberative meeting for the purpose of organizing its proceedings.

THAT it underline the courage of Mrs. Stéphanie Bérard, of Mr. François Beaudry and of Mrs. Chantal Levert, who have contributed to the fight against corruption in the construction industry and in the granting of public contracts;
