#### **Debates on Reports from Committees**

The Assembly took into consideration the report from the Committee on Public Finance, which, on 20 November 2013, carried out the quarterly examination of the Government's budgetary policy and of the evolution of public finance. The report contains two recommendations.

Mr. Cousineau, Second Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this debate: 51 minutes 18 seconds shall be allotted to the parliamentary group forming the Government; 45 minutes 36 seconds shall be allotted to the parliamentary group forming the Official Opposition; 17 minutes 6 seconds shall be allotted to the Second Opposition Group; and 6 minutes shall be allotted to the independent Members. Within this framework, any time not used by the independent Members or by any of the parliamentary groups shall be redistributed among the parliamentary groups in proportion to their representation in the Assembly. Lastly, individual addresses shall not be limited.

At the request of Mrs. Poirier, First Vice-President, Mr. Dubé (Lévis) withdrew certain words deemed unparliamentary.
