Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mr. Therrien (Sanguinet), together with Mr. Laframboise (Blainville) and Mr. Khadir (Mercier), moved:

THAT the National Assembly demand that, before 30 September 2014, the municipalities, cities and towns provide the Régie des rentes du Québec with their actuarial valuations updated to 31 December 2013;

THAT the Régie des rentes du Québec provide those actuarial valuations to the Committee Secretariat of the National Assembly before 9 October 2014;

THAT this motion become an order of the Assembly.

By leave of the Assembly, a debate arose thereon.

ORDERS OF THE DAY

Government Bills

Passage in Principle

The Assembly resumed the debate, which had been adjourned on 17 September 2014, on the motion by Mr. Moreau, Minister of Municipal Affairs and Land Occupancy, for the passage in principle of Bill 3, An Act to foster the financial health and sustainability of municipal defined benefit pension plans.

At 12.55 o'clock p.m., by leave of the Assembly, Mr. Gendron, Third Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.03 o'clock p.m.

Passage in Principle

The Assembly continued the debate on the motion by Mr. Moreau, Minister of Municipal Affairs and Land Occupancy, for the passage in principle of Bill 3, An Act to foster the financial health and sustainability of municipal defined benefit pension plans.

At the end of his address, Mr. Marceau (Rousseau) moved the following hoist motion:

THAT the motion under debate be amended by striking out the word "now" and by adding at the end thereof the words "this day three weeks hence".

The hoist motion was declared receivable.

Mrs. Gaudreault, Second Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this motion: 57 minutes shall be allotted to the parliamentary group forming the Government; 33 minutes and 32 seconds to the parliamentary group forming the Official Opposition; 23 minutes and 28 seconds to the Second Opposition Group; and 6 minutes to the independent Members. Within this framework, any time not used by the independent Members or by any of the parliamentary groups shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

The Assembly entered upon the debate on the hoist motion moved by Mr. Marceau (Rousseau).

Debates Upon Adjournment

At 6.03 o'clock p.m., the Assembly held a debate upon adjournment on a question by Mr. LeBel (Rimouski) addressed to Mrs. David, Minister of Culture and Communications, on the following subject: "The closing of regional conservatories".

At 6.16 o'clock p.m., Mrs. Gaudreault, Second Vice-President, adjourned the Assembly until Tuesday, 23 September 2014, at 13.45 o'clock p.m.
