At the request of Mr. President, Mrs. Charbonneau, Minister of Families, withdrew certain words deemed unparliamentary.

Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mrs. St-Pierre, Minister of International Relations and La Francophonie, together with Mrs. Poirier (Hochelaga-Maisonneuve), Mr. Martel (Nicolet-Bécancour) and Mr. Khadir (Mercier), moved:

THAT the National Assembly pay tribute to the holding of the 15th Summit of La Francophonie in Dakar and the designation of Earth Day Québec as the Earth Day Network representative for La Francophonie;

THAT it recognize Earth Day Québec's long-standing involvement in environmental protection;

THAT it urge Earth Day Québec to explore potential avenues of co-operation with the Institut de la Francophonie pour le développement durable, whose head office is in Québec City, in order to effectively carry out its new mandate.

By leave of the Assembly, the motion was carried.

Mrs. Hivon (Joliette), together with Mrs. Samson (Iberville) and Mrs. David (Gouin), moved a motion concerning the domain name ".quebec"; this motion could not be debated for want of unanimous consent.

Mr. Surprenant (Groulx), together with Mrs. Massé (Sainte-Marie–Saint-Jacques), moved a motion concerning the awarding and management of public contracts in the information technology and communications industry; this motion could not be debated for want of unanimous consent.

Mr. Khadir (Mercier), together with Mr. Drainville (Marie-Victorin), moved a motion concerning the company TransCanada Energy.

RULING FROM THE CHAIR

Mr. Gendron, Third Vice-President, declared the motion inadmissible. When the Chair of the Assembly notes that the key wording of a motion is not consistent with the spirit of the Standing Orders because it contains insulting language, the Chair is obliged to declare the motion out of order. In so doing, the Chair is not required to submit the motion to consent for a debate to be held thereon.

The fact that this motion is inadmissible does not preclude a Member from moving another motion on the subject. However, the wording of the motion in question must comply with the Standing Orders.

By leave of the Assembly to set aside Standing Order 84.1 and pursuant to Standing Order 146, Mr. Sklavounos, Deputy Government House Leader, moved:

THAT the Committee on Institutions, within the framework of its examination of Bill 21, An Act respecting mainly the implementation of agreements on labour matters between the Gouvernement du Québec and the Mohawk Council of Kahnawake, hold special consultations and public hearings on Tuesday, 25 November 2014, in the Louis-Hippolyte-LaFontaine Room and, for this purpose, hear the following groups:

Mohawk Self Insurance and Mohawk Council of Kahnawake Régie du bâtiment du Québec Commission de la santé et de la sécurité du travail Commission de la construction du Québec CSN-Construction FTQ-Construction;

THAT a period of 12 minutes be set aside for opening statements, allocated as follows: 6 minutes to the parliamentary group forming the Government, 3 minutes 30 seconds to the parliamentary group forming the Official Opposition, and 2 minutes 30 seconds to the Second Opposition Group;

THAT the presentation by each organization last no longer than 10 minutes and the exchange with the committee members last no longer than 50 minutes, allocated as follows: 25 minutes to the parliamentary group forming the Government, 15 minutes to the Official Opposition, and 10 minutes to the Second Opposition Group;

THAT the Minister responsible for Native Affairs be a member of the said Committee during its proceedings with respect to this order of reference.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 84.1 and pursuant to Standing Order 146, Mr. Sklavounos, Deputy Government House Leader, moved:

THAT the Committee on Planning and the Public Domain, within the framework of the examination of Bill 23, An Act to amend the Charter of Ville de Montréal as concerns the composition of the executive committee, hold special consultations to hear Ville de Montréal on Wednesday, 26 November 2014, in the Louis-Joseph-Papineau Room;

THAT a period of 12 minutes be set aside for opening statements, allocated as follows: 6 minutes to the parliamentary group forming the Government, 3 minutes 30 seconds to the parliamentary group forming the Official Opposition, and 2 minutes 30 seconds to the Second Opposition Group;

THAT the presentation by each organization last no longer than 10 minutes and the exchange with the committee members last no longer than 50 minutes, allocated as follows: 25 minutes to the parliamentary group forming the Government, 15 minutes to the Official Opposition, and 10 minutes to the Second Opposition Group;

THAT the Minister of Municipal Affairs and Land Occupancy be a member of the said Committee during its proceedings with respect to this order of reference.

By leave of the Assembly, the motion was carried.

Information on the Proceedings of the Assembly

Mr. Gendron, Third Vice-President, informed the Assembly that on Wednesday, 19 November 2014, during Business Standing in the Name of Members in Opposition, a debate would be held on the motion by Mr. Marceau (Rousseau).

This motion reads as follows:

THAT the National Assembly endorse the position of the Minister of the Economy, Innovation and Exports, calling for the maintenance of tax credits for video game companies, for the aeronautics and information technology sectors and for cultural enterprises.

ORDERS OF THE DAY

Introduction of Bills

Passage

Mr. Coiteux, Minister responsible for Government Administration and Ongoing Program Review and Chair of the Conseil du trésor, moved the passage of Bill 12, An Act respecting the implementation of recommendations by the pension committee of certain pension plans in the public sector and amending various legislative provisions:

After debate thereon, the motion was carried and, accordingly, Bill 12 was passed.

At 3.45 o'clock p.m., at the request of Mr. Sklavounos, Deputy Government House Leader, Mr. Gendron, Third Vice-President, suspended the proceedings until the expiry of the delay for receiving notices for debates upon adjournment.

The proceedings resumed at 3.54 o'clock p.m.

At 3.55 o'clock p.m., at the request of Mr. Sklavounos, Deputy Government House Leader, and by leave of the Assembly to set aside Standing Order 20, Mr. Gendron, Third Vice-President, suspended the proceedings until 6.00 o'clock p.m.

Debates Upon Adjournment

At 6.03 o'clock p.m., the Assembly held three debates upon adjournment:

- the first, on a question by Mr. Traversy (Terrebonne) to Mrs. Charbonneau, Minister of Families, about the Minister's change to the mechanism for granting child care spaces;
- the second, on a question by Mrs. Soucy (Saint-Hyacinthe) to Mrs. Vien, Minister of Tourism, about the severance package of the former head of Tourism Montréal;
- the third, on a question by Mrs. Léger (Pointe-aux-Trembles) to Mr. Bolduc, Minister of Education, Recreation and Sports, about the agreement with illegal schools.

Mr. Bolduc, Minister of Education, Recreation and Sports, moved the adjournment of the Assembly until Wednesday, 19 November 2014, at 9.45 o'clock a.m.

The motion was carried.

Accordingly, at 6.40 o'clock p.m., Mr. Gendron, Third Vice-President, adjourned the Assembly until Wednesday, 19 November 2014, at 9.45 o'clock a.m.
